

## LOCAL GOVERNMENT BY-ELECTION

### The Highland Council: Electoral Ward No7 Tain and Easter Ross and No11 Caol and Mallaig Notice of Poll - Election of Councillor

1. Polling will take place between the hours of 7am and 10pm on **Thursday 25 September 2025** for the election of **ONE COUNCILLOR** for the above mentioned electoral wards as there are more validly nominated candidates than the number of councillors to be elected.
2. Only those persons who are registered to vote in the ward and aged 16 or over on the day of the poll will be eligible to vote.
3. The name, description (if any) and address of each validly nominated candidate is as below; where the candidate has given a commonly used surname and/or forename on that candidate's nomination form, it is that commonly used surname and/or forename (instead of any other name) that appears on the Notice of Poll.
