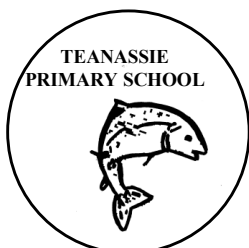

I have been one of the local elected Councillors for Beaully since May 2017. I am a great supporter of the shinty club and the amazing work they do for the village and the wider community.


