

THE HIGHLAND COUNCIL
(TEMPORARY TRAFFIC RESTRICTIONS DURING THE
'RIVER NESS FLOOD ALLEVIATION AND STREETScape SCHEME') ORDER 2014

Notice is hereby given that on 13 February 2014 the Highland Council, in exercise of the powers conferred on them by Section 14 (1) of the Road Traffic Regulation Act 1984, as amended, did make the above titled Order:-

The reason for making the Order is to enable temporary restrictions to be put in place during the River Ness Flood Alleviation and Streetscape Scheme in Inverness.

1. The Order may be cited as 'The Highland Council (Temporary Traffic Restrictions During The 'River Ness Flood Alleviation And Streetscape Scheme') Order 2014' and shall come into operation on Monday 3 March 2014 and will remain in force until Friday 28 August 2015, or at least until the Works are complete, whichever comes first.

2. The Interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.

3. The following expressions will have the meanings hereby respectively assigned to them:-

'Vehicle' means a cycle, motor cycle or motor vehicle constructed solely for the carriage of passengers and their effects:

'Emergency Vehicle' means a motor vehicle constructed or adapted for use by the Police, Ambulance Service, Fire Brigade or the Maritime and Coastguard Agency:

'Engineer' means the person or persons responsible for managing the River Ness Flood Alleviation and Streetscape Scheme:

'Contractor' means the person or persons employed to carry out the River Ness Flood Alleviation and Streetscape Scheme:

'Works' means the works to be carried out by the Contractor on behalf of the Client.

4. All provisions contained in any Order, Enactment or others in so far as the same repeat or are inconsistent with the provisions of the Order and the true intent or meaning hereof shall cease to have effect, during the period stated in Article 1 of the Order.

5. When the Order comes into effect the following temporary restrictions come into force:-

(1) No person shall drive or cause or permit to be driven any vehicle on Riverside Street, Inverness, between its junction with Waterloo Place and its termination.

(2) No person shall drive or cause or permit to be driven any vehicle on Factory Street, Inverness, between its junction with Riverside Street and its termination.

(3) No person shall drive or cause or permit to be driven any vehicle on Portland Place, Inverness, between its junction with Waterloo Place and its termination.

(4) No person shall drive or cause or permit to be driven any vehicle on Waterloo Place, Inverness between its roundabout junction with the A82 Glasgow – Fort William – Inverness Road and the Waterloo ('Black') Bridge.

(5) No person shall drive or cause or permit to be driven any vehicle on the Waterloo ('Black') Bridge, Inverness.

(6) No person shall drive or cause or permit to be driven any vehicle on Grant Street, Inverness, between the Waterloo ('Black') Bridge and its con-junction with Pumpgate Street.

(7) No person shall drive or cause or permit to be driven any vehicle on Pumpgate Street, Inverness, between its junction with Lower Kessock Street and its con-junction with Grant Street.

(8) No person shall drive or cause or permit to be driven any vehicle on Shore Street, Inverness, between its roundabout junction with the A82 Glasgow – Fort William – Inverness Road and its roundabout junction with Harbour Road.

(9) No person shall drive or cause or permit to be driven any vehicle on Shore Street, Inverness, between its roundabout junction with Harbour Road and its con-junction with Cromwell Road.

(10) No person shall drive or cause or permit to be driven any vehicle on Cromwell Road, Inverness, between its con-junction with Shore Street and its junction with Lotland Street.

(11) No person shall drive or cause or permit to be driven any vehicle on Longman Drive, Inverness, between its junction with Lotland Street and its con-junction with Stadium Road.

(12) Subject to Articles 5(1) and/or 5(2) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Waterloo Place, Inverness, to Riverside Street.

(13) Subject to Article 5(4) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Riverside Street, Inverness, to Waterloo Place.

(14) Subject to Article 5(3) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Waterloo Place, Inverness, to Portland Place.

(15) Subject to Article 5(4) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Portland Place, Inverness, to Waterloo Place.

(16) Subject to Article 5(6) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Nelson Street, Inverness, to Grant Street.

(17) Subject to Article 5(6) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Pumpgate Street, Inverness, to Grant Street.

(18) Subject to Article 5(7) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Lower Kessock Street, Inverness, to Pumpgate Street.

(19) Subject to Article 5(8) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Shore Street Roundabout, Inverness (forming part of the A82 Glasgow – Fort William – Inverness Trunk Road), to Shore Street.

(20) Subject to Articles 5(8) and/or 5(9) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Harbour Road, Inverness, to Shore Street.

(21) Subject to Article 5(8) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Innes Street, Inverness, to Shore Street.

(22) Subject to Article 5(10) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Lotland Place, Inverness, to Cromwell Road.

(23) Subject to Article 5(10) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Lotland Street, Inverness, to Cromwell Road.

(24) Subject to Article 5(10) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Longman Drive, Inverness, to Cromwell Road.

(25) Subject to Article 5(11) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Lotland Street, Inverness, to Longman Drive.

(26) Subject to Article 5(11) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Stadium Road, Inverness, to Longman Drive.

(27) Subject to Article 5(3) of the Order the on street parking places – permit parking, on Portland Place, shall be temporarily suspended.

(28) Subject to Article 5(1) of the Order the on street parking places on Riverside Street shall be temporarily suspended.

(29) No person shall drive or cause or permit to be driven any vehicle on Abban Street, Inverness, between its junction with Lochalsh Road and its con-junction with Huntly Place.

(30) No person shall drive or cause or permit to be driven any vehicle on Huntly Place, Inverness, between its con-junction with Abban Street and its junction with Gilbert Street.

(31) No person shall drive or cause or permit to be driven any vehicle on Gilbert Street, Inverness, between its junction with Grant Street and its junction with Dunabban Road.

(32) No person shall drive or cause or permit to be driven any vehicle on Dunabban Road, Inverness, between its junction with Upper Kessock Street and its junction with Gilbert Street.

(33) No person shall drive or cause or permit to be driven any vehicle on Anderson Street, Inverness, between its junction with Thornbush Road and its termination in a turning head, a distance of 750 metres (820 yards), or thereby.

(34) Subject to Article 5(31) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Grant Street, Inverness, to Gilbert Street.

(35) Subject to Article 5(32) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Gilbert Street, Inverness, to Dunabban Road.

(36) Subject to Article 5(30) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Abban Street, Inverness, to Huntly Place.

(37) Subject to Article 5(29) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Huntly Place, Inverness, to Abban Street.

(38) Subject to Article 5(29) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Lochalsh Road, Inverness, to Abban Street.

(39) Subject to Article 5(33) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Brown Street, Inverness, to Anderson Street.

(40) Subject to Article 5(33) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Nelson Street, Inverness, to Anderson Street.

(41) Subject to Article 5(33) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Jamaica Street, Inverness, to Anderson Street.

(42) Subject to Article 5(33) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Madras Street, Inverness, to Anderson Street.

(43) Subject to Article 5(33) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from MacLennan Crescent, Inverness, to Anderson Street.

(44) Subject to Article 5(33) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Thornbush Road, Inverness, to Anderson Street.

(45) Subject to Article 5(49) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Anderson Street, Inverness, to Thornbush Road.

(46) Subject to Article 5(29) of the Order the on street parking places – permit parking, Monday to Saturday, 8am to 6pm, on Abban Street, Inverness, shall be temporarily suspended.

(47) Subject to Article 5(30) of the Order the on street parking places – permit parking, Monday to Saturday, 8am to 6pm, on Huntly Place, Inverness, shall be temporarily suspended.

(48) Subject to Article 5(30) of the Order the on street parking places – waiting limited to 1 Hour, Monday to Saturday, 8am to 6pm, on Huntly Place, Inverness, shall be temporarily suspended.

(49) No person shall drive or cause or permit to be driven any vehicle on Thornbush Road, Inverness, between its junction with Anderson Street and its con-junction with Kessock Road.

(50) No person shall drive or cause or permit to be driven any vehicle on Kessock Road, Inverness, between its con-junction with Thornbush Road and its junction with Craigton Avenue.

(51) Subject to Article 5(50) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Craigton Avenue, Inverness, to Kessock Road.

(52) Subject to Article 5(50) of the Order no person shall drive or cause or permit to be driven any vehicle so as to take access from Kessock Avenue, Inverness, to Kessock Road.

(53) Subject to Articles 5(29), 5(30), 5(46) and 5(47) of the Order and subject to availability parking permit holders may park in those on street parking places on adjacent roads which are normally reserved for permit parking use.

(54) Vehicles, including Emergency Vehicles, requiring access from Huntly Place, Inverness, to Gilbert Street, may only take such access on those days and at those times deemed appropriate by the Engineer or Contractor, during the period stated in Article 1 of the Order.

(55) Vehicles, including Emergency Vehicles, requiring access from Dunabban Road, Inverness, to Gilbert Street, may only take such access on those days and at those times deemed appropriate by the Engineer or Contractor, during the period stated in Article 1 of the Order.

(56) Subject to Articles 5(54) and/or 5(55) of the Order no person shall drive or cause or permit to be driven on Gilbert Street, Inverness, between its junction with Grant Street and its junction with Dunabban Road, other than in the direction indicated by means of traffic signs of a type prescribed or character authorised under Section 64 of the Road Traffic Regulation Act 1984.

(57) Vehicles requiring Access are exempt from the restrictions detailed in articles 5(1) to 5(11), 5(29) to 5(33) and 5(49) to 5(50) of the Order, subject to the discretion and by the instruction of the Engineer or Contractor.

(58) Emergency Vehicles requiring Access are exempt from the restrictions detailed in articles 5(1) to 5(11), 5(29) to 5(33) and 5(49) to 5(50) of the Order, subject to the discretion and by the instruction of the Engineer or Contractor.

(59) Pedestrian access may be restricted, on those roads listed in Articles 5(1) to 5(11), 5(29) to 5(33) and 5(49) to 5(50) of the Order, on those days and at those times deemed necessary by the Engineer or Contractor, during the period stated in Article 1 of the Order.

(60) The restrictions listed in the Order may apply to the entire length of road named, or any section, or sections, contained therein.

(61) The restrictions listed in the Order may apply on any day or at any time, deemed necessary by the Engineer or Contractor, during the Period stated in Article 1 of the Order.
