**Disabled Persons' Parking Places (Scotland) Act 2009**



Application form for disabled persons' parking place

Disabled parking places are for people who have severe problems getting around and who currently have a blue badge. To qualify for a disabled persons' parking place you must have a blue badge and a suitable vehicle must be registered with DVLA to your address.

**If you think you meet these requirements and want to apply for a disabled persons' parking place. Please complete this form and return it with a photocopy of the V5 – vehicle registration document (Do NOT send the original) - to The Highland Council Service Centre, Alness Business Park, Alness, IV17 OUP**

**Remember when using a disabled persons' parking place**

- You must have your blue badge on display in your car, otherwise the Police/Traffic Warden can issue you with a fixed penalty notice
- These parking places are not for your exclusive use and can be used by anyone displaying a blue badge
