# The Direct Debit Guarantee



- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit The Highland Council will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request The Highland Council to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by The Highland Council or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
  - If you receive a refund you are not entitled to, you must pay it back when The Highland Council asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

The Highland Council and Scottish Water are committed to providing quality services, which make a real difference to you, and to the wellbeing and sustainability of the Highland community as a whole. If you choose to pay by Direct Debit, you will be helping us to maintain and where possible to improve the quality and range of services we provide.

#### What is in it for you?

- You choose the payment date which best suits you.
- You can choose to pay by Direct Debit: weekly, fortnightly, monthly by 10 or 12 instalments, quarterly or by a lump sum payment.
- You can choose to pay on the 1st, 15th or the 28th of the month, if you elect to pay over 10 or 12 instalments or by a lump sum payment.
- You can choose to pay over 10 months with one payment holiday in July and August; December and January; or February and March.
- You will receive a bill showing the amount(s) we will collect from your account.
- You will be able to budget, safe in the knowledge that if you pay by Direct Debit a set amount will be taken from your account each period.
- You give us your details only once and every year the Council and your Bank or Building Society will do the rest.

You won't need to write or post cheques or queue to make payments.

You won't need to remember or be reminded to pay. Your payments will always be made on time so there is no need to worry about receiving a Reminder Notice, Final Notice or being the subject of court action.
