# MEASURE 1

## Description of proposed measure

1.0 Maintaining the economic and social prosperity of fisheries communities

## **Specific Objective**

To provide training programmes for existing fishermen, fish farmers and the fisheries community which help develop new business skills and new enterprises.

To prepare feasibility studies and community development plans in fisheries communities that can be a focus for longer-term development activity.

Training in marine skills for school leavers and those wishing to follow a career in the marine sector

#### Rationale

SWOT analysis indicates that within the FLAG area one of the main strengths lies in the skills held by workers in the fisheries and aquaculture sector. However a weakness lies in the seasonality of their work and a shortage of workers with the correct or transferable skills that could be recruited to maintain or enhance economic activity.

A further weakness is lack of resources within communities to support the preparation of appropriate development plans that will establish longer term development needs.

#### Scope of action

- Preparation of community development plans;
- Training programmes designed to support economic diversification and skills transfer;
- Marine skills training for school leavers wishing to enter the maritime sector.

# **Specific Objective**

Improving quality of fishery and aquaculture products

Piloting collaborative management and exploitation of fishery resources

## Rationale

SWOT analysis identifies the high quality fisheries and aquaculture resource that is available within the FLAG area. However it also identifies limited processing capacity in some parts of the FLAG area, the predominance of consigning outwith the area, limited local markets and highly seasonal local markets for some of the products within the FLAG, particularly with regard to shellfish species.

# Scope of action

- Projects designed to improve quality, diversity, value and availability of fishery products throughout the year from the FLAG area;
- Collaborative projects in local fisheries exploitation which improve sustainability and value within the FLAG area.

#### Rationale

SWOT analysis indicates that within the FLAG area strengths lie in the very high quality of the natural environment and the attractions the coastal environment has as a destination for visitors from the UK and mainland Europe. Weaknesses lie in the condition and availability of infrastructure in some areas to support visitors and to encourage them stay longer.

#### Scope of action

- Installation if infrastructure at harbour facilities which encourages visitors to the area and longer stays;
- Support for businesses that service the visitor sector;
- Support for community development projects that diversify employment within FLAG areas

## Rationale

There are a large number of natural heritage designations within the FLAG area and the SWOT analysis identifies the quality of the natural environment and the social and cultural heritage of fisheries areas as valuable strengths, where there are opportunities to development the provision of interpretive facilities for visitors.

## Scope of action

- Developing new or improving visitor facilities
- Local interpretive projects, panels, publications and signage
- Guided walks and coastal excursions
- Marine safaris and nature trails
- Cultural/social history events

#### Rationale

The European Fisheries Areas Network (FARNET) exists to assist fisheries areas across the EU confront significant and similar challenges. It provides support for capacity building, testing and transferring successful responses and creates a platform for linkinglearing and innovation in fisheries areas to EU and national policy.

Within the UK there are other fisheries regions that have been implementing economic diversification programmes via Axis 4, LEADER and other community development frameworks.

A SWOT analysis has identified poor linkages with other national and international fisheries areas that are undergoing similar changes as a weakness. This action will provide the opportunity to learn from other fisheries areas that have wider experience of the use of EFF Axis 4 and demonstrate significant economic outcomes.

#### Scope of action

- Support for projects developed in fisheries communities that promote national and international exchange and learning in the field of community development, capacity building and economic diversification.
- Support for collaborative fisheries management projects that seek to help integrate fisheries and fisheries management with other maritime activities.
