The new Local Plan area substantially coincides with the combined areas of the North West Sutherland, Tongue & Farr, Golspie & Lairg and South & East Sutherland Local Plans, and also with some small parts of the areas covered by the Caithness, Ross & Cromarty East and Wester Ross Local Plans. The new Local Plan, once adopted, will therefore replace these seven older Local Plans but only in so far as they relate to any part of the area of the new Sutherland Local Plan.
