
I have attached a map and key which was submitted by Tongue Community Council at the early stages of Local Plan development prior to publishing our issues and options 'Sutherland Futures'.

It should be noted that the attached was not submitted or referred to alongside any sustained objection to the Plan, but it does give an indication of a housing area to south of SDA which was previously suggested after local consultation (not submitted directly by the Melness Crofters Estate). I understood from their objection that their reference to extension of the SDA to the south referred to the sports facility, not and another suggested extension of the SDA to the south. The objection does state 'in particular' in relation to the sports facility but in the absence of directly seeking another extension or marking it on a map I did not consider this an outstanding issue to be covered in a schedule 4.

I am sorry I was not available on Friday to explain the background, if I can be of any further assistance please let me know.



Carol-Anne,

In response to your e-mail, there was in fact a full planning application reference 00/00111/FULSU for creation of a sports field and car park which was granted permission, and additionally there was a separate outline planning application reference 00/00112/OUTSU for erection of a sports/ leisure building which was also granted permission. I attach a map which shows the sites of these. This is an extract from the committee papers as the original applications' site plans which are now only held by us in scanned form are difficult to make out.
