# **NOTES** for the completion of the Agricultural Exemption Claim Form

You may claim this exemption if the property is unoccupied and unfurnished and is situated on lands and heritages used for agricultural or pastoral purposes only, or as woodlands, market gardens, orchards, allotments or allotment gardens, fish farms or forestry, or, on lands exceeding one tenth of an hectare used for the purpose of poultry farming;

### **AND**

When last occupied and used, was occupied together with and used in connection with the lands and heritages on which the dwelling is situated.
