

## **The Highland Council**

### **The Roads (Scotland) Act 1984 and the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947.**

The Highland Council (hereinafter referred to as “the acquiring authority”) in exercise of the powers conferred by sections 103 to 106 inclusive as read with section 110(2) of the Roads (Scotland) Act 1984 hereby make the following compulsory purchase order–

**1.** This Order may be cited as The Highland Council (Inverness West Link) Compulsory Purchase Order 2013.

**2.** Subject to the provisions of this Order, the acquiring authority are hereby authorised to purchase compulsorily for the purposes of (a) the construction of a public road and bridges comprising a primary distributor road linking the Inverness Southern Distributor B8082 at Holm Roundabout, Dores Road, Inverness with the A82 Inverness-Fort William Trunk Road at Glenurquhart Road, Inverness and (b) mitigating any adverse effect which the existence or use of the said road and bridges has or will have on the surroundings of said road and bridges (One) the land which is described in the Schedule hereto and is delineated in red and coloured pink on the three maps signed with reference to this Order and marked “Map No. CPO1 referred to in The Highland Council (Inverness West Link) Compulsory Purchase Order 2013”, “Map No. CPO2 referred to in The Highland Council (Inverness West Link) Compulsory Purchase Order 2013” and “Map No. CPO3 referred to in The Highland Council (Inverness West Link) Compulsory Purchase Order 2013” respectively and the location of which land is shown on the location plan signed with reference to this order and marked “The Location Plan for the Maps referred to in The Highland Council (Inverness West Link) Compulsory Purchase Order 2013”; (Two) the various servitude rights over the land which is described in the Schedule hereto and is delineated in red and coloured blue on the said maps and the location of which land is shown on the said location plan; and (Three) the various servitude rights over the land which is described in the Schedule hereto and is delineated in red and coloured green on the said maps and the location of which land is shown on the said location plan.

**3.** In relation to the foregoing purchase section 70 of the Railway Clauses Consolidation (Scotland) Act 1845 and sections 71 to 78 of that Act as originally enacted and not as amended for certain purposes by section 15 of the Mines (Working Facilities and Support) Act 1923 are hereby incorporated with the enactment under which the said purchase is authorised, subject to the modifications that references in the said sections to the company shall be construed as references to the acquiring authority and references to the railway or works shall be construed as references to the land authorised to be purchased and any buildings or works constructed or to be constructed thereon.
