# 5. Appointment of Assessor and Electoral Registration Officer Suidheachadh Dreuchd Mheasadair agus Oifigeir Clàraidh Thaghaidhean

There had been circulated the agreed presentation topic. A list of possible interview questions was tabled. Members agreed a list of five questions to be posed to each candidate.

Members also had available the papers previously circulated for the Shortlisting meeting on 9 October 2013, which included copies of the Job Description and Person Specification and of the two applications under consideration.

### **Interviews**

In the course of each interview, the candidate gave a presentation on the agreed topic. The Panel then asked questions in relation to the presentation; the set of five interview questions as selected; and supplementary questions as appropriate.

Thereafter, the Panel Members, following a professional assessment by the External Adviser of each presentation and set of interview responses, considered each candidate in light of this assessment, the performance of each candidate, and the Job Description and Person Specification and the essential criteria identified therein.

Following deliberation, the Panel **AGREED** to offer the post of Assessor and Electoral Registration Officer to Mr W Gillies, currently Depute Assessor and Electoral Registration Officer with the Highland and Western Isles Valuation Joint Board. Mr Gillies was offered and verbally accepted the post.

The meeting ended at 11.45 a.m.
