North Highland Onshore Vision – Action Plan Update

Report by Director of Planning and Development

Summary

The purpose of the North Highland Onshore Vision is to identify key land use planning actions which will help to support the growth of the marine renewables sector in North Highland. As part of this, the Highland Council agreed a 10 point action plan in May 2011 which was developed in consultation with a variety of stakeholders. The action plan sets out a framework for delivering support for the sector by providing actions, together with timescales, the lead agency and some of the other key partners involved.

An annual update, setting out revised actions, was agreed by the Caithness and Sutherland Area Committee in November 2012. The purpose of this report is to provide an update on the progress made during 2013 and asks Members to agree the revised version of the Action Plan for the coming year.

1. Background

- 1.1 The marine renewables sector covering wave, tidal and offshore wind energy is expected to expand significantly in the Caithness and North Sutherland area over the next 20 years. The National Planning Framework 3 (NPF3) Main Issues Report (2013) continued to identify the Pentland Firth as an 'area for co-ordinated action' and the Council is promoting the potential economic benefits and employment opportunities that this sector will bring to the area. This is reflected as a key priority for the Caithness & North Sutherland Regeneration Partnership, of which the Highland Council is a partner. The designation of the Pentland Firth and Orkney Waters as Scotland's first Marine Energy Park should provide further stimulus to the sector and make the area more attractive for inward investment.
- 1.2 The Planning Environment and Development (PED) Committee, at its meeting in May 2011, agreed a 10 point action plan which focussed primarily on the land use planning of onshore development associated with the marine renewables sector in North Highland. An updated version was agreed by Caithness and Sutherland Area Committee in November 2012.
- 1.3 A further updated version of the 10-point action plan is attached to this report as Appendix 1 for consideration. It sets out a framework for delivery by

providing timescales, the lead agency and some of the other key partners involved. Updates on progress with the actions are reported on a frequent basis to the Pentland Firth and Orkney Waters Leadership Forum and through the Caithness and North Sutherland Regeneration Partnership.

2. Action Plan Progress

- 2.1 Progress has been made on a number of the actions set out in the Action Plan and updates for all actions are documented in Appendix 1. The following provides some further information, particularly regarding the linkage to other development planning work of the Council.
- 2.2 Following the call for sites exercise (Action 2) undertaken in late 2012 which focused exclusively on seeking suggestions of sites which could be developed for employment uses to support the marine renewables industry, initial analysis was undertaken of the suggestions received and outline information was published on the Council website. Information about sites in Wick and Thurso was fed in to the charrettes held in the towns in February 2013. The site suggestions are now being taken forward through the Caithness and Sutherland Local Development Plan (CaSPlan). The aspiration for the area to embrace economic opportunity is clear, as is the need to plan carefully for it. As part of CaSPlan preparation, each site suggestion will be subject to strategic environmental assessment (SEA) and the Council will come to a view on which sites it prefers.
- 2.3 For Delivering Development (Action 4), we can report that a recent and very useful liaison meeting was held in August between planning officers of The Highland Council, Orkney Islands Council and Marine Scotland, with a focus on delivering marine renewables. It is intended to hold such meetings regularly, on a quarterly basis. Through this we are sharing experience and practice, discussing day-to-day working arrangements for dealing with developments in the coastal zone and for the relationship between marine and terrestrial planning, and on siting and design issues. We will continue to work on these issues together during 2014. In terms of siting and design guidance, in North Highland there is likely to be a particular focus on planning for infrastructure in the coastal zone, in existing infrastructure corridors and for hubs (whereas on the Orkney Islands there is likely to be greater need, in addition, for entirely new infrastructure corridors to be identified).
- Turning to Masterplans for Scrabster/ Thurso West (Action 6) and for Wick Harbour and Lower Pulteneytown (Action 7), outline information about the aspirations of the harbours and their plans together with information about opportunities for nearby properties was fed into the Wick and Thurso charrettes. This provided opportunity in each case for these to be discussed within the context of community aspirations for the town as a whole; there was consensus that the harbours have a key part to play in the towns' future and an understanding that this would require development. There remains value in teasing out detailed issues as we go forward with CaSPlan, to ensure that what we include for the harbours in the Proposed Plan is sufficient and robust and, if necessary, is supplemented by additional guidance. There is therefore

a tie-in with the timetable for CaSPlan for exploring the specific issues further and consulting on them.

3. Caithness and Sutherland Local Development Plan (CaSPlan)

- 3.1 The North Highland Onshore Vision work is feeding in to preparation of the Caithness and Sutherland Local Development Plan (CaSPlan). Marine renewables and related opportunities will play a major role in this plan.
- 3.2 Work formally commenced on CaSPlan itself in early 2013 and early stages have been as follows:
 - 1. Beginning preparation of the Monitoring Statement;
 - 2. Charrettes for Wick and Thurso were held in February 2013, the Final Charrettes Report brought to Area Committee in May 2013 and followon meetings held with the communities in June 2013;
 - 3. A general Call for Sites and Ideas for CaSPlan was held 23 August to 17 October 2013.

3.3 The next steps include:

- 1. Assessing the Call for Sites and Ideas suggestions, and feeding in the Charrette outcomes;
- 2. Completing preparation of the Monitoring Statement;
- 3. Preparation of and consultation on a Main Issues Report;
- 4. Preparation of and consultation on a Proposed Plan.
- 3.4 In preparing CaSPlan we are aiming to focus it on the delivery of specific outcomes. We are therefore looking carefully at the Single Outcome Agreement, the Council's Programme and outcomes sought by other partners, discussing these with them in order to be clear on shared outcomes and to identify key outcomes for CaSPlan itself.
- Our intention is to bring a report on draft contents for the Main Issues Report to the next meeting of the Area Committee in February 2014 for consideration.

4. Fit with the Programme for the Highland Council 2012 – 2017

4.1 The work outlined in this report contributes to several commitments within the Council's Programme 'Working Together for the Highlands'. It helps to provide a comprehensive sustainable economic growth strategy based around the renewables sector for the area including supporting Scrabster Enterprise Area and the area's ports. The work also contributes to the Council's Single Outcome Agreement commitment to align with national outcomes for making the area an attractive place to do business, help fulfil its economic potential, create better employment opportunities and contribute to a better educated and skilled workforce.

5 Resource implications

5.1 The North Highland Onshore Vision Action Plan was approved by PED committee in May 2011 and as such the work streams are provided for in our programme and budgets.

6 Equality implications

6.1 An EqIA Screening will be undertaken for the Local Development Plan and Supplementary Guidance documents which are to be prepared.

7 Climate Change and Carbon Clever implications

7.1 Strategic Environmental Assessment (SEA) will be carried out to assess any policy and site options identified in the CaSPlan Main Issues Report, including for each site submitted as part of the call for sites. A core part of this assessment is to consider the impact on greenhouse gas emissions and climate change.

8 Legal and Risk implications

8.1 Our local development plans and supplementary guidance will be produced in accordance with statutory requirements.

9 Conclusions

9.1 The North Highland Onshore Vision is a key piece of work in maximising the onshore benefits in Caithness and North Sutherland from the anticipated expansion of marine renewables. The Action Plan is a valuable tool as it sets out 10 particular projects and outlines the lead agent, important partners, and target dates for completion. This report presents an updated version of the action plan to highlight progress made, current status, and agree revised target dates.

- 2) Agree the revised Action Plan which sets out updated targets and timescales for the coming year; and

NORTH HIGHLAND ONSHORE VISION: 10 POINT ACTION PLAN - NOVEMBER 2013

Appendix 1

This action plan focuses primarily on the land use planning of onshore development associated with the expected expansion of the marine renewables sector in North Highland. It has been developed by the Council in consultation with partners and includes both infrastructure and support industry requirements. As a result it will make a practical contribution towards ensuring a coordinated planning approach to the delivery of onshore development for the marine renewables industry in Caithness and North Sutherland.

The 10 key action points are set out in the table on the following page – the actions shaded purple relate to the action plan which was approved in November 2012 and the points which are not shaded are the updated actions.

The aim of the action plan is to provide a clear framework for delivery by showing timescales, who will drive forward pieces of work and other partners involved; however it does not attempt to list everyone that could ultimately be involved such as Nuclear Decommissioning Authority (NDA), Dounreay Site Restoration Ltd (DSRL), Skills Development Scotland, Caithness Chamber of Commerce and the North Highland Initiative. The Council will seek agreement from partners that they will contribute to delivery of the actions.

The Council intends to finalise this Action Plan by working with partner organisations including Caithness and North Sutherland Regeneration Partnership to ensure that the proposals fit well with their work streams and working arrangements.

THC is working with OIC and Marine Scotland to prepare a Marine Spatial Plan; Issues and Options Consultation was held in summer 2013. THC have succeeded in promoting 'Orkney, Pentland Firth and North Caithness' as an 'Area of Coordinated Action' in National Planning Framework 3's Main Issues Report.
