Community Learning and Development Consultation

Report by Director of Education, Culture and Sport Service

SUMMARY

This report provides information on the Scottish Governments consultation on new legislation to place a responsibility on Local Authority Education Services to co-ordinate the delivery of Community Learning and Development Services from 1st September 2013.

1. INTRODUCTION

1.1 In June 2012 the Scottish Government issued strategic guidance for community planning partnerships

This guidance set the focus of community learning and development (CLD) as:-

- Improved life chances for people of all ages, through learning, personal development and active citizenship.
- Stronger, more resilient, supportive, influential and inclusive communities.
- 1.2 The Scottish Government in acknowledging that there is a weak legislative basis for CLD has drafted new legislation to place a responsibility on Local Authority Education Services (because of the learning focus required in the legislation) to co-ordinate the delivery of CLD Services from 1st September 2013.
- 1.3 The key policy goals of the draft legislation requirements are as follows:-
 - Communities across Scotland, but particularly those with a disadvantage, have access to the CLD support they need.
 - Communities across Scotland are enabled to express their needs for CLD provision.
 - Community planning partnerships, Local Authorities and providers of public services respond appropriately to the expectations set by the CLD strategic guidance.

The regulations place a responsibility on Local Authorities to demonstrate how they are planning and co-ordinating the delivery of CLD services via the submission of a CLD plan every 3 years.

2. RESPONSE TO CONSULTATION

- 2.1 The requirement to increase the level of co-ordination and joint planning and delivery of services which deliver learning in communities fits well with the Council's priorities of:-
 - Caring communities
 - Empowering communities
 - Strong and safe communities
- 2.2 A response required to be submitted by 26th April and this is appended as **Appendix 1** to this report.

Given very close working with Education Scotland and the close fit of the key policy goals with the Council's priorities a positive response was submitted simply seeking a strengthening in the areas of:-

- A broadening of the legislation from individuals and groups to include specific communities.
- The placing of an obligation on all publicly funded organisations with a learning focus to participate in the processes to support the goals outlined in Section 1 of this report.
