20mph Speed Limit Avoch

Report by Director of Transport, Environmental and Community Services

Summary

This report invites Members to approve the 20mph speed limit within the village of Avoch in accordance with the Draft Road Traffic Order (DRTO) entitled The Highland Council (Avoch Village) (20mph Speed Limit) Order 2013. One objection has been received in response to the DRTO.

1. Background

- 1.1 As part of the Council's strategy to introduce 20mph speed limits as a measure to improve road safety and provide an environment to encourage walking and cycling, plans were drawn up to introduce a 20mph speed limit on High Street and various residential streets on the older part of the village of Avoch.
- 1.2 A draft order entitled The Highland Council (Avoch Village) (20mph Speed Limit) Order 2013 was prepared.
- 1.3 A drawing showing the area of the proposed 20mph speed limit is shown in **Appendix 1**.

2. Statement of Reasons

2.1 Following representation from the public and consideration by the local Ward Members it was considered appropriate, in the interests of road safety, to promote a 20 mph speed limit on part of the A832 Road and some of the roads that make up the village of Avoch.

3. Consultation

- 3.1 The following were consulted on the proposals for a 20mph speed limit on High Street and other streets in Avoch:
 - Ward Members
 - Community Council
 - The Emergency Services
 - Freight Transport Association
 - Bus Companies

- 3.2 There were no objections to the proposals from any of the above.
- 3.3 The proposals were then advertised in the local press and letters were sent to all premises on the affected streets.

4. Objection to the Draft Road Traffic Order

- 4.1 One objection to the DRTO has been received from Nr Neal Drummond.
- 4.2 Under the Council's Scheme of Delegation, the power to make a permanent Road Traffic Order is delegated to the TECS Committee where there are unresolved objections.
- 4.3 The Committee has three options:
 - 1. Approve the proposed 20mph speed limit as advertised and instruct its implementation
 - Order a formal local hearing in accordance with the Local Authorities Traffic Order (Procedures) (Scotland) Regulations 1999 to decide the matter.
 - 3. Accept that the objection is valid and instruct that the Draft Order be withdrawn and redrafted.

5. Objections - in Summary

Mr Drummond's objection is that the 20mph speed limit should not apply to High Street, A832 as it would cause driver frustration and increase journey times. Correspondence from Mr Drummond and the Council's response is included at **Appendix 2**.

6. Response – in Summary

- 6.1 In response to his correspondence Mr Drummond was informed that the Council had a policy in relation to 20 mph speed limits in town and village centres and residential areas and the benefits gained from the introduction of these measures. He was made aware that the desire for a 20mph speed limit in the village was initiated by the community through the Community Council.
- 6.2 Mr Drummond has been informed that the proposal, including all correspondence, will be included on the agenda for a future TECS Committee meeting.

7. Implications

7.1 There are no resource implications arising from this report, as the work is included in existing budgets.

- 7.2 There are no legal implications arising from this report
- 7.3 There are no equality implications this report
- 7.4 Reduced vehicle speeds through will reduce carbon emissions into the atmosphere.
- 7.5 There are no risk implications arising from this report.


8. Recommendation

Dear Neal

I refer to the various email correspondence below regarding the proposed 20mph speed limit on High Street in Avoch and your objection to it.

As Drew has intimated, the local community, represented by the community council intimated a strong desire to have a 20mph limit in the village, both to replace the existing advisory 20mph limit in Henrietta and Ormonde Terrace and to cover the streets in the dock area.

The initial proposal submitted did not include High Street, but the Community Council were concerned by the number of signs required to highlight the speed limit change at the High Street end of every street. This was exacerbated by the fact that it was often difficult to find a suitable location to erect the signs due to the variable pavement widths. To remove the need for all the speed limit signing on the High Street/ side street junctions, it was agreed to provide a 20mph limit on High Street. This was however kept as short as possible while still covering all the side street links which will have a 20mph limit.

The proposal to have the 20mph limit on the High Street also reflected the council's policy to provide 20mph limits in town and village centres and in residential areas. The aim of this policy is to improve the quality of life for local residents and for the vulnerable users in our town and village centres where there is a general concentration of pedestrian movements. The lower speed limit is also aimed at encouraging the use of healthier and more sustainable transport modes such as walking and cycling. There may also be environmental benefits as, generally, driving more slowly at a steady pace will save fuel and reduce pollution.

I note and share your concerns about excessive use of traffic calming to provide a reduced speed limit and the effect this would have on the flow of traffic through the village. I can therefore assure you that all the physical works on the High Street have been completed apart from some lining works and the erection of the 20mph signing; depending on the resolution of objections. On the basis of this I maintain that delays will be minimal as previously outlined.

The scheme we developed did not change the available parking on the High Street but did remove where possible the chances of vehicles parking on the pavement at the east end to allow disabled users free passage along the street.

While I accept you are not really not in agreement with the proposals for a reduced speed limit on High Street, I would hope that you will see that the scheme will benefit the more vulnerable users in the village. On the basis of the above I hope you would feel able to remove your objection to the proposed speed limit.

Dear Neal,

I refer to you recent e-mail lodging an objection to the proposed 20mph speed limit on the A832 Road in Avoch.

The Community Council have been for some time seeking a 20mph speed limit in the old part of the village to the south west of the A832 road. When plans were produced for them showing 20mph speed restriction signs on all side roads leading from High Street, the Community Council rejected them because of the sign clutter that was required to introduce an enforceable speed limit. They were however happy to have the A832 Road included within the 20mph restriction because it removed the need for so many signs in their village and provided a safer and more pleasant environment for pedestrians. There have in fact been 4 reported road accidents on this section road in the 3 year period up to July 2012.

I cannot accept that the introduction of a 20 mph speed limit in Avoch is going to be a disincentive to anyone wishing to live in the pleasant country environment that the Black Isle offers. The time penalty involved if travelling along the section of road mentioned is only 19 seconds if travelling at 20mph instead of 30mph, hardly a significant length of time in any journey.

Now that I have explained the reasons behind the proposed 20mph speed limit on the A832 in Avoch I hope that you will reconsider your position and withdraw your objection.
