Review Hearings and Update on Non Payment of Annual Premises Licence Fees 2013/14

Report by the Clerk to the Licensing Board

Summary

This Report relates to review hearings in respect of the non-payment of annual premises licence fees for the period 1 October 2013 to 30 September 2014.

1.0 Background

1.1 In terms of the Licensing (Scotland) Act 2005, Schedule 3, Mandatory Condition 10, an Annual Premises Fee must be paid in accordance with the regulations.

In terms of the Licensing (Fees) (Scotland) Regulations 2007 payment of the Annual Premises Licence fee is due on 1 October each year.

- 1.2 At its meeting on 17 December 2013 the Board agreed to make review proposals in respect of a number of premises licences where the annual fee had not been paid.
- 1.3 A Review Hearing must be commenced within 42 days of the date of the making of the review proposals.
- 1.4 Due to the festive period and to allow more time for the annual fee to be paid, the Review Hearings cannot take place today but should be adjourned to the Board meeting on 4 February 2014. Premises Licence holders have been notified accordingly.
- 1.5 The Appendix to this Report details those premises licence annual fees which remain outstanding as at 6 January 2014 and those that have been surrendered.

Recommendation

The Board is invited to adjourn the Review Hearings in respect of those premises which have not paid their annual fee to the scheduled meeting of the Board on 4 February 2014.
