Application for a major variation of Premises Licence under the Licensing (Scotland) Act 2005

Harpers, 17-19 Back Bridge Street, Wick

Report by the Clerk to the Licensing Board

#### Summary

Ref: HC/CSER/1594 Premises: Harpers, 17-19 Back Bridge Street, Wick Applicant: Alexander M Harper

This Report relates to an application for a major variation of Premises Licence.

### **1.0** Description of Premises

**1.1** The premises was granted a premises licence on 22 November 2011. The premises are a detached two storey building in Wick town centre comprising a public bar, lounge bar, function room, outdoor drinking area and associated facilities on the ground floor.

### 2.0 Summary of Variation Application

- 2.1 1. Variation to On Sales Hours: Sunday 1100 hrs to 0100 hrs
  - 2. Variation to Off Sales Hours: Sunday 1100 hrs to 2200 hrs
  - 3. Add gaming as an activity or service to be provided outwith core hours.
  - 4. Add seasonal variation "The premises shall seek to operate any period of extended hours offered by the Highland Licensing Board such as festive extensions".

### 3.0 Background

3.1 On 12 November 2013 the Licensing Board received an application for a major variation of a Premises Licence by the applicant.

- 3.2 The Board has advertised the application on the Council's website for a period of 21 days and the applicant had to display a Notice on site for the same period.
- 3.3 In accordance with standard procedure, Police Scotland, Scottish Fire and Rescue Service, the Council's Environmental Health, Planning and Building Standards were consulted on the application.

Notification and a copy of the application have been sent to NHS Highland and to the local Community Council.

- 3.4 A notice of the application has been sent to all the people listed under S21(1) of the Act.
- 3.5 No objections have been received in respect of the application.

### 4.0 Legislation

4.1 The Licensing Board must in considering and determining the application, consider whether any grounds of refusal apply and if none of them applies, the Board must grant the application.

Relevant grounds of refusal may be: -

- 1. the grant of the application will be inconsistent with one or more of the licensing objectives;
- 2. having regard to; (i) the nature of the activities carried on or proposed to be carried on in the subject premises, (ii) the location character and condition of the premises, and (iii) the persons likely to frequent the premises, if the Board considers the premises are unsuitable for use for the sale of alcohol in accordance with the proposed variation;
- 3. having regard to the number and capacity of (i) licensed premises of the same or similar description as the subject premises (taking account of the proposed variation), in the locality in which the subject premises are situated, the Board considers that, if the application were to be granted, there would, as a result, be over provision of licensed premises or licensed premises of that description in the locality.
- 4.2 The Board has power where, if they would refuse the application as made, but if a modification is proposed by them and accepted by the applicant, the application can be granted as modified.

## 5.0 Licensing Standards Officer's Comments

- 5.1 The changes to licensed hours at paragraph 2.1 for On sale and Off Sales on a Sunday are in line with Board policy.
- 5.2 The premises may be open during and outwith licensed hours for certain activities and services. The applicant initially wished to add Gaming as an activity or service to be provided outwith core licensed hours but now wishes to amend the application to withdraw that element and requests that the Board allow the amendment.

5.3 The seasonal variation applied for is in accordance with Board policy.

# 7.0 Conditions

# 7.1 Mandatory Conditions

If the application is approved the Mandatory Conditions set out in Schedule 3 of the Act will apply.

# 7.2 Local Conditions

Existing local conditions and addition of -

(q) The licence holder shall submit to the Board and to Police Scotland, prior to 1 December each year, notice of the dates within the festive period on which it is intended that the premises remain open until the festive period terminal hour stated for that category of premises in the Board's Policy Statement. The Premises may remain open until the festive period terminal hour only on those dates for which notice has been given by the licence holder to the Board and to Police Scotland in accordance with this condition.

## 7.3 Late Opening Local Conditions

The following shall apply on any occasion that the Premises are open after 0100 hrs.

1) A person trained to the satisfaction of the Licensing Board in administering first aid must be present on the premises from 0100 hrs (on any day when the premises are open at that time) until whichever is the earlier of-

- (a) the time at which the premises next close; and
- (b) 0500 hrs.

2) A designated person who is the holder of a personal licence must be present on the premises from 0100 hrs (on any day when the premises are open at 0100 hrs) until whichever is the earlier of:-

- (a) the time at which the premises next close, and
- (b) 0500 hrs.

## Recommendation

The Board is invited to determine the above application and the amendment to remove gaming outwith core hours as detailed at para 5.2, local conditions and late opening local condition(s) detailed at para(s) 7.2 and 7.3 above, noting that the application for variation is within the policy adopted by the Board on 1 October 2013 as the Board's new policy for 1 December 2013 to 30 November 2016.
