Late Hours Catering Licences – Applications for Exemption (Ward 15 – Inverness Central)

**Report by the Legal Manager** 

#### **Summary**

This Report relates to three requests received for exemption, under Section 42(5) of the Civic Government (Scotland) Act 1982, from the requirement to hold a late hours catering licence.

# 1.0 Background

- 1.1 The Highland Council has resolved that in terms of the Civic Government (Scotland) Act 1982 a licence will be required for the operation of a late hours catering premises. A licence is required where the premises are selling food during any of the hours between 11.00pm and 5.00am.
- **1.2** Section 42(5) & (6) of the abovementioned Act states that:
  - (5) A licensing authority may, on application made to them, exempt the use of premises requiring a late hours catering licence from the requirement to have such a licence —
  - (a) in respect of any particular occasion; or
  - (b) during a specified period not exceeding 2 months in any period of 12 months.
  - (6) The licensing authority may attach conditions to an exemption granted under subsection (5) above, and the provisions of Part I of this Act relating to the attaching of conditions to licences and subsection (3) above shall apply to the attaching of conditions to exemptions under this subsection."
- **1.3** Three applications for exemption have been received in respect of the following premises:
  - Zoom Takeaway, 23 Baron Taylor Street, Inverness.
  - McDonalds Restaurant, 12-22 High Street, Inverness.
  - Topkapi Takeaway, 44 Baron Taylor Street, Inverness.

# 2.0 Application 1 – Zoom Takeaway, 23 Baron Taylor Street, Inverness

- 2.1 Mr Mohammed Afif holds a late hours catering licence for the premises at Zoom Takeaway, 23 Baron Taylor Street, Inverness which expires on 23 September 2016.
- 2.2 The premises are currently licensed for the permitted policy hours for Inverness City Centre late hours catering premises these being:

Wednesday to Sunday – to 3.00am Monday and Tuesday – to 12 midnight

- 2.3 On 29 November 2013 a request was received from Mr Afif via his agent, MacLeod and MacCallum Solicitors, for exemption from the requirement to hold a licence under Section 42(5) of the abovementioned Act.
- 2.4 A copy of the letter from MacLeod and MacCallum Solicitors is attached in Appendix 1 and details the days and hours for which the exemption is sought, these being
  - To 4.00am from 18 December 2013 to 4 January 2014 (both dates inclusive).

# 3.0 Application 2 – McDonalds Restaurant, 12-22 High Street, Inverness

- 3.1 Mr Craig Duncan holds a late hours catering licence for the premises at McDonald's Takeaway, 12-22 High Street, Inverness which expires on 14 March 2016.
- 3.2 The premises are currently licensed for the following hours:

Sunday to Wednesday – to 12 midnight Thursday to Saturday – to 3.00am

- 3.3 On 2 December 2013 a request was received from Mr Duncan seeking exemption from the requirement to hold a licence under Section 42(5) of the abovementioned Act.
- 3.4 A copy of the letter from Mr Duncan is attached in Appendix 2 and details the days and hours for which the exemption is sought, these being
  - 21, 22 28 and 29 December 2013 to 4.00am.

#### 4.0 Application 3 – Topkapi Restaurant, 44 Baron Taylor Street, Inverness

- 4.1 Mr Enbiya Kilig holds a licence for the premises at Topkapi Takeaway, 44 Baron Taylor's Street, Inverness which expires on 8 November 2015.
- **4.2** The premises are currently licensed for the permitted policy hours for Inverness City Centre late hours catering premises these being:

Wednesday to Sunday – to 3.00am Monday and Tuesday – to 12 midnight

- 4.3 On 3 December 2013 a request was received from Mr Kilig seeking exemption from the requirement to hold a licence under Section 42(5) of the abovementioned Act.
- 4.4 A copy of the letter from Mr Kilig is attached in Appendix 3 and details the days and hours for which the exemption is sought, these being
  - To 4.00am from 23 December 2013 to 2 January 2014 (both dates inclusive).

#### 5.0 Consultation

- **5.1** Following receipt of these requests a copy of the same was circulated to the following Agencies/Services for consultation:
  - Police Scotland
  - Scottish Fire & Rescue Service
  - Highland Council Environmental Health Service
- **5.2** Due to the short consultation period any responses received will be tabled at the meeting.

#### 6.0 Conditions

As detailed in Paragraph 1.2 above if the Committee are minded to grant the exemptions the Act permits the Licensing Authority to attach conditions to the same. Attached in Appendix 4 are the standard licence conditions for late hours catering licences within Inverness City Centre which Members may wish to apply to any exemptions granted together with any additional conditions suggested by Consultees or as Committee may decide.

The Festive Season Policy, *inter alia*, states that applications for extended permitted hours will generally be granted to 4.00am for late night opening premises during the period from 13 December 2013 to 2 January 2014 (i.e. it ends on the morning of 3 January 2014).

#### 8.0 Comment

- **8.1** The application from Zoom Takeaway is for a period greater than the period covered by the Licensing Board's Festive Season policy.
- 8.2 During the period covered by the Licensing Board's Festive Season policy only one late night opening venue has been granted or given notice that they intend to implement the extended permitted hours to 4.00am during the entire period.

### 9.0 Recommendation

**9.1** Members are **invited** to determine the requests for exemption.

opening liquor licences (i.e. after 1.00 am)

7. The trader shall make arrangements to the satisfaction of the licensing authority for the disposal of litter or other refuse arising from his undertaking and will, during operating hours, at the close of business each day and at any other times designated by officers authorised by the Licensing Authority (hereinafter referred to as "Authorised Officers"), collect and remove all litter within a 50m radius of the premise, and sweep the area or pavement outside

his/her premises, that is to say sweep and thereafter remove and dispose of all waste and detritus from the area bounded by premises frontage to the kerb or similar structure.

- 8. The trader will regularly wash (and at least once weekly) or otherwise cleanse, the area or pavement outside his/her premises, to remove stains, grease, chewing gum etc or to a frequency agreed with Authorised Officers.
- 9. Steward(s) to be provided at the premises from 11.00pm until the premises close.

# **Additional Condition for Inverness Premises Only**

10. The trader shall hold membership of the Radio Link scheme throughout the term of the licence.
