1 General

1.1 This appendix provides project status information for current key capital projects funded by the Inverness Common Good Fund, including financial progress details, as at 23 May 2013.

2 Capital Programme Update

2.1 The current status of each individual project is summarised below.

2.2 **Restoration of Inverness Steeple**

- 2.2.1 The contract was completed on the 22 March 2012 and the defects liability period will end on the 21 March 2014.
- 2.2.2 The final account is still to be agreed and this will be completed by the end of May.

2.3 Adoption of Roads, Longman Drive, Inverness

2.3.1 The contract was completed on the 8 June 2012 and the defects liability period will end on the 7 June 2013.

2.4 Replacement of Gas Boilers; Inverness Town House

2.4.1 The contract has been awarded to Truedeal Building Services. The pre-start meeting is scheduled to take place on Thursday 30 May 2013.

2.5 **Conservation of External Fabric, Town House, Inverness**

2.5.1 The Design Team were appointed on 23 May 2013. The first design team meeting is scheduled to take place on Monday 27 May 2013. A programme will be discussed and agreed. The agreed programme will be taken to the next committee.
