Minutes of Meeting of the **Inverness Common Good Fund Grants Sub-committee** held in the 1st Floor Committee Room, Town House, Inverness on Monday, 12 May 2014 at 9.15 am.

1. Apologies for Absence

Apologies for absence were intimated on behalf of Mrs G Sinclair.

2. Declarations of Interest

The Sub-committee NOTED the following declarations of interest:-

3. Exclusion of the Public

The Sub-committee **RESOLVED** that, under Section 50(A) of the Local Government (Scotland) Act 1973, the public be excluded from the meeting during discussion of the following item on the grounds that it involved the likely disclosure of exempt information as defined in Paragraph 6 and 9 of Part 1 of schedule 7A of the Act.

4. Deprived Area Fund 2014-15

Following on from the last Grants Sub Committee Meeting a verbal update was given by Ms MacKenzie on the progress made to engage with community areas where there had been no application to the Deprived Area Fund (DAF).

Work Clubs have been set up in Smithton and Raigmore with support from DAF. Hilton Community Centre is currently undergoing a major refurbishment but on completion DAF will fund new laptops, sessional workers and volunteer expenses to get the Work Club operational. Ardersier have still to be contacted. Members were concerned that notable absences from the list were Dalneigh and the City Centre.

Following a discussion Members all agreed that the Merkinch Partnership was a good example of what can be achieved. However there were concerns that not all Job Clubs gave the same level of service. Consideration should be given to setting standards and encouraging collaboration between Work Clubs across the area, especially in relation to ensuring appropriate training and engagement with specialist advice services.

Although the Grants Sub Committee has been appointed to decide on awards of the DAF they do not set the local policy. This should be done at City Committee level. It was proposed that other organisations involved in community development including the NHS and Jobcentre Plus should also be involved and that a meeting should be arranged. Feedback on this meeting will be given to the City of Inverness Area Committee.

5. Requests for Financial Assistance 2013/14

There had been circulated Report No. GSC/08/14 dated 29 April 2014 by the Inverness City Manager. In this connection, there had been circulated separately a copy of the applications and any supporting documentation as Booklets A, B and C.

Mr Wardlaw drew the Sub Committee's attention to Appendix 1 and the funds available to the Committee for dispersal. There is also a roll-forward budget of £160,904 for grants committed in 2013/14 but not yet paid out.

The Sub Committee **NOTED** the Financial Monitoring information contained in Appendices 1- 5. Cllr Laird asked for the date of homologation to be inserted for applications approved outwith meeting dates.

Following consideration of the applications submitted, the Sub-committee **AGREED** to make the decisions regarding, disbursement of funds from the Grants Budget within the City of Inverness Common Good Fund Revenue Budget for 2013/14 as detailed in Appendix 1.

Cllr Laird left the room while Booklet A, item (9) was considered and Cllr McAllister took no part in the discussion.

6. Highland Military Tattoo

The Sub-Committee **AGREED** to homologate the decision to recommend approval to the City of Inverness Area Committee for a further award of £9,900 to the Highland Military Tattoo making a total of £14,900.

7. Addictions Counselling Inverness

The Sub-Committee **AGREED** to the request from Addictions Counselling Inverness for an amendment to their project to extend their project duration from December 2014 to June 2015.

8. Friends of Arms

The Sub-Committee **AGREED** to continue to waive the rent for the Multiple Sclerosis Therapy Centre for the year to 31st March 2015.

9. Requests for extension to Grant Period

The Sub-Committee AGREED to extend the time period to the Grants awarded to:-

- i. The Highlands Buildings Preservation Trust to end June 2014
- ii. Charleston Academy to October 2014 (project to be completed during the School Summer holiday).

10. Civic Functions – Protocol and Procedures

There had been circulated Report No. GSC 09/14 dated 29 April 2014 by the Inverness City Manager. This report followed on from the Protocol (affecting decision making) which was agreed after the Inverness City Committee held on 12 November 2007. Detailed within the report were proposals which: review the application process; enhance the information available; improve scrutiny; clarify the competency aspects that Members may wish to consider when making decisions and; confirm that a list of functions usually given support will be provided at the start of the new financial year.

The Sub-Committee AGREED:-

I. that applications will be considered competent if; (i) lodged 7 working days prior to each GSC meeting or (ii) if the event falls on a date prior to or just after the next appropriate GSC, or otherwise requires an urgent decision, consideration will be given to the application by emailing the Members of the GSC the application form. Members will be given a date to respond by and if no response received by that date it will be taken that they are in agreement with the recommendation. In the event of a majority of Members being in agreement, it shall be at the discretion of the Provost and the GSC Chair to confirm if they have any objection to the application being granted. In the event of any decision other than approval, the application shall be considered at a meeting of the GSC
