Business

1. Apologies for Absence

Apologies for absence were intimated on behalf of Mrs H Carmichael and Mr A Graham.

2. Declarations of Interest

3. Exclusion of Public

The Sub-Committee **RESOLVED** that, under Section 50(A) of the Local Government (Scotland) Act 1973, the public be excluded from the meeting during discussion of the following items on the grounds that they involved the likely disclosure of exempt information as defined in Paragraph 6 and 9 of Part 1 of schedule 7A of the Act.

4. Requests for Financial Assistance 2014/15

Declarations of Interest -

- Mrs B McAllister declared non-financial interests in relation to parts of this item on the grounds of being a Board Member of Merkinch Enterprise and on the Steering Group of Arts in Merkinch
- Mrs J Slater declared a non-financial interest in relation to part of this item on the grounds of being an Advisory Group Member on the Inverness Festival Association
- Mr G Ross declared a non-financial interest in relation to part of this item on the grounds of being a Member of Nairn Dunbar Golf Club
- Mr T Prag declared a non-financial interest in relation to part of this item on the grounds of being a member of the Inverness Marketing Group

but, having applied the test outlined in Paragraphs 5.2 and 5.3 of the Councillors' Code of Conduct, concluded that their interests did not preclude their involvement in the discussion.

In connection to the request for funding from Merkinch Community Centre, Mrs B McAllister pointed out that she was not a Board Member, despite being referred to as such in the application.

There had been circulated Report No. GSC/13/14 dated 1 August 2014 by the Acting Head of Community and Democratic Engagement which listed the applications received for financial assistance from the Inverness Common Good Fund together with an indication being given of whether the applicant had been a recent previous beneficiary. The report also showed:-

- the balance of funds available for allocation, the funds committed for Grants over and under £10,000 and for Subvention:
- the funds committed to major projects; and
- funds allocated from the City Promotions Budget.

In this connection, there had been circulated separately a copy of the applications and any supporting documentation as Booklets A, B and C. In this regard, additional information was tabled in relation to a supplementary application received from POL-UK Creative Writers.

Discussion then took place as to the applications listed in Appendix 7 of the report. Amongst the comments made were the following:-

Booklet A

<u>Phoenix Explorer Scouts and 2nd Inverness Kingsmills Scout Group</u> – clarification was received that £4,000 was being sought specifically from the Common Good Fund and related to 4 Scouts from Inverness.

<u>Inverness Chamber Music Society</u> – details as to how the Society might subsidise Concert Series in future years were requested.

<u>Merkinch Partnership</u> – Discussions were proposed with the Council's Employability Team and Merkinch Partnership regarding the possibility of the project forming part of the work being undertaken in the area funded from the Deprived Area Funding streams.

<u>Inverness Festival Association</u> – Members were reminded of the grant awarded to the Association the previous year. Members recognised the significant community involvement but, to encourage greater fundraising and marketing, were minded to give them £8,000, with a further £1,000 underwritten.

<u>High Life Highland</u> – it was suggested that an extra day opening, as referred to in the application, be held on a Sunday to encourage people into Inverness at the weekend.

<u>Highland Golf Links</u> – Golf played an important role in attracting people to Inverness and this application would heighten the profile of the Golf Links and would have significant benefit in terms of tourism to Inverness.

<u>POL-UK Creative Writers</u> – Members were provided with revised costs of the project. Members were of the view that funding to match that provided by the General Consulate of the republic of Poland be made, namely £1,100, but that all funding be confirmed prior to the grant being paid.

Booklet B

Inverness Angling Club – it was explained that the application was effectively a mechanism whereby a framework could be put in place which would give the Club, which was made up of volunteers, a 5-year rent free period. The Club had drawn up a programme of work that they wanted to instigate and which would make them more sustainable. It was suggested however that, rather than giving them the entire amount, funding be provided annually with a review and a report on progress also made annually before the next year's allocation of funding was granted.

In discussion, Members felt that a year-to-year allocation would make it difficult for the Club to draw up a business model and would have a detrimental impact on its sustainability and that a 2-3 year allocation would be more appropriate. It was important too to ascertain how the Common Good would benefit from its investment, in terms of additional husbandry and promotion of the river to visitors and young people, and the Club had already indicated that they were willing to enter into discussions regarding this. By proposing an "in principle" award the Common Good Fund also had the opportunity to ensure progress was made.

Merkinch Community Centre – disappointment was expressed that other forms of funding were not being pursued, the position being confirmed by the Acting Head of Community and Democratic Engagement that High Life Highland had

indicated that they were not in a position to support this project in the foreseeable future. As a result, it was suggested that High Life Highland meet with Merkinch Community Centre to find a way forward.

<u>Inverness Leisure Limited</u> – the upgrading of flood lighting at Queens Park would add value to the project offered and provide additional training facilities to promote athletics within the Inverness area. It was pointed out that there was a waiting list for youngsters to train at Queens Park and this would allow extended hours and competitions to take place in the evenings, bringing sports facilities in Inverness up to a national level.

The Sub-Committee:-

- i. considered the applications detailed in Booklets A, B and C and **DETERMINED** them as listed in Appendix 1 of this minute; and
- ii. **AGREED** to make recommendations to the City of Inverness Area Committee for its meeting on 2 September 2014 regarding those applications for more than £10,000.

5. Inverness Common Good Fund Scheme for Winter Payments 2014/15

There had been circulated Joint Report No. GSC/14/14 dated 1 August 2014 2014 by the Director of Finance and the Acting Head of Community and Democratic Engagement which followed on from the revision of the Winter Payment Scheme for 2013/14 and built on these amendments to improve the Winter Payment Scheme for 2014/15.

During discussion, confirmation was received, that the amount per person had been increased to £79 per person. The current budget had been increased from £52,000 to £102,000 but this was because the Scheme was demand led. With the widening of the criteria it was expected that there would also be an increase in expenditure and therefore additional resources had been proposed. The extension of the Scheme to include people with children under the age of 5 in receipt of specific benefits was also welcomed.

In relation to how Landward Areas were funded, it was confirmed that the proposed mechanism was competent given the emphasis on ensuring that those receiving funding also received advice on how to make their homes energy efficient and how to reduce their carbon footprint. In this regard, it was pointed out that no mention was made of the Landward Benevolent Funds and that detail of this should be included in the report submitted to the City of Inverness Area Committee.

The Sub Committee **AGREED**, taking into account the inclusion of the Landward Hardship Fund into the report to be considered by the City of Inverness Area Committee, to make the following recommendations to the City of Inverness Area Committee on 2 September 2014 for the Winter Payments Scheme:-

- i. that criteria for the 2013/14 scheme as set out in paragraphs 2.1 to 2.3 in the report be used as the basis for the 2014/15 scheme;
- ii. eligibility for the 204/15 scheme be extended to include those with children under the age of 5 years that also receive Income Support, Income based Job Seekers Allowance, Income based Employment and Support Allowance or Pension Credit (Guarantee Credit);
- iii. a single tier payment of £79 be made to those applicants that satisfy the eligibility criteria for the 2014/15 scheme;
- iv. the scheme be made available to residents in the City of Inverness and the Landward areas of the seven City Wards;
- v. the sum set aside within the Inverness Common Good Fund revenue budget 2014/15 for the Winter Payment Scheme, be increased to £102.000; and
- vi. £20,000 be donated from the Common Good Fund to the Blythswood Food Hamper Scheme for 2014/15.

6. Requests for Civic Hospitality 2014/15

Declarations of Interests -

Mr G Ross and Mrs J Slater declared non-financial interests in relation to parts of this item on the grounds of being named as having Promoted/Sponsored the request from the 2nd Inverness Company Girls' Guide application and being related to the applicant who had submitted the request on behalf of Inverness Town Twinning respectively but, having applied the test outlined in Paragraphs 5.2 and 5.3 of the Councillors' Code of Conduct, concluded that their interests did not preclude their involvement in the discussion.

There had been circulated Report No. GSC/15/14 dated 1 August 2014 by the Acting Head of Community and Democratic Engagement.

In this connection, there had been <u>circulated separately</u> a copy of the applications and any documentation as Booklet D. Additional information had also been circulated in relation to a supplementary application received for an application for a Civic Reception and Dinner for the Convention of the Highlands and Islands.

During discussion of the requests in relation to the Masters World Championships, additional information was sought on a number of specific points including the need for prior notice to be given for requests of this nature, the implications arising out of holding such events, the resources involved, details regarding the catering arrangements on specific days and that such proposals might be more appropriately funded from the Events and Festivals budget. The Acting Head of Community and Democratic Engagement assured Members that their various points would addressed and confirmed that an evaluation exercise would be carried out and submitted to the Events and Festival Working Group and the Inverness Common Good Fund Grants Sub Committee.

The Sub-Committee considered the applications detailed in Booklet D and **DETERMINED** the requests as listed in Appendix 2 of this minute.
