Application for Renewal of a Taxi Operator's Licence – Syed Ali (Ward 20 – Inverness South)

Report by the Legal Manager

Summary

This Report relates to an application for renewal of a taxi operator's licence.

This item is subject to a formal hearing procedure

1.0 Background

- 1.1 The Highland Council has resolved that in terms of the Civic Government (Scotland) Act 1982 a licence will be required for the operation of a licensed taxi. A licence for the same is issued by the Highland Council and is valid for the whole Council Area.
- **1.2** Mr Syed Ali currently holds a taxi operators licence which expires on 22 August 2014.
- **1.3** Mr Ali submitted an application for renewal of his licence on 5 August 2014.

2.0 Objection

- 2.1 Following consultation an objection in relation to the application was received on 8 August 2014 from the Council's Trading Standards Service, a copy of which is contained in Appendix 1.
- 3.0 Highland Council Penalty Points System for Taxi and Private Hire Car Operators
- 3.1 On 1 June 2006 the Council agreed the introduction of a penalty points system for licensed taxi and private hire car operators which formally came into use by Trading Standards on 1 July 2006.
- **3.2** The trigger point for formal action is 20 points.
- 3.3 The objection received from Trading Standards confirms that Mr Ali has accrued 29 penalty points taking him over the agreed trigger point.
- 3.4 Members are asked to note that some of the productions which are referred to in the Trading Standards Report have not been circulated but will be made available at the meeting.

4.0 Determination of Application

- 4.1 In terms of Section 5(3) of Schedule 1 of the abovementioned Act the Committee may refuse an application for licence where it deems the applicant not to be fit and proper to hold such a licence.
- 4.2 If Members are minded to grant the application the Committee could require the operator to present his vehicle(s) for inspection on a more frequent period then the current 6 or 12 month inspection regime e.g. every 3 months. This would allow the Trading Standards Service an opportunity to undertake a more regular monitor on this vehicle(s).

5.0 Recommendation

The Committee is invited to determine the application in accordance with the Council's Hearings Procedure.

It Is Reported That:

Mr Ali has failed to maintain his licensed taxi to the standard required by the Licensing Authority, Highland Council, contrary to Condition 1 of the Taxi Operator's Conditions of Licence, as demonstrated by the result of a vehicle inspection carried out by Highland Council's contractor at the request of an Assistant Trading Standards Officer and is not a fit and proper person to hold a licence.

Background Information

The Penalty Points System was introduced on July 1st 2006. Its purpose is to assist Trading Standards in the evaluation of how well licensed operators are maintaining their vehicles.

Points accumulate when faults are discovered at the Council's inspection of the licensed vehicle or during "on the spot" inspections of the vehicle by Trading Standards staff. An appeal system is in place which allows an operator to question the allocation of points.

When the points total reaches 20 or more during a two year rolling period, the operator becomes the subject of a report to the Licensing Committee.

A Taxi and PHC Penalty Points Tariff which identifies possible faults and the points allocated to those faults, is included with this report.

Summary of Facts and Evidence

This report relates to the licensed vehicle operated by Syed Ali, licence number 11 449. A Council inspection, carried out on Wednesday 7th May 2014, at the request of an officer from Trading Standards after receiving information from a member of the public, led to the identification of 5 MOT failures, 2 of which were deemed "Dangerous", and 4 problems with the appearance of the licensed vehicle.

Antecedents

Mr Ali has only one licensed vehicle, licence number 11 499. The licence was first issued on 23rd August 2005 and a Mercedes Benz E220, registration number WJ51 TXE, was substituted onto the licence on 9th August 2010.

Mr Ali's licence had been allocated 3 penalty points in 2006 and 5 penalty points in 2007. From 2008 until the Council inspection on 7th May 2014 none of Mr Ali's Council inspections had identified any problems. Mr Ali's last routine Council inspection had been on Thursday 30th January 2014.

Mr Imran Raja is a licensed operator driver of Licence Plate Number 11 500. His licensed vehicle is a blue Mercedes E220, registration number KD51 LCK. He is not a qualified mechanic but he does carry out repair work on vehicles for people he knows.

Evidence Relating to Licence Number 11 499

On Sunday 4th May 2014 an email was sent to Trading Standards by a member of the public complaining about the poor standard of licensed vehicles in Inverness. Two vehicles were identified as examples, the quote below identifying Mr Ali's taxi.

WJ51TXE Taxi 11499

Suspension feels unsafe when traveling as a passenger and rust bubbling through paint.

Assistant Trading Standards Officer Hiddleston asked Mr Ali to bring his taxi to the Trading Standards Office and on Wednesday 7th May Mr Hiddleston travelled as a passenger in the vehicle. The taxi was making a noise which appeared to come from underneath at the rear and Mr Hiddleston asked Mr Ali to present his vehicle to the Council's Contractor for inspection. The Taxi Test Report Form dated Wednesday 7th May shows the result of that inspection. Five safety related failures, which were also MOT failures, were identified, with two of the failures labelled as "Dangerous".

Interview of Mr Ali

Sayed Ali was interviewed by Elizabeth Gardner, Trading Standards Officer, in the presence of Assistant Trading Standards Officer Stewart Hiddleston, at the Trading Standards Office, 38 Harbour Road, Inverness on Wednesday 14th May 2014.

Mr Ali was asked what maintenance regime he had in place for his licensed vehicle. He produced 27 invoices, 25 of which related to parts bought since May 2012 and 2 of which showed work being carried out by Inverness garages. All were cash invoices, 7 of them identified Mr Ali as the customer, 3 identified Mr Imran Raja as the customer and 17 had no identification of the customer. Mr Ali explained that he had recently sent documents to his accountant and these were what he had left.

He was aware that there was a noise in his car and at the start of the month he'd gone to the Inverness MOT Centre to get the suspension checked out. He had been told there was nothing wrong.

Mr Imran Raja services the vehicle. Sometimes he uses Mr Neil Hrycenko in Lotland Street, Inverness. Only when neither of them can work on the vehicle does he go to others.

Mr Ali said his history was good and asked to be given another chance. He said he would be happy to take care of the car, going to the Inverness MOT Centre every

month for safety aspects. The result of the inspection had shaken him. When he had gone to the MOT Centre about the rattling noise they couldn't find anything wrong. He said he would sort out this and promised it wouldn't happen again and he always keeps his promises.

This Council inspection of the licensed vehicle had been requested by WITNESS HIDDLESTON from Trading Standards following the receipt of a complaint from a member of the public which alleged that the suspension of the vehicle had felt unsafe when he had been a passenger in the vehicle. ALI was advised that it would be helpful if he could bring with him invoices and receipts which showed what work had been carried out on the vehicle.

The interview took place at the Trading Standards Office, 38 Harbour Road, Inverness on Wednesday 14th May 2014 at 13.55hrs, in the presence of WITNESS HIDDLESTON.

I informed ALI that he had been asked to take part in an interview because the result of the last inspection of his Mercedes had been very poor and the inspection had followed receipt of a complaint from a member of the public. Although he'd had few penalty points before, this one inspection had led to the allocation of 29 penalty points. Five MOT failures had been found during the inspection, two of which were considered dangerous by the examiner. In addition the tread of offside rear tyre had been found to be below the legal limit. This meant that a report to the Licensing Committee was being considered.

I asked what maintenance had been carried out on the Mercedes and ALI produced a ring binder containing 28 invoices.

Production Number 1 to 25 – Invoices for parts

Production Number 26- Invoice dated 17/1/2014 from Neil Hyrcenko, Unit 3, 23 Lotland Street, Inverness, IV1 1ST for a service of the Mercedes.

Production Number 27- Invoice dated 10/1/2014 from Mike Norgate Body Repairs, Carsegate Road South, Inverness, IV3 8LL for body repairs and spray, as required, of the Mercedes.

ALI said he had recently sent documents to his accountant and these were what he had left.

ALI had gone to the Inverness MOT Centre to get the car's suspension checked out because there was a noise in the car but they could find nothing wrong. That was at the start of the month. (May)

ALI went on to say that Imran Raja usually services the vehicle, sometimes he'd go to Neil Hrycenko on Lotland Street and only when neither of them could do the work would be go to others. He had asked Neil to provide him with something in writing about the work he had carried out on the car and he was going to until his wife said no, so ALI had nothing to show that Neil Hrycenko had done any work.

He claimed his history was good and he should be given a chance. He'd be happy to take care of the car, going to Inverness MOT Centre every month for safety aspects. The result of the inspection and the

interview had been a bit of a shake for him. He would sort it all out and he promised it wouldn't happen again and he always keeps his promises.

I advised ALI that the documents he had provided would be evaluated and a decision would be made as to whether he would be reported to the Licensing Committee. I would let him know on Friday afternoon, 16^{th} May. On the Friday afternoon I telephoned ALI to inform him that he would be the subject of a report to the Highland Council's Licensing Committee.

I telephoned Mr Imran Raja and left a message on his answering machine asking him to contact me. At 14.55hrs on Friday 16th May Imran Raja returned my call. I asked him if he regularly maintained Mr Syed Ali's Mercedes. Mr Raja replied that he did occasionally but he had not seen the car recently, not for more than six months.

I asked Mr Raja if he had any qualifications as a mechanic. Mr Raja said he did not, he was experienced but it was his hobby. He had a deep interest in electronics and injectors, things like that. It was a passion but he was not a professional. He had not checked Mr Ali's car in the last six or seven months. He said Mr Ali uses someone else, he wasn't sure who. Neil perhaps. (Neil Hrycenko.)

During my interview of SAYED ALI he had stated that he had no paperwork from Neil Hrycenko and that Mr Hrycenko had refused to put anything in writing for him.

On Tuesday 22nd July I spoke to Mr Adam Colvin De Valle at the Inverness MOT Centre. I asked him if MR SYED ALI had taken his Mercedes E220 to their premises in early May to have the rear suspension checked out. Mr De Valle checked the firm's computer records but could find no record of Mr Ali or his Mercedes at any time. However he did remember someone with a Mercedes coming in to have bushes checked but it had been a while ago, earlier in the year than May. He said that if there had been anything wrong the man would have been advised to have work carried out.

ALI'S last routine Council inspection was on 30th JANUARY 2014. He received a "Pass" result with three observations, one of which was "rear subframe bushes worn" as detailed in

Production Number 31 Taxi Test Report Form dated 30th January 2014

The mileage was recorded on 30th January as 168735 miles. On 7th May 2014 the Taxi Test Report Form from ALI'S inspection recorded the mileage as 178633, an increase of 9898 miles since January and the observation regarding the rear subframe bushes was now recorded in Group A as "rear subframe bushes worn to excess - Dangerous", an MOT failure, as detailed in

It Is Reported That:

Mr Ali has failed to maintain his licensed taxi to the standard required by the Licensing Authority, Highland Council, contrary to Condition 1 of the Taxi Operator's Conditions of Licence, as demonstrated by the result of a vehicle inspection carried out by Highland Council's contractor at the request of an Assistant Trading Standards Officer and is not a fit and proper person to hold a licence.

Background Information

The Penalty Points System was introduced on July 1st 2006. Its purpose is to assist Trading Standards in the evaluation of how well licensed operators are maintaining their vehicles.

Points accumulate when faults are discovered at the Council's inspection of the licensed vehicle or during "on the spot" inspections of the vehicle by Trading Standards staff. An appeal system is in place which allows an operator to question the allocation of points.

When the points total reaches 20 or more during a two year rolling period, the operator becomes the subject of a report to the Licensing Committee.

A Taxi and PHC Penalty Points Tariff which identifies possible faults and the points allocated to those faults, is included with this report.

Summary of Facts and Evidence

This report relates to the licensed vehicle operated by Syed Ali, licence number 11 449. A Council inspection, carried out on Wednesday 7th May 2014, at the request of an officer from Trading Standards after receiving information from a member of the public, led to the identification of 5 MOT failures, 2 of which were deemed "Dangerous", and 4 problems with the appearance of the licensed vehicle.

Antecedents

Mr Ali has only one licensed vehicle, licence number 11 499. The licence was first issued on 23rd August 2005 and a Mercedes Benz E220, registration number WJ51 TXE, was substituted onto the licence on 9th August 2010.

Mr Ali's licence had been allocated 3 penalty points in 2006 and 5 penalty points in 2007. From 2008 until the Council inspection on 7th May 2014 none of Mr Ali's Council inspections had identified any problems. Mr Ali's last routine Council inspection had been on Thursday 30th January 2014.

Mr Imran Raja is a licensed operator driver of Licence Plate Number 11 500. His licensed vehicle is a blue Mercedes E220, registration number KD51 LCK. He is not a qualified mechanic but he does carry out repair work on vehicles for people he knows.

Evidence Relating to Licence Number 11 499

On Sunday 4th May 2014 an email was sent to Trading Standards by a member of the public complaining about the poor standard of licensed vehicles in Inverness. Two vehicles were identified as examples, the quote below identifying Mr Ali's taxi.

WJ51TXE Taxi 11499 Suspension feels unsafe when traveling as a passenger and rust bubbling through paint.

Assistant Trading Standards Officer Hiddleston asked Mr Ali to bring his taxi to the Trading Standards Office and on Wednesday 7th May Mr Hiddleston travelled as a passenger in the vehicle. The taxi was making a noise which appeared to come from underneath at the rear and Mr Hiddleston asked Mr Ali to present his vehicle to the Council's Contractor for inspection. The Taxi Test Report Form dated Wednesday 7th May shows the result of that inspection. Five safety related failures, which were also MOT failures, were identified, with two of the failures labelled as "Dangerous".

Interview of Mr Ali

Sayed Ali was interviewed by Elizabeth Gardner, Trading Standards Officer, in the presence of Assistant Trading Standards Officer Stewart Hiddleston, at the Trading Standards Office, 38 Harbour Road, Inverness on Wednesday 14th May 2014.

Mr Ali was asked what maintenance regime he had in place for his licensed vehicle. He produced 27 invoices, 25 of which related to parts bought since May 2012 and 2 of which showed work being carried out by Inverness garages. All were cash invoices, 7 of them identified Mr Ali as the customer, 3 identified Mr Imran Raja as the customer and 17 had no identification of the customer. Mr Ali explained that he had recently sent documents to his accountant and these were what he had left.

He was aware that there was a noise in his car and at the start of the month he'd gone to the Inverness MOT Centre to get the suspension checked out. He had been told there was nothing wrong.

Mr Imran Raja services the vehicle. Sometimes he uses Mr Neil Hrycenko in Lotland Street, Inverness. Only when neither of them can work on the vehicle does he go to others.

Mr Ali said his history was good and asked to be given another chance. He said he would be happy to take care of the car, going to the Inverness MOT Centre every month for safety aspects. The result of the inspection had shaken him. When he had gone to the MOT Centre about the rattling noise they couldn't find anything wrong. He said he would sort out this and promised it wouldn't happen again and he always keeps his promises.
