# Licensed Taxi Operator – Robert Tait (Ward 22 – Fort William & Ardnamurchan)

## Report by the Legal Manager

#### Summary

This Report relates to a licensed taxi operator who has been reported for a breach of licence conditions.

### This application is subject to a formal hearings procedure.

#### 1.0 Background

- **1.1** The Highland Council has resolved that in terms of the Civic Government (Scotland) Act 1982 a licence will be required for the operating of a licensed taxi. A licence for the same issued by the Highland Council is valid for the whole Council Area.
- **1.2** Mr Robert Tait is both a licensed taxi operator and licensed taxi driver with the Highland Council and currently holds the following licences:-

Taxi Driver's Licence:Expires – 19 July 2017Taxi Operator's Licence:Taxi Plate 23025 – Expires – 7 March 2015

### 2.0 Highland Council Penalty Points System for Taxi and Private Hire Operators

- 2.1 Highland Council (Trading Standards) introduced a Penalty Points System on 1 July 2006 to assist in the assessment of the level of compliance shown by each Operator in relation to Conditions 1 and 2 of a Taxi Operator's Licence. When the points on an Operator's Licence reach 20 or more during a two year rolling period, the Operator becomes the subject of a report to the Licensing Committee.
- 2.2 On 16 September 2014 a report in relation to Mr Tait was received from the Council's Trading Standards Service who are responsible for the enforcement of the licensing scheme for taxi/private hire cars and their drivers. A copy of the report received from Trading Standards is attached. (Members are asked to note that some of the productions referred to in the Trading Standards Report have not been circulated but will be made available at the meeting).

This report has been submitted due to Mr Tait accruing a total of 35 points on Taxi Operator Licence No. 23025 and for failing to maintain his licensed taxi to the standards required by the Licensing Authority.

#### 3.0 Process

**3.1** A copy of the report and all attachments have been sent to both parties who, in terms of Paragraph 4(2) of the Civic Government (Scotland) Act 1982, have been invited to attend and will be provided with an opportunity to be heard by the Committee. A copy of the procedure which will be followed at the meeting has also been sent to both parties.

## 4.0 Consideration of action to be taken

- **4.1** In terms of Section 11 of Schedule 1 of the Civic Government (Scotland) Act 1982 a Licensing Authority may suspend a licence(s) on the following grounds:
  - (a) if in their opinion the holder of the licence is no longer a fit and proper person to hold the licence(s);
  - (b) the carrying on of the activity to which the licence relates has caused, is causing or is likely to cause undue public nuisance or a threat to public order or public safety; or
  - (c) a condition of the licence has been contravened.
- **4.2** If Members are not of a mind to suspend the licence, the Committee could require the operator to present his vehicle for inspection on a more frequent period than the current 6 or 12 months inspection regime eg. every 3 months. This would allow Trading Standards an opportunity to undertake more regular monitoring of the vehicle.

### 5.0 Policies and Conditions

**5.1** The Standard Taxi Operator's licence conditions are relevant to this case and can be accessed via the following link:

In terms of Condition 1 of the Taxi Operator's licence conditions, "the holder of a Taxi Operator's licence shall ensure that the taxi, including all body work, upholstery and fittings, is maintained in a safe and serviceable condition and, subject to prevailing road conditions, is maintained in a clean condition and of smart appearance".

### 6.0. Recommendation

The Committee is invited to consider whether any action should be taken against the licence holder as outlined at paras 4.1 and 4.2 above.

Should the Committee be of a mind to suspend the licence(s), the Committee must specify a reason for the suspension in terms of paragraph 4.1 above.

#### It Is Reported That:

Mr Tait has failed to maintain his licensed taxi to the standard required by the Licensing Authority, Highland Council, contrary to Condition 1 of the Taxi Operator's Conditions of Licence, as demonstrated by the results of two vehicle inspections carried out by Highland Council's contractor and is therefore not a fit and proper person to hold a licence.

#### **Background Information**

The Penalty Points System was introduced on July 1<sup>st</sup> 2006. Its purpose is to assist Trading Standards in the evaluation of how well licensed operators are maintaining their vehicles.

Points accumulate when faults are discovered at the Council's inspection of the licensed vehicle or during "on the spot" inspections of the vehicle by Trading Standards staff. An appeal system is in place which allows an operator to question the allocation of points.

When the points total reaches 20 or more during a two year rolling period, the operator becomes the subject of a report to the Licensing Committee.

A Taxi and PHC Penalty Points Tariff which identifies possible faults and the points allocated to those faults, is included with this report. (**Production Number 1** Penalty Points Tariff).

#### Summary of Facts and Evidence

This report relates to the licensed vehicle operated by Robert Tait, licence number 23 25 which was first issued on 8<sup>th</sup> August 2012. A black Vauxhall Vectra, registration number SD07 VFJ, is the only vehicle which has been on the licence. \*Redacted\* This matter is reported because more than 20 Penalty Points have been accumulated within a two year rolling period.

I have been employed as a Trading Standards Officer enforcing the Civic Government (Scotland) Act 1982 as it applies to licensed taxis and PHCs and the Conditions of Licence for licensed operators and drivers for 17 years.

I spoke to ROBERT TAIT on the telephone on Thursday 7<sup>th</sup> July to advise him that the results of the last two Council inspections of his taxi had led to the accumulation of 35 points against his operator's licence and that a report to the Licensing Committee was a possibility. I invited him to interview so that

he would be able to demonstrate how his licensed vehicle was maintained and asked him to take with him any invoices he had which showed work being carried out on the vehicle or parts being bought.

I interviewed ROBERT TAIT at 11.00am on Tuesday 12<sup>th</sup> August 2014, in the presence of WITNESS HIDDLESTON, in Fulton House, Cameron Square, Fort William. I told TAIT that the accumulated points were as a result of a Council inspection on 30<sup>th</sup> January 2014 when three MOT failures had been identified and the result was a dangerous "Fail"

and another Council inspection on 30th July 2014

(Production Number 5, Taxi Test report Form dated 30<sup>th</sup> July 2014)

when the three MOT failures listed were

(1) both front springs broken,

(2) both front anti roll bar links worn to excess

(3) the nearside rear outer brake pad thin.

These resulted in another dangerous "Fail". In addition two faults were identified in the Group B

"Appearance and Utility" section.

TAIT'S response to the January Fail was that he had put his vehicle in for a pre-test to his mechanic who was an ex-AA man and he'd thought there was nothing wrong with the car. TAIT said he uses John Stewart in Inverlochy and when he'd checked the identified MOT failures after the Council inspection

he'd thought they were all reasonable. And picking up on the headlight was just picky, the bulb had been put in upside down.

For the July test TAIT admitted the car should have been off the road. He shouldn't have put it in for the test. All the parts were on order but his mechanic couldn't fit him in. So TAIT did what he always does with his car, puts it in for an MOT, gets a fail and gets it fixed. He sources the parts himself and John (Stewart) just charges labour. TAIT said "That was me not thinking, the July one."

TAIT was unable to produce any invoices relating to work carried out on the car, he said it had never occurred to him that he might need to. He claimed that there were a lot of times when the car was in and out of the garage every month. He used Slipway Autos up till Christmas but he put his prices up and was too expensive so TAIT uses Heathercroft as well now.

TAIT acknowledged that he got at least four weeks' notice of a Council inspection and said that from now on the taxi will go for a pre-MOT at least three weeks before a test to get parts ordered. Every 5000 miles the taxi will be going into a garage to get checked. TAIT then produced two different check sheets he said he was intending to use from now on.

He also produced a list of work which had been carried out on his car up to April 2014 which he had created to show what had been done to the car

(Production Number 8, Schedule of Repairs, 2013-14).
