Disabled Persons' Parking Places (Scotland) Act 2009 – Annual Report 2013/14

Report by Director of Community Services

Summary

This report invites Members to note the Council's Annual Report in accordance with the Disabled Persons' Parking Places (Scotland) Act 2009.

1. Background

- 1.1 The Disabled Persons' Parking Places (Scotland) Act 2009 was introduced through a private Members Bill.
- 1.2 The main policy objective of the Bill was to prevent parking spaces designated for disabled persons' being occupied by those who are not entitled to use them and thus ensuring that enforcement action under the Act can be taken in the case of any contravention.
- 1.3 At the TEC Services Committee on 24 September 2009 it was agreed that the Council will commence to implement its duties under the Act within existing resources.
- 1.4 The Act requires that each Local Authority prepares an annual report on its performance in relation to the Act and that this report is published. The Annual Report on the Council's performance under the Act as submitted to the Scottish Government is contained in **Appendix A.**

2. Implementation of the Act

- 2.1 The preparation of the Traffic Regulation Orders (TRO) is being carried out on a priority basis as set out below:
 - 1. On-street:
 - 2. Off-street for Council controlled Car Parks: and
 - 3. Private car parks with the permission of the owner / tenant.
- 2.2 On-street TROs for Caithness, Inverness, Lochaber, Ross-shire, and Skye and Lochalsh are operational. The bays included in these TROs have both the required road markings and signs in place.
- 2.3 In Sutherland and Easter Ross the consultation process for the On-street TRO was successfully completed and the TRO will be made when the site works are complete. (Subsequent to the report being submitted the site works have been completed and the TRO is now operational.)
- 2.4 In Nairn, Badenoch and Strathspey the draft on-street TRO has been completed and statutory consultees have been consulted. (Subsequent to the

report being submitted the public consultation process has been completed and the TRO will be made when the site works are complete.)

- 2.5 In Lochaber an amended on-street TRO was put in place in 2013 which includes new bays that have been installed since the original Lochaber TRO was made operational in 2012.
- 2.6 The work to identify disabled bays in all off-street car parks is on-going and will be progressed in due course.
- 2.7 A small number of private business owners have indicated that they would like the disabled bays in their private car parks to be included in a TRO. A draft TRO has not yet been completed for disabled bays in private car parks.
- 2.8 All of the on-street TROs that have been put in place are recorded in the Council's WDM asset management system to aid future management and maintenance.

3. Implications

- 3.1 No additional resources have been provided to carry out this work and full implementation is dependent on funding being found from existing budget allocations.
- 3.2 The disabled parking bays are supported by Traffic Regulation Orders.
- 3.3 This work will support disabled drivers.
- 3.4 There are no climate change/carbon clever implications arising from this report.
- 3.5 There are no risk implications arising from this report.
- 3.6 There are no Gaelic or rural implications arising from this report.
