Dornoch Common Good Quarterly Monitoring Report 1 April 2014 to 31 December 2014

Report by the Head of Policy and Performance

Summary

This report provides Members with information on the status of the Dornoch Common Good Fund at 31 December 2014.

1. Background

1.1 Attached to this report is a monitoring report showing income and expenditure on Dornoch Common Good Fund for Quarters 1, 2 and 3 of the current Financial Year.

2. Income

2.1 The income for the year is slightly more than anticipated with an estimated variance of £550.

3. Expenditure

3.1 Spend on property costs is within budget. However Members will see that a £13,000 overspend is anticipated in relation to Grants and Contributions. This is as a result of the £15,000 grant awarded to Dornoch Area Community Interest Company for the Discover Dornoch project as agreed by Caithness and Sutherland Area Committee on 9 December 2014. Members will recall that this project was considered to be sufficiently significant to justify drawing on reserves as it both promotes Dornoch (not least on behalf of 71 subscribing businesses) to potential visitors and secured significant match funding

4. Implications

4.1 Overall members will see from the monitoring statement that a deficit of £12,450 is anticipated at the end of the year. As noted above this is due to the significant grant award made to Discover Dornoch. There are sufficient reserves to cover the overspend. Clearly regular annual deficits would be a matter of concern and would result in an unacceptable depletion of the usable reserves which stood at £218,538 at the end of March 2014. However in this case the overspend is a result of a one off grant in a case where the benefits of the grant and leverage it provided were regarded as sufficient to justify the award. It will not create ongoing reductions.

- 4.2 Members are referred to Note 1 on the Appendix which lists the projects funded in the current Financial Year.
- 4.3 There are no Equalities, Climate Change/Carbon Clever, Legal, Financial, Gaelic or Rural Implications.
