- iii. an explanatory note of the calculations involved in determining the financial

implications of applications for early retirement/voluntary severance.

Members expressed concern that one of the applicant's notice of retirement had already been released to the media. There was a feeling that there was an assumption that the decision had already been taken for them which they were uncomfortable with. In order that this situation did not happen again, Members requested that a report on the review of the process for submitting Early Retirement/Voluntary Severance applications agreed at the last meeting, be brought to the next meeting of the Sub-Committee.

Members were advised of the process for dealing with cases of redundancy of employees and support provided. In this respect, Members requested that employees in such a situation should be advised in writing that they should seek independent financial advice in terms of the financial package that was being offered to them.

Thereafter, the Sub-Committee AGREED:-

- i that a report on the review of the process for submitting Early Retirement/Voluntary Severance applications agreed at the last meeting, be brought to the next meeting of the Sub-Committee;
- that employees in a redundancy situation would be advised in writing that they should seek independent financial advice in terms of the financial package that was being offered; and
- that the undernoted applications be granted Early Retirement on the following grounds: release of benefits on compassionate grounds and Criteria 1 on the grounds of redundancy; 2(i) as an alternative to redundancy of an individual; 2(ii) to avoid redundancy of another employee; 2(iii) to assist in service restructuring.
