In Inverness the ASDA site at Slackbuie was the only device publically available 24/7. Deborah Jones suggested a needs assessment, considering morbidity/mortality rates would be useful in developing a strategic approach across the City. Deborah agreed to refer details of a Raigmore-based Cardiologist to assist; Margaret Kinsella offered to assist in identifying HC support, as did Naomi Hyslop from HLH.
