Supplementary Policy Statement on Extended Hours

Report by the Clerk to the Licensing Board

Summary

This Report invites the Board to consider the responses received to the consultation on the introduction of a supplementary policy statement on extended hours for special events of local or national significance and to decide whether to introduce such a statement.

1. Background

- 1.1 Under section 68 of the Licensing (Scotland) Act 2005 the Board has discretion, on the application of a premises licence holder, to extend the licensed hours of the premises by such period as is specified in the application or by such other period as the Board consider appropriate.
- 1.2 Before granting extended hours in respect of any premises, the Board must first be satisfied that it is appropriate to do so in connection with either:
 - (i) a special event or occasion to be catered for on the premises, or
 - (ii) a special event of local or national significance.
- 1.3 Where the Board is so satisfied, it is open to the Board to permit extended hours outwith the normal permitted operating hours of the premises and, indeed, outwith the premises licence core hours set out in the Board's Policy Statement or beyond the normal guideline that the maximum continuous period during which alcohol should be sold should not exceed 14 hours. The decision in each case depends on whether the Board considers that the hours sought are justified by the nature of the special event or occasion and would not conflict with any of the licensing objectives.
- 1.4 The Board's Policy Statement currently identifies the annual festive period as a special event of local or national significance during which the Board will generally grant applications to extend the terminal hour to 0400 at late opening premises and to 0200 hours at other on-sales premises.
- 1.5 A public consultation has now taken place on whether the Board should specify, in a supplementary policy statement, other special events of local or national significance for which similar extended hours will generally be granted.

1.6 The consultation responses received are appended to this Report.

APPENDIX 1 contains the response from the Highland Licensing Forum. This is not a single response from the Forum as a body but, instead, a collection of the responses received by the Clerk to the Forum from some of the individual Forum members and representatives to the Forum. These responses came from two licensed trade representatives, one resident member, the Police Scotland representative, the Public Health representative, the Highland Alcohol and Drug Partnership (HADP) representative and the Care and Learning representative (formerly known as the Education and Social Care representative).

APPENDIX 2 contains the collated responses submitted using the Consultation Questionnaire provided. These responses came from the three Highland Licensing Standards Officers, eleven Community Councils, one licensee and one private individual.

APPENDIX 3 contains other responses which were submitted by letter or email. These came from TLT Solicitors on behalf of Punch Partnership Limited (premises licence holder for eleven licensed premises in Highland), Greene King Brewing and Retailing Limited (premises licence holder for six licensed premises in Highland) and Ramsay McGhee on behalf of the Inverness, Highland and Islands Licensed Trade Association.

- 1.7 Although also consulted separately as statutory consultees, Police Scotland and NHS (Highland) did not submit their responses directly. The responses by their representatives to the Forum, however, represent the official position of each of these statutory consultees.
- 1.8 It should be noted that the Board agreed at its meeting on 6 January 2015 that extended hours for special events or occasions to be catered for on the premises (under section 68(1)(b)(i) of the Act) should not be included in the consultation exercise. It was not considered that a policy statement on extended hours for such premises-specific events might be of benefit. The consultation accordingly related only to whether to introduce a policy statement on extended hours for special events of local or national significance under section 68(1)(b)(ii) of the Act.

2. Consultation responses

2.1 The consultation has produced a fairly mixed reaction. Responses to the specific questions asked are summarised below

- 2.2 Question 1: Do you consider that the Highland Licensing Board should introduce a supplementary policy statement identifying the special events of local or national significance, in addition to the festive period, for which applications for extended terminal hours will generally be considered favourably?
- 2.2.1 The majority of responses from Community Councils, the Licensing Standards Officers and the licensed trade were in favour of the principle of introducing a supplementary policy statement of this nature to assist licence holders in forward planning for events. Others considered that the convenience of licence holders was not a sound basis for this type of policy.
- 2.2.2 The statutory consultees, Police Scotland and NHS (Highland), and the Licensing Forum representatives from the HADP and the Council's Care and Learning Service were particularly opposed to the proposal. They are strongly of the view that extended hours should continue to be applied for, and applications considered, individually on a case by case basis. In particular, Police Scotland consider it important that they have sight of each extended hours request received to ensure that appropriate enquiry can be carried out and appropriate planning can be put in place so as not to impact adversely on the public.
- 2.2.3 In considering the principle of introducing a supplementary policy statement on extended hours, the difficulty facing the Board is therefore the issue of how to give licence holders a greater degree of certainty as to the special events for which extended hours are likely to be granted, while at the same time retaining the opportunity for scrutiny of individual cases by the Police and, indeed, the Board itself.
- **2.2.4** Possible ways of achieving both ends are considered more fully at section 2.7 below.
- 2.3 Question 2: If your answer to Question 1. is yes, do you consider that the following are special events of local or national significance which should be included?
- **2.3.1** The events listed for the purposes of the consultation were
 - Easter weekend (Friday and Saturday nights).
 - Halloween (31 October and the Friday and Saturday nights immediately before and after 31 October)
 - the 6 Day Trials and Downhill Bike Championship in Fort William
 - the National Mod
 - Burns Night (25 January and the Friday and Saturday nights immediately before and after 25 January)
 - St Andrews Night, (30 November and the Friday and Saturday nights immediately before and after 30 November), and
 - · Major sporting events in Highland.

- **2.3.2** Most of the respondents who were opposed to the principle of introducing a supplementary policy expressed no view on the individual events listed.
- 2.3.3 Notable exceptions, however, were NHS Highland (through the Public Health representative to the Forum), the HADP and the Council's Care and Learning representative to the Forum. They each commented that sporting events (such as the 6 Day Trials, the Downhill Bike Championship and other major sporting events) should not be included in any supplementary policy statement. They considered that any association between alcohol consumption and sport should be minimised, in keeping with national policies restricting alcohol at sporting events.
- 2.3.4 Those who supported the principle of having a supplementary policy expressed diverse views on the events listed. These are too diverse to summarise and can be read in full in Appendices 1, 2 and 3.
- 2.3.5 If minded in principle to introduce a supplementary policy, the Board will require to agree which of the events listed should be identified in the policy as special events of local or national significance.
- 2.3.6 In relation to each special event which the Board may decide to include in any supplementary policy statement, the Board will also have to agree the dates around these events on which extended hours are likely to be granted. These will require to be specified in the supplementary policy statement for the sake of clarity.
- 2.4 Question 3. What, if any, other special events of local and national significance do you consider should be included and why?
- **2.4.1** Additional events suggested by respondents and which the Board may wish to consider including are as follows:
 - Local Highland Games
 - Loopallu, Ullapool
 - Ullapool Skiff Regatta
- 2.4.2 The Licensing Standards Officers also suggested including world-wide televised sporting events such as the Olympic Games, rugby and football World Cups and American Superbowl. Where, however, such televised events are being screened live within a licensed premises and are outwith normal operating hours, this would be classed as a "special event or occasion to be catered for on the premises", and extended hours may be sought on that basis.

- 2.4.3 The timing of such live screenings will vary considerably and it would accordingly not be possible to specify in advance, by means of a supplementary policy statement, appropriate hours for such events. It is recommended therefore that applications for extended hours for such live screenings on individual premises continue to be dealt with on a case by case basis, with applications under section 68 of the Act being required in each case.
- 2.5 Question 4: Do you agree that the following extended terminal hours should generally be granted for any special events to be included in a supplementary policy?

Late opening premises – 0400 hours Other on-sales premises – 0200 hours

- 2.5.1 Two of the Community Councils who responded to the consultation supported the principle of introducing a supplementary policy but then opposed the hours proposed. They offered no alternative proposal as to the hours they would instead support. Another opposed the principle of introducing the policy but supported the extended hours proposed. It is difficult to draw any conclusion, therefore, from these particular responses.
- 2.5.2 In general, however, those who opposed the principle of introducing the policy also opposed the hours proposed, while those who supported the principle also supported the proposed hours.
- 2.5.3 As the Board will be aware, the hours proposed are the same as those currently generally permitted under the Board's festive period policy. If the Board is minded to introduce a similar policy in respect of other special events of local or national significance, it would seem reasonable to identify in the policy the same extended hours as for the festive period.
- 2.6 Question 5: For special events of only local significance, should extended terminal hours in terms of any supplementary policy statement be restricted to premises which the Board considers lie within the locality of the event?
- **2.6.1** All respondents to this question agreed that if extended hours for special events of local significance are to be granted, they should apply only to premises which lie within the locality of the event.
- 2.6.2 The Licensing Standards Officers suggest in their response that the "locality" should be identified as the relevant town or village in which the event takes place and, in the case of events in Inverness, only those parts of the city which traditionally support the late night economy. They recognise, however, that for certain large events such as the National Mod the "locality" may require to include surrounding towns or villages.

- 2.6.3 A statement to this effect can be included in the policy statement should the Board decide to introduce one, with the caveat that the Board reserves the right to refuse extended hours for any special event of local significance if, in the opinion of the Board, the premises is outwith the locality of the event.
- 2.7 Question 6: Should licence holders be permitted to avoid having to lodge individual applications for extended hours for the special events specified in any supplementary policy statement by varying their operating plan to include a statement that they will open, during those events, for such extended hours as the Board has agreed in its supplementary policy?
- 2.7.1 Many respondents considered that this practice should be allowed in the interest of reducing the work/cost involved for both licence holders in lodging, and the Board in processing, individual extended hours applications. The fee for an extended hours application is fixed by Scottish Government regulations at only £10. There is, however, a fair amount of paperwork involved in processing each application, albeit much of this is now dealt with electronically.
- 2.7.2 This practice of avoiding the need for section 68 applications by including an appropriate statement in operating plans is currently permitted by the Board in respect of the festive period. Various premises in Highland include, under the "Seasonal Variations" section of their operating plan, a statement to the effect that they intend to open for such extended hours as have been agreed for the festive period in terms of the Board's Statement of Licensing Policy. The Board does not require individual extended hours applications from those premises for extended opening hours during the festive period, provided the extended hours are as stated in the Board's Statement of Licensing Policy.
- 2.7.3 Some of these premises licences have a condition attached to them requiring the licence holder to notify Police Scotland and the Board, prior to 1 December each year, of the dates within the festive period on which it is intended that the premises will open until the festive period terminal hour. Some older premises licences do not, however, have this condition, having been granted before the practice of imposing the notification condition was adopted. The notification condition can only be added to these older licences if or when the licence holder applies for a variation of the licence.
- 2.7.4 Consequently, it is already the case in respect of premises with festive period "Seasonal Variation" statements that the Police (and indeed the Licensing Standards Officers) sometimes have difficulty finding out which premises have, or should have, submitted the appropriate notification when taking advantage of festive period extended hours.

- 2.7.5 As mentioned at section 2.2 above, Police Scotland have serious concerns about extending this "Seasonal Variation" statement practice to other special events of local or national significance throughout the year. They have particular concern that this will create resourcing issues for them, making it difficult for them to ensure appropriate event planning is in place and reducing their ability to keep people safe.
- 2.7.6 The Police would be consulted at the stage at which a premises licence holder applies to vary their operating plan to include a "Seasonal Variation" statement in respect of any special events of local or national significance identified in a supplementary policy statement. This would be classed as a major variation and the Police would therefore have opportunity to object to that variation being granted. If the variation is granted, however, the Police would thereafter have no opportunity to object to extended opening at the premises for any event covered by the "Seasonal Variation" statement.
- 2.7.7 There is a further issue in that some existing "Seasonal Variation" statements are sufficiently loosely worded as to give rise to the argument that they will cover any extended hours available in terms of the Board's Statement of Licensing Policy. A typical example is the statement that the premises "intend to take advantage of any additional hours which may be available in terms of the Board's statement of licensing policy, including the festive season". This would arguably allow extended hours opening for any special event which the Board has identified in policy as one for which extended hours will generally be allowed.
- 2.7.8 In light of the above issues, if the Board is minded in principle to introduce a supplementary policy statement on special events of local or national significance, the Board is invited to consider the following options as possible ways of accommodating (a) the licensed trade's desire for greater certainty as to special events in respect of which extended hours are likely to be granted, (b) the concerns of Police Scotland and (c) the need for the Board itself to retain a degree of control over extended hours opening for special events.

2.7.9 Option 1

Allow extended hours opening for any of the special events of local or national significance which the Board identifies in its supplementary policy statement but only where an application under section 68 has first been lodged with and granted by the Board.

2.7.10 Option 2

Allow extended hours opening for any of the special events of local or national significance which the Board identifies in its supplementary policy statement only where an application under section 68 has first been lodged with and granted by the Board **unless** the premises licence has been varied (by major variation application) to include a statement, under the "Seasonal Variations" section of the operating plan, that the premises "will open for the extended hours identified in the supplementary policy statement for the following special events of local or national significance:".

It should be a requirement that the specific events for which the premises intend to open for extended hours be listed individually in the major variation application and these would then be listed in the operating plan if the application is granted. This will ensure clarity as to the events for which the premises may open for extended hours.

It should also be stipulated in the supplementary policy statement that any existing statement as to extended hours opening included in the "Seasonal Variations" section of an operating plan will not be deemed to apply to the special events of local or national significance identified in the supplementary policy statement. Again, this is to ensure clarity as to the events for which the premises may open for extended hours.

It should further be stipulated that the grant of any such major variation application will be subject to a condition requiring the licence holder to submit to the Board and Police Scotland, at least 28 days before the date of each special event, notice of their intention to open for extended hours on the date of the event.

- 2.7.11 Option 1 is clearly the option which statutory consultees, Police Scotland and NHS (Highland) would prefer in the event that the Board chooses to introduce a supplementary policy statement on this issue. It would also ensure that the Board retains the power to refuse extended hours for a special event of local or national significance at any premises, without having to undertake a full premises licence review process. Furthermore, it would ensure absolute clarity at all times as to which premises are entitled to stay open for extended hours during any particular special event.
- 2.7.13 Option 2 would not entirely meet the concerns of the statutory consultees. Moreover, it would lead to the situation whereby, where a premises licence has been varied to include a "Seasonal Variation" statement allowing avoidance of the requirement to lodge an extended hours application for particular special events, the Board could only prevent extended hours opening at that premises for any of those events by undertaking a premises licence review. Compliance with the advance notification condition would be as difficult to monitor as it currently is for festive period extended hours.

- 2.7.14 In theory, however, this second option would nonetheless provide at least some measure of advance warning to Police Scotland and the Board as to which premises were to be opening for extended hours for particular special events.
- 2.7.15 Should the Board be minded to favour **Option 2**, it should be noted that the representations made on behalf of some premises licence holders (see Appendix 3) include a proposal that the Board consider a special discounted fee (£150) for lodging an application for a major variation to add a "Seasonal Variation" statement which would allow extended hours opening for the special events (additional to the festive period) included in the supplementary policy statement. The normal fee for a major variation application is £72 for clubs, visitor attractions and premises with nil rateable value and between £288 and £721 for other premises depending on their rateable value.
- 2.7.16 However, while fees for major variation applications are fixed at the discretion of the Board, the legislation also requires that the fees charged by the Board meet the cost of administering the liquor licensing regime in the Board's area. The fees for major variation applications have been fixed by the Board on this basis. As the true cost of processing each major variation application is more or less the same irrespective of the nature of the major variation sought, introduction of a discounted rate for a particular type of major variation would accordingly lead to a deficit in income and a failure to meet costs. It is therefore not recommended that the Board accept the discounted fee proposal made by some of the licensed trade.

3.0 Recommendation

3.1 The Board is invited:

- (i) to consider the consultation responses attached at Appendices 1, 2 and 3 to this Report and to decide whether to introduce a supplementary policy statement on extended hours for special events of local or national significance, and
- (ii) if the Board is minded to introduce such a supplementary policy statement, to agree the principal terms of the statement and the special events (and dates) to be identified in it and to require the Clerk to the Board to submit a draft supplementary policy statement incorporating those terms to the next meeting of the Board for final approval.

1. Do you consider that the Highland Licensing Board should introduce a supplementary policy statement identifying the special events of local or national significance, in addition to the festive period, for which applications for extended terminal hours will generally be considered favourably?

Yes: Two Licensed Trade representatives said Yes. No: The majority of Forum members who responded (the Police Scotland representative, the Public Health representative, the HADP representative and the Care and Learning representative) said No, stating that applications for extended hours should be considered on a case by case basis (see reasons in bold below).

The Public Health representative and the Care and Learning representative emphasised that in the event that the Board decided to introduce any such supplementary policy the policy should not extend to sporting events, nor to events which are organised predominately for children and young people in an educational setting.

objection: No resident member stated that she would have no objection to introduction of policy provided that the location premises to which the policy might apply is considered on a case by case basis. The resident expressed concern for guests and residents of properties in the vicinity of late night venues. The resident member did not complete any other questions on the questionnaire.

Reasons: The Licensed Trade representatives did not provide reasons for the answer.

The Police Scotland representative, the Public Health representative, the HADP representative and the Care and Learning representative explain that extended hours should be applied for and applications considered on a case by case

basis.

Police Scotland explains that it requires to deploy resources appropriately with the overriding principle of Keeping People Safe; if extended hours are to be issued on a regular basis this could have a detrimental effect on those resources and reduce the ability of Police Scotland to keep people safe. Furthermore, it is important for Police Scotland to have sight of each request received for extended hours to ensure that appropriate enquiry can be carried out, each request can then be assessed individually and appropriate event planning can be put in place so as not to impact adversely on the public.

The HADP representative explains the rationale behind the HADP position as follows: to introduce a supplementary policy statement identifying additional events for which applications for extended terminal hours will generally be considered favourably is likely to increase the availability of alcohol and therefore risk increasing levels of harm. It would also serve to further normalise the consumption of alcohol by encouraging opportunities for increased consumption at special events of local and national significance. HADP agrees with the submissions put forward by the partners in Police Scotland and Public Health. It is the HADP view that it would be best practice to consider applications on a case by case basis as this would be the most effective approach to protecting public health and keeping people safe.

The Public Health representative explains that any association between alcohol consumption and sport should be minimised in keeping with national policies restricting alcohol at sporting events¹. Furthermore, events organised within an educational establishment where the target audience is young people under the age of 18 should not be included in this supplementary policy statement. From a population based approach it is important to give out sensible drinking messages to adults and young people because of the long term harms arising from alcohol misuse. Protecting young people is one of the objectives within the Alcohol etc (Scotland) Act 2010 and is in keeping with national policies of restricting alcohol availability. Although the numbers of applications in these circumstances are likely to be small, it is the totality of measures that make a difference, relating to overall availability and promotion. The Care and Learning representative agrees with the Public Health representative's comments.

2. If your answer to Question 1. is yes, do you consider that the following are special events of local or national significance which should be included?

The majority of Forum members did not answer Question 2 as their answer to Question 1 was No.

One Licensed trade representative answered this question but did not provide reasons to support the answers. The other trade representative expressed support for all the proposals in the questionnaire but did not answer the different sections of this question and did not provide reasons for the position.

Reasons: The Public Health representative and the Care and Learning representative emphasised that sporting events, of local or national significance should not be included in this supplementary policy statement. Any association between alcohol consumption and sport should be minimised and is in keeping with national policies of restricting alcohol at sporting events¹.

The Licensed Trade representative did not provide reasons.

3. What, if any, other special events of local and national significance do you consider should be included and why? (You can add more comments on this at Box 7 below if you run out of space here)

One Licensed Trade representative suggested the Isle of Skye Highland Games and Music Festivals. The other Licensed Trade representative made no suggestions.

The Police Scotland representative states again that extensions should be applied for on a case by case basis and refers to the points he made and the reasons given in response to question 1 of this questionnaire.

The Public Health representative, the Police Scotland representative, the HADP representative and the Care and Learning representative emphasised the importance of considering events on a case by case basis, and referred to the reasons given in response to question 1. The Public Health representative stated that events organised within an educational establishment where the target audience includes young people under the age of 18 should not be included in this supplementary policy statement. From a population based approach it is important to give out sensible drinking messages to adults and young people because of the long term harms arising from alcohol misuse. Protecting young people is one of the objectives within the Alcohol etc (Scotland) Act 2010 and is in keeping with national policies of restricting alcohol availability.

5. For special events of only local significance, should extended terminal hours in terms of any supplementary policy statement be restricted to premises which the Board considers lie within the locality of the event?

Yes: All respondents said Yes. No:

Reasons: The Police Scotland representative said that as detailed above, he believes extended hours should be applied for on a case by case basis. However, should the decision be made that extended hours be granted then they should apply to premises which lie within the locality of the event. Otherwise the process may become unmanageable if licensed premises out

with are given carte blanche to apply whenever an event is taking place in the Highland area. Furthermore, should this be allowed to happen then licensed premises throughout Scotland could well have an argument to say they should also be given an extension.

The Public Health representative, the Care and Learning representative and the HADP representative referred to their answer to question 1.

The Licensed Trade representative did not provide reasons.

6. Should licence holders be permitted to avoid having to lodge individual applications for extended hours for the special events specified in any supplementary policy statement by varying their operating plan to include a statement that they will open, during those events, for such extended hours as the Board has agreed in its supplementary policy?

Other respondents refer to their answer to question 1. The Police Scotland representative states again that he believes extended hours should be applied for on a case by case basis.

The Police Scotland representative said that he is unable to see how extending terminal hours for numerous events without Police enquiry, and without notification to Police so resourcing can be reviewed and bolstered if required, fits in with the five objectives which must always be linked to the sale of alcohol as per Section 4 of the Licensing (Scotland) Act 2005:-

- 1. Preventing Crime and Disorder
- 2. Securing Public Safety
- 3. Preventing Public Nuisance
- 4. Protecting and Improving Public Health

Protecting Children from Harm

The Public Health representative, the HADP representative and the Care and Learning representative said that applications for extended hours should be considered on a case by case basis. They agreed that associations between alcohol consumption and sport should be discouraged and this is in line with current national policy. A population approach to reducing alcohol harm is through restricting alcohol advertising at sporting events. The Licensing Board can contribute to this population approach by excluding these sporting events in this supplementary policy¹.

The Public Health representative and the Care and Learning representative said that events organised within an educational establishment where the target audience is young people under the age of 18 should not be included in this supplementary policy statement. From a population based approach it is important to give out sensible drinking messages to adults and young people because of the long term harms arising from alcohol misuse. Protecting young people is one of the objectives within the Alcohol etc (Scotland) Act 2010 and is in keeping with national policies of restricting alcohol availability.

Although the numbers of applications in these circumstances are likely to be small, it is the totality of measures that make a difference, relating to overall availability and promotion.

The reason for this is that we felt there was enough scope within the present arrangements. We - and one of us is a former publican - saw no advantage to easing the restrictions on late opening in this area. We have past experience here that late drinking often increases the likelihood of disturbance and potential violence, in particular during the busier months, in what is otherwise a quiet and peaceful area.

Morar itself has only one licensed premises, and we feel fortunate that it is reopening to the public this summer and will provide a much-needed social hub for the community.

However it is in close proximity to housing, and at one point in the past, when it was poorly run by previous owners, there was frequent early morning disturbance during the summer months. A couple of nearby residents keep poor health and such disturbance can be stressful for them and detrimental to their wellbeing.

We are not being killjoys, just realistic about what is best for our community, and we feel that this community is best served by somewhere which is open and welcoming to people throughout the day and into the evening, but with occasional late opening for events of local and community significance, which can be planned in advance.

Furthermore, there are implications for policing, and since this is now controlled from Fort William access to the service isn't so easy or immediate as it once was.

The festive period is so called because it is the time of year when a large proportion of the population celebrate and take time off work. People living close to licensed premises will be prepared to accept that there may be a bit of early morning disturbance at this time. Normal licensing hours still allow for plenty of time for celebratory activity at other times of the year and it seems unfair to expect the majority of folk who would not be drinking very late to have to put up with additional disruption on a almost routine basis, particularly if they have to work the next day.

Question 3: What, if any, other special events of local or national significance do you consider should be included and why? Loopallu, Ullapool. Attracts a large number of Highland Licensing Standards spectators. The festival closes at 2300 hrs on Officers each day following which licensed premises offer entertainment. The Board have promoted a policy for this event in previous years. Ullapool Skiff Regatta - This recently established annual event attracts a considerable number of competitors and spectators. Extended hours, until 0200 hrs, have been granted previously for the benefit of spectators, competitors and visitors. The Board have promoted a policy for this event in previous years.

Any special event or occasion to be catered for on premises if the applicant can evidence good reason why the event cannot be accommodated reasonably during core hours. Examples may include world-wide, significant, televised sporting events or occasions such as Olympic Games, rugby and football World Cups, American Superbowl and for private parties where there is a genuine good reason for a later start for the event or occasion.

There is a growing appetite for outdoor music festivals within the boundaries of or in proximity to some towns and villages and which, because of possible noises issues, cease their performances around 2300 hrs. Local licensed premises commonly then offer fringe entertainment and may apply for extended hours on a premises specific basis. If an event becomes established the Board may wish to put a promote a policy for such events and particularly when there is a history of demand and engagement with the licensing objectives.

It is an unintended consequence of the Board policy on general terminal hours that when a local gala or highland games, being an event of local significance, ends with a marquee or village hall the voluntary organisation can suffer financially while potential customers remain in pubs and hotels until closing time. These events operate with an occasional licence and organisers endeavour to engage a well-known band and need the profits from the bar to pay towards their There may be a case for not permitting extended hours on other licensed premises in the locality on those days but allowing the voluntary organisation occasional licence at the dance venue until 0200 hrs following appropriate consultation on the application.

An obvious category for consideration in this region would be the many local "Highland Games" which are held in localities across the Highlands. They are arguably stronger candidates for the label of "special events" than – for example – Hallowe'en. See also the general comments in response to Q7 below.

Question 7: Any other comments

Following informal discussion with licence holders. premises managers and staff in connection with the festive period extended hours it is interesting to note that sales of alcohol after 0100 hrs were less than operators had anticipated. It appears that a large number of customers treated the extended hours as an additional "drinking up" time and left the premises in smaller groups throughout the extra hour rather than en-masse at normal closing. The benefits of that more relaxed approach by the customers will likely be less noise and congestion in town centres, easier access to public transport and a lesser requirement for police to monitor noisy, boisterous groups. There is also some suggestion that night-club patrons are not obliged to queue for entry for extended periods thus reducing the opportunities for frustration and flashpoints.

This entire proposal seems to be based on some peculiar logic. There is widespread national consensus, and popular recognition, of the fact that Christmas and New Year ("the festive season") are a special period of public and private celebration when it is reasonable to permit licensed premises to extend their normal hours.

But to use this as a precedent, or a justification, for the automatic presumption of similar extension approval at other times of year is misconceived for two reasons. First, it immediately undermines the "specialness" of the festive season as a period when late-opening is socially acceptable. Second, the "default position" of presumed consent is abdication of the principal effectively an responsibility of the Licensing Board to manage and control the operation of licensed premises in a way which safeguards, and strikes a balance between. the interests of licence holders and their customers on the one hand, and the wider community on the other.

The proposal is deficient in two other respects. It fails adequately to define what might constitute a "special" or "major" or "significant" event. This leave the rules imprecise and the criteria undefined. How might the public, or indeed the licensees, understand how this proposed policy distinguishes between, say, outdoor events like Rock Ness and pop festivals; sporting events based around club premises, like a golf tournament; indoor events like Burns Suppers; and standard calendar dates.

The presumption of approval also ignores the crucial question of **venue**. A key element in consideration of extended hours is the potential impact upon the immediate vicinity. In a town or city centre scenario, presumed consent to an extension of hours – if afforded to one licensed establishment – would then be invoked as a precedent for similar extensions to all others. The licensing board ought to be able to take a view on whether all – or how many – premises in a given locality should be permitted extensions.

More serious is the scenario where licensed premises are located in a residential area. In such circumstances the presumption of automatic extended-hours approval, for whatever calendar dates the Board thinks are significant, would be totally unacceptable.

A further practical problem is that this proposal, because it sets the default as presumed consent, removes the scope for the licensing authority to scrutinise the details of any particular event, and constrains the exercise of the critical tools which the Board should be using to manage extensions of hours properly — namely the imposition of Late Opening Conditions.

In summary, this proposal is ill-judged, open to inconsistent interpretation and quite possibly unworkable in practice.

While generally agreeing that the Licensing Board should introduce a supplementary policy statement, any increase in extended terminal hours is incompatible with the recently introduced drink-drive limits.


