## **Environmental Health Operational Plan Review 2014/15**

### **Report by Director of Community Services**

#### **Summary**

This report invites Members to approve the review of the Environmental Health Operational Plan for 2014/15.

#### 1. Background

- 1.1 At the last meeting of the Transport, Environmental and Community Services on 6<sup>th</sup> February 2014 members approved the Environmental Health Operational Plan for 2014/15. The plan provides members with information on the objectives for the whole of Environmental Health including those areas not covered by the service plan. The report is published to also provide members of the public and businesses with background information on the function. The operational plan for 2105/16 was approved by this committee on 4<sup>th</sup> June 2015.
- 1.2 This report provides a review of the 2014/15 Environmental Health Operational Plan.

#### 2. Review of 2014/15 Environmental Health Operational Plan

- 2.1 A review of the specific objectives of the plan is provided in **Appendix 1.**
- 2.2 In summary, good progress was made with the key projects identified in the 2014/15 plan. Of the 46 identified:
  - 33 were either completed or are on track;
  - 12 were shown to have made some/little progress. Difficulties in progressing these projects were down to delays at national level or with lack of resources/competing priorities internally.
  - 1 project showed no significant progress this was on internal retention procedures. Work on this is being undertaken in 2015/16.
- 2.2 Key areas of work/achievements were:
  - a) Continued high performance on inspections of high risk food establishments and monitoring of high risk private water supplies;
  - b) Development and approval of new Joint Health Protection Plan for 2015-2017 with NHS Highland and Argyll & Bute Council;

- c) Taking forward work to control risks from VTEC/E.coli O157 at animal visitor attractions and events/agricultural shows;
- d) Taking forward work on an air quality management area within Inverness;
- e) Proactive work completed on gas safety and legionella with businesses throughout the Highlands;
- f) Working with the Scottish Government and the Food Standards Agency Scotland on the proposals and introduction of the new Scottish Food Safety Body 'Food Standards Scotland'. The new body was established in April 2015.
- g) Responding to over 5000 service requests from businesses and the public throughout the year. These include complaints and queries on all areas of Environmental Health and includes
  - 530 requests for assistance through housing grants;
  - 400 food safety related gueries;
  - Investigation of 90 accidents at work;
  - Investigation of 120 cases of enteric disease;
  - Investigation of 8 disease outbreaks (2 related to E.coli O157, 6 norovirus) and involvement at Ebola management group;
  - Investigation of 300 noise complaints;
  - Investigation of 370 nuisance complaints:
  - Investigation of 160 food hygiene/standards complaints;
  - Investigation of 100 complaints into private sector/rented properties;
  - Responding to 340 queries and complaints on animal health and Welfare;
  - Responding to 100 queries on private water supplies;
  - Responding to over 440 planning consultations.

#### 3. Implications

- 3.1 The operational plan contains actions that control risk associated with item CMS1 in the risk register 'Consequences of serious food and water borne disease outbreak'.
- 3.2 There are no Legal, Equalities, Climate Change/Carbon Clever, Gaelic or Rural implications arising from this report.
