Key issues raised were: duplication of meetings, potential staff overload, lack of clear agenda and focus. There was also confusion regarding the title 'District Partnership'. However no suggestion had been taken forward to rename the DP. LM advised that there is a statutory requirement to hold DP's. THC Corporate Manager and Director of Health and Social Care were continuing with the review process. Further direction re the shape and form of DP's to come early in 2014.

	Integrated Family Teams in Children's Services (report circulated)	A report had gone to Adult & Children Services Committee in November. Staff consultation is ongoing and a further report will be put to the Committee in early 2014 when a more concrete model is in place. Updated job descriptions had been distributed 3-4 weeks previously. On the whole there had been positive feedback in relation to the 'model'. DP will be kept updated on progress.		
	Implementation of 600 hours Early Learning and Childcare (report circulated)	<ul> <li>A report had gone to the Adult &amp; Children Services Committee on 13 November. The following points were highlighted from the progress report:-</li> <li>Moving from 475 pre-school education hours to 600 care &amp; learning hours by August 2014.</li> <li>135 primaries throughout the Highlands have nurseries. 74 with double sessions &amp; 61 with single sessions.</li> <li>2 options have been drawn up:-</li> <li><u>Option 1</u> - Extend both sessions to 3 hours per day. The sessions would have to run for two weeks longer than the school session and staff contracts would need to be extended to 37 hours per week.</li> <li><u>Option 2</u> - Extend both sessions to 3 hours 10 minutes per day. Nurseries would be staffed by two separate teams (am &amp; pm), all on 23 hours per week.</li> </ul>

		<ul> <li>27 road shows have been carried out, with the majority of staff favouring option 2.</li> <li>Site visits will be starting in January 2014 and all staff have been offered one to one consultations.</li> </ul>		
		Cllr Jaci Douglas commented that there were concerns with Grantown Primary due to the double sessions. The school has worked hard to get trained professionals who are very committed to their jobs. JD also queried why there could not be different options to fit locally as the same option might not fit in every area. This was noted.		
6	Adults Services (report circulate)	<ul> <li>The following points were highlighted from Margaret Walker's report:-</li> <li>Pilots currently running in Nairn. District Integrated Team are hoping to be replicated in B&amp;S.</li> <li>LM requested feedback from the pilots be reported back to the DP. MW advised she would be happy to report back once the feedback had been relayed to her.</li> <li>Care at Home staffing was problematic due to staff health. With 70.3 hours allocated in Nairn, ways of getting people in posts quickly were being looked into to make sure the service was being delivered.</li> <li>B&amp;S are fully staffed with the establishment they are meant to have, however, due to the wide spread area they could do with more staff. This is being looked into with the hope to get more staff, so they can be more evenly spread.</li> </ul>	MW	04/04/14
