Street naming – New developments at Slackbuie, Inverness and at Tomatin Report by Director of Development and Infrastructure

Summary

The Committee is asked to homologate decisions by the Community Councils, supported by the local Members, to name:

five residential streets at Slackbuie that currently have built units:

- Poppy Gardens (Gàrradh a' Chrom-Iuis)
- Lily Bank (Bruach na Lilidh)
- Gorsebank (Bruach a' Chonaisg)
- Ivy Crescent (Corran na h-Eidhne)
- Foxglove Crescent (Corran Lus nam Ban-Sìth)

and one street in Tomatin that currently has built units:

Mill View (Sealladh a' Mhuilinn)

1. Background

1.1 The Council's Corporate Address Gazetteer (CAG) Team within the Development and Infrastructure Service was asked by the developers who were building residential properties, to create addresses for the new roads.

2. Consultations

- 2.1 The CAG Team determined that there should be street names. A request was sent to the Ward Manager to consult with the Community Councils and local Members who all agreed that the streets be called as follows:
- 2.1.1 five residential streets at Slackbuie that currently have built units:
 - Poppy Gardens (Gàrradh a' Chrom-luis)
 - Lily Bank (Bruach na Lilidh)
 - Gorsebank (Bruach a' Chonaisg)
 - Ivy Crescent (Corran na h-Eidhne)
 - Foxglove Crescent (Corran Lus nam Ban-Sìth)
- 2.1.2 and one street in Tomatin that currently has built units:
 - Mill View (Sealladh a' Mhuilinn)

3. Delegation to City/Area Committees

3.1 As per the Scheme of Delegation the final decision on Street and Building Naming is delegated to the Area/City Committees. However in this instance the properties at Slackbuie and Tomatin were ready for marketing prior to this committee. We therefore had to act on what had been agreed with the Community Councils and local Members and bring the matter to the Area Committee for homologation.
