Report by the Director of Community Services

Summary

This report provides information to Members on the status of the 2015-16 Housing Revenue Account Capital Projects and the 2016-17 Housing Revenue Account Capital Programme for the Lochaber Area.

1. Background

- 1.1 At the Area Committee on 26 February 2015 Members were first presented with a report giving the status of capital projects for the Area as detailed in Appendix 1 of that report. Members will recall that the approved work is targeted in order to meet the Council's commitment to achieving the Scottish Housing Quality Standard.
- 1.2 The mainstream HRA Capital Programme 2013/15 was approved by the Finance, Housing and Resources Committee on 3 October 2012, subsequently updated for revised cost estimates, and approved by the FHR Committee on 9 October 2013 and Community Services Committee on 5 February 2015. The bulk of the programme is committed to completing contracts to achieve the Scottish Housing Quality Standard. The programme also includes additional resources for Adaptations for disabled tenants and other priority work. This has been allocated pro-rata by housing stock, with £94,950 for adaptations and £189,000 for Other Projects in Lochaber. Some projects relate to more Areas than Lochaber. The total approved HRA Capital Programme which relates to projects for Lochaber for 2015/16 is £11.171m.

2 2015-16 Capital Projects

- 2.1 An update for Members on the 2015/16 programme is given in **Appendix 1** which provides Spend to Date, Estimated Outturn and the Approved Project Cost. At this stage full spend is anticipated with projects completing before the end of the current financial year.
- 2.2 With regard to the current heating projects the Contract Administrators continue to liaise with the local Principal Housing Officer so that a heating system is chosen which is appropriate for the tenant and which will also ensure the property meets the Energy Efficiency standard as required by the Scottish Housing Quality Standard.

3 Lochaber HRA Capital Programme 2016-17

On 5 November 2015 the HQ Community Services Committee approved the Highland wide HRA Capital Programme for 2016-17.
 The total budget allocation for Lochaber is £1,202,146. The outline of the programme is given in Appendix 2 and is in accordance with the Briefing Note provided for

Members for the Consultation meeting that took place on 21 October 2015.

3.2 Members will recall that the elements of the programme are:

3.3 Major Component Replacement

Prioritising kitchens over 30 years old, bathrooms over 30 years old, windows and doors over 30 years old, rewiring over 30 years old. Representing 45% of annual programme.

3.4 Heating / Energy Efficiency

External wall insulation. Install on suitable properties.

Prioritise all heating systems over 20 years old and all low performing electric heating systems and replace with renewable systems from our heating options approach. Solar panels/district heating. Based on individual feasibility studies and availability of external funding.

Representing 45% of annual programme.

3.5 External fabric (major component replacement)

Major component works/disrepair e.g. re-roofing. Replace where Health and Safety issue or identifiable damage to property over long-term period.

Representing 5% of annual programme.

Work put forward informed by recommendations from local Maintenance Officers.

3.6 External fabric (environmental improvements)

Undertake local priority projects to improve the environment of HRA housing estates. This section is Member led representing 5% of annual programme.

Liaison with Members is underway to identify local issues previously raised by local communities. Budget allocation permitting for any new projects, community consultation, led by the Tenant Participation Officer will be undertaken.

3.7 Equipment and Adaptations

At a set overall budget for the NBSL Area of £180,000 per year for the five years with clients identified via Occupational Health Advisor. This budget divided pro-rata by % of Council housing stock by Ward.

3.8 Address Lists

Members had requested address lists for the projects. It is considered that it is not appropriate for these to be released onto the Council's Internet with this report and consequently these will be provided to Members separately.

3.9 Monitoring of Progress

The status of the 2016-17 projects will be reported to future Lochaber Area Committees.

4 Potential External Insulation Works

4.1 At the Area Committee on 21 May 2015 the issue of completing external insulation work at the remainder of the properties in Plantation had been raised.

The first phase of the external insulation work in Plantation was carried out with 100% funding from Scottish Power. This was because even though the properties are cavity construction Scottish Power were able to secure funding as the properties were deemed to be "hard to treat". The contractor was only able to deliver 44 fully complete properties by the time the available funding ceased at the end of March 2013. There

are 45 properties which did not receive external insulation in the work carried out in 2012-13.

The Energy & Sustainability team approached E.on to seek match funding for the remaining 45 properties. E.on advised that as the construction of the properties is cavity wall they are not able to provide funding for external wall insulation. Scottish Gas has also been approached however no expression of interest was forthcoming from them.

At the time of writing this report clarification is being sought as to the number of utility companies approached and the responses in relation to completing the external insulation work in Plantation. An update will be provided at the Area Committee.

Without match funding the indicative cost per property is in the order of £11,200 so an indicative cost of £504,000 would be required to complete these 45 properties should a match-funding partner not be found.

On 5 November 2015 the HQ Community Services Committee approved the Highland wide HRA Capital Programme for 2016-17.

At the Consultation Meeting with Lochaber Members on 21 October 2015 regarding the 2016-17 Lochaber HRA Capital Programme the proposed works taking up the budget were agreed without including external insulation due to the lack of a matchfunding partner.

There is a commitment to continue to work with the Energy & Sustainability team to identify a match-funding partner to complete the external insulation work in Plantation. The outcome of this work will be used to inform consultation with Members for the 2017-18 Lochaber HRA Capital Programme.

5. Implications

- 5.1 **Resources:** The budget for the 2016-21 Capital Programme for Highland was agreed at the Community Services Committee on 20 August 2015. There will be an annual review of the Capital Plan.
- 5.2 **Legal**: There are no known legal implications.
- 5.3 **Climate Change / Carbon Clever**: Investment in heating and energy efficiency through the HRA Capital Programme contributes to Council policy.
- 5.4 **Risks:** there are risks associated with the delivery of the capital programme which will be mitigated through regular monitoring and reporting to both the HQ Community Services Committee and Area Committees.
- 5.5 There are no known specific equality, Gaelic or risk implications arising from this report.

Recommendation Members are invited to note:-

- (i) the status of the 2015-16 Lochaber HRA capital projects contained in this report.
- (ii) the position regarding the 2016-17 Lochaber HRA Capital Programme and that the status of the 2016-17 programme will be reported to future Lochaber Area Committees.

(iii) the position with regarding completing external insulation work in Plantation, Fort William.
