Grass Cutting and Ancillary Works Specification and Priorities

Report by Director of Community Services

Summary

This report presents an update on progress with the retender of grass cutting and ancillary services including the specification for grass cutting service standards.

1. Background

- 1.1 On 20 August 2015 report Ref COM/43/15 was presented to the Community Services committee.
- 1.2 A programme of Ward Business Meeting briefings on the retender and Community Engagement are being delivered between January and March 2016 (Appendix A).
- 1.3 Common themes emerging from the WBM's are: contract monitoring, support for consistent standards, support for asset based budget and ability to set local priorities within budgets, and concerns regarding strength of communities to support community engagement.

2. Contract Monitoring and Management

- 2.1 The Community Services HQ based team will continue to manage the contracts, undertaking validation inspections and provide training and support to the operational staff in the Areas.
- 2.2 It is intended that the future contract will include self-monitoring by the contractor of his sub-contractors work using IT mobile working.
- 2.3 It is intended to utilise the Council's mobile working IT system Total Mobile and those of contractors, with trials organised for 2016. In Inverness the contractor, ISS, has introduced their system (All on Mobile), whilst the Council's system is to be tested on Skye and with the in-house service in Sutherland.

3. Standards and priorities

3.1 Results from panel and Community Council surveys show that maintenance of burial grounds, sports pitches and play areas are a very high priority for local

communities.

- There is no statutory requirement stipulating that amenity grass must be cut. The Council has various duties to maintain public safety, deliver education in accordance to national standards, deliver a burial service, maintain roads and paths in a safe condition, and support the national play initiatives. To discharge these duties requires varying minimum standards of grass cutting to be delivered.
- 3.3 The amenity grass estate maintained by CS is allocated to budget groups and has been classified into three categories:
 - A Statutory where there is no scope for change of standard
 - B Statutory but reduction of standard possible and/or transferral
 - C Non-statutory where grass cutting could be reduced, ceased or transferred
- 3.4 Initial assessment shows there are limited areas classified as C but significant areas classified B where communities could request to take on works if the local requirement is for a standard above the statutory minimum.
- 3.5 Feedback from WBM's on revisions to priorities and standards has been positive.
- 3.6 It is proposed to modify the standards delivered in accordance with the general details given in **Appendix B.**
