Development Plan Scheme 2016

Report by Director of Development and Infrastructure

Summary

This report outlines the content of the annual Development Plan Scheme (DPS) which provides an up to date position on progress in preparing and reviewing the Development Plan for Highland, and tells people how and when they can get involved. We have retained the 'Newsletter' format for this document following its introduction last year. This aims to make it more useful and appealing to our communities and stakeholders.

Members are asked to approve the Development Plans Newsletter as the 2015 Development Plan Scheme for submission to Scottish Ministers and publication on the Council's website.

1. Background

- 1.1 The Planning etc. (Scotland) Act 2006 introduced a requirement for each planning authority to prepare a Development Plan Scheme (DPS), to give certainty to communities and developers as to when each stage of the development planning process will be reached, and how people can get involved.
- 1.2 Last year, the Highland Council DPS was published as a 'Development Plans Newsletter' which aims to make it more useful and appealing to our communities and stakeholders. This aims to contribute towards the Community Planning Partnership's outcomes for reducing inequality as set out in the Highland Single Outcome Agreement 3.

2. The 2016 Development Plans Newsletter

- 2.1 This year's Development Plans Newsletter, enclosed at **Appendix 1**, includes updates on:
- adoption of the Inner Moray Firth Local Development Plan (IMFLDP), and current and future stages in preparing the Caithness and Sutherland Local Development Plan (CaSPlan) and the West Highland and Islands Local Development Plan (WHILDLP);
 - the next stage in reviewing the Highland-wide Local Development Plan (HwLDP);
 - the preparation of Supplementary Guidance; and
 - our Participation Statement explaining how we will involve people in the

preparation of our Development Plans.

- 2.2 The content of the DPS has been updated to track performance against timescales set out in the 2015 DPS, and to provide an indicative 5 year programme, setting milestones to be reached in order to realise the Scottish Government's challenging Development Plan preparation timescales. The Newsletter highlights the Development Plan's role in informing decision making, and the various ways in which people can influence this through each stage of plan preparation.

3. Implications

3.1 Resource

It is not anticipated that there will be any direct resource implications for the Council, as preparation of these documents, and their monitoring, is part of the existing work programme of the Development Plans team.

3.2 Equality and Climate Change/Carbon Clever

It is not anticipated that there will be any equality or climate change/carbon clever implications for the Council.

3.3 Legal and Risk

It is not anticipated that there will be any legal or risk implications for the Council.

3.4 Rural

There are no known direct rural implications arising from this report. All communities, including rural, will be consulted with, and given the chance to influence development within their area through making representations to emerging Local Development Plans. All consultation documents are made available on our website with alerts placed on social media to raise awareness and reach out to all communities.

3.5 Gaelic

There are no Gaelic implications arising from this paper.

Development Plans Newsletter

This is Highland Council's Development Plans Newsletter which provides an annual update of the timetable for preparing land use planning documents for the Highland Council area. It lets you know how and when you can get involved in preparing these plans. This Newsletter also acts as the Council's **Development Plan Scheme** that we submit to Scottish Government.

The Development Plan is a set of documents that guide where and how new building and development can take place across Highland. These documents include Local Development Plans (LDPs) that set out policies and site allocations, and Supplementary Guidance (SG) which contain more detailed

guidance on specific issues or places. Planning applications for all types of development are assessed against these documents so it's important that people know when and how they can input to them. What's happening now and looking ahead

Over the last few months we have formally adopted the first of our Area LDPs for the Inner Moray Firth area. The Proposed LDP for Caithness and Sutherland has been published for consultation from 22 January to 18 March, and throughout February Area Committees will be asked to approve a Main Issues Report for the West Highland and Islands LDP. Earlier in 2015 we launched a new online consultation portal for Development Plans consult.highland.gov.uk providing people with an easy method for reading and commenting on draft plans. Hundreds have registered with the service and five separate consultations have been carried out, gathering comments from over 1200 people or organisations. In the most recent consultation almost 90% of comments were made through the online portal and we will be promoting this further throughout 2016.

We have been working with the [Highland Community Planning Partnership](#) to get public sector buy-in on development plans. We have also continued to work with communities to help enable regeneration, including work with the Isle of Rum Community Trust on a new community plan, and publication of Town Centre Action Plans for Tain, Nairn and Fort William and the Muirtown and South Kessock Development Brief. We have also started to update our approach to monitoring and audits to make sure plans are based on the most up to date information.

There are a number of priorities for the year ahead:

- The **Caithness and Sutherland Proposed Local Development Plan** will be out for consultation from 22 January to 15 March. A new **Pentland Firth and Orkney Waters Pilot Marine Spatial Plan** is being finalised for publication.
- The **Highland-wide Local Development Plan Main Issues Report** was out for consultation until 29 January 2016. Comments made are being considered to help prepare the next stage, the Proposed Plan. Later, comments will also be sought on new Supplementary Guidance on issues such as wind energy development, and a new Local Transport Strategy.
- The **West Highland and Islands LDP Main Issues Report** marks the first stage in preparing this new plan and will be taken to Area Committees in February 2016 before being published for consultation in spring.

Full details of these plans are set out in this Newsletter and the back page shows the timetable for preparing them.



How to get involved in preparing Development Plans

We aim to make Development Plans that represent the views of those who live, work and invest in the Highlands. To achieve this we encourage people to get involved from an early stage in the preparation of these plans. The 5 key stages of preparing a Local Development Plan are shown in the diagram below. This begins with the Call for Sites and Main Issues Report (MIR) stages (**shown in green**), followed by the Proposed Plan (**amber**). At the final stage an Examination (**red**) is carried out by independent Reporters who may invite further comments from those who commented on the Proposed Plan.

This Newsletter tells you how and when you can get involved at each stage. By registering with our new online consultation portal consult.highland.gov.uk customers can be kept up to date with the progress on each plan.

Our **Participation Statement** below outlines our commitment to involving you. We will:

- Produce interactive online documents that are easy to read and comment upon
- Include clear maps and graphics in our documents
- Use a range of media to keep you up to date and let you know how and when you can get involved
- Provide copies of plans in Service Points and Libraries
- Work with community groups and stakeholders to encourage them to participate
- Use public meetings and committees to provide regular progress updates
- Maintain our availability so you can speak with the people preparing the plans

The Highland-wide Local Development Plan

The **Highland-wide Local Development Plan (HwLDP)**, was adopted in April 2012, and provides an overarching 20 year vision and spatial strategy for the Highlands. The plan contains planning policies and site allocations to help make decisions on planning applications. The HwLDP is accompanied by Supplementary Guidance (SG) which forms part of the Development Plan and provides more detailed information on various topics.

The HwLDP needs to be replaced by 2017. The new HwLDP is proposed to be a policy only plan, with any site allocations and maps transferred to the Area LDPs and area based SG. We have started the review of the HwLDP and ran a public consultation on the HwLDP2 Main Issues Report for 18 weeks up to 29 January 2016. Nine consultation events were held across a wide geographical area. At the close of the consultation over 120 responses were received. We are now considering all comments received on the options for the future vision, spatial strategy and policy issues.

Looking ahead, the **Proposed Plan** is anticipated to be published in **summer 2016**. When it is agreed by Committee it will become the Council's settled view on the vision, spatial strategy and policies to inform future development.




Topic Based Supplementary Guidance

The HwLDP includes a range of SG on topics and areas. As the new HwLDP will cover policies only, we have started to transfer any area based SG (such as Development Briefs) across to the relevant Area LDP. The table below sets out our programme for preparing topic based SG over the year ahead. The programme of work for area based SG is set out against the relevant Area LDP.

We had previously intended to prepare topic based SG on Accommodation for an Ageing Population but it is felt appropriate to await the feedback on the MIR to determine the scope and necessity for this work.

Area LDPs - Identifying Where Development Can Happen

Area Based SG

The process of preparing Area LDPs is similar to the HwLDP but with a focus on where and how development could be delivered. As development plans affect everyone in an area we will continue to make efforts to raise awareness and encourage participation in development plan consultations. We have and will continue to notify the immediate neighbours of potential development sites when we consult on our Area LDPs. The timescales for preparing or reviewing Area LDPs is set out below.

Area Based Supplementary Guidance


Area based SG also forms part of the Development Plan and contains more detailed guidance on how places or sites can be developed. The existing suite of SG will be reviewed as the Area LDPs are prepared, when any new SGs will also be flagged up.

Progress in preparing SG relevant to the IMFLDP area is listed below. We had planned to prepare SGs for Developer Contributions in the A96 Corridor, and Development Briefs for the Ashton Farm area and the Longman Core and Longman Landfill areas. However, this work will need to await the outcome of Transport Scotland's A9/A96 Connections Study. We plan prepare a programme of work for these projects in next year's Development Plans Newsletter.

Inner Moray Firth Local Development Plan (IMFLDP)

The IMFLDP was adopted by The Highland Council on 31st July 2015 following modification of the Plan in line with recommendations from the Examination Report. The Plan was the first Area LDP to be adopted alongside the HwLDP. An accompanying Action Programme was published in October 2015, setting out the actions for delivering the plan. This will be reviewed at least every two years.

Progress in preparing SG relevant to the IMFLDP area is listed below. We had planned to prepare SGs for Developer Contributions in the A96 Corridor, and a Development Brief for the Ashton Farm area. However, this work still awaits the final outcome of Transport Scotland's A9/A96 Connections Study. A programme of work for these projects in next year's Development Plans Newsletter.


Caithness and Sutherland Local Development Plan (CaSPlan)

The CaSPlan will be the second of our Area LDPs. The **Proposed Plan** is the Council's settled view on the vision, strategy and allocations that should guide future development. The vision is described as four Outcomes outlining what the Plan aims to achieve for people and places in the area. Maps show where development is likely to be supported.

We are running a public consultation on the **Proposed Plan** from 22 January to 18 March 2016.

Following consultation on the MIR, we undertook a consultation on additional sites and issues that had been raised in comments on the MIR. We considered all of the comments from both consultations carefully before deciding on the contents of the **Proposed Plan**.

Looking ahead, once we have considered the comments received on the **Proposed Plan** we will look to finalise the Council's position. We aim to submit CaSPlan to Scottish Ministers in late summer 2016, leading to an **Examination** of outstanding issues by a reporter appointed by Scottish Government, likely to begin in **autumn 2016**.

West Highland and Islands Local Development Plan (WHILDP)

The West Highland and Islands will be the third and final Area Local Development Plan to prepare. As with other plan consultations we will continue to encourage interest and participation in the plan making process through a range of community groups. High Schools in the area were closely involved in the early stages of preparing the plan.

The **Call for Sites and Ideas** stage for the WHILDP commenced in January 2015 and ran until **27 March 2015**. Comments, suggestions and ideas received helped inform the preparation of the **Main Issues Report** which will be published for consultation in spring 2016.

Community Plans

The Community Empowerment Bill is introducing new opportunities for local people to play a greater role in shaping their community. In Highland, we see this is a natural extension to the role local communities play in contributing to the preparation of Development Plans. As new Area LDPs are prepared there will be an opportunity for smaller communities to prepare their own Community Plan to promote sustainable growth in conformity with the Area LDP. We will ask community groups to tell us whether they are interested in such opportunities. We have already assisted the Rum Community Trust in preparing a community land use plan which we intend to bring forward as Supplementary Guidance to the West Highland and Islands Local Development Plan.



Monitoring and Research

Auditing and monitoring work provides useful evidence for preparing Development Plans. We prepare a range of documents on a variety of topics to help ensure that our Development Plan are based on the most up to date information. The use of online mapping is helping to improve access to and sharing of information.

Over the coming year the team will be working on the **Modernising Monitoring Project** which will update the way we carry out such monitoring. We have also updated the timetable for carrying out such work which is set out below.

Our online **Wind Farm Mapping** launched in 2015 provides an interactive map of wind turbines across Highland. In the first quarter of 2016 we propose to expand this to include new applications for wind energy development, as well as Screening and Scoping applications. An audit of **Hydro schemes** will also be carried out with results published through the online mapping.

The **Housing Land Audit** published in October last year, and shown on our online mapping, provides an update on housing land supply, and will now be published every year. Alongside, we continue to carry out monitoring of **weekly planning approvals** and **monthly housing completions**.


We also aim to publish a **Business and Industrial Land Audit** in June 2016 providing an overview of employment land, and a **Retail Audit** providing snapshots of the current and changing provision of retail land across Highland.

A **Minerals Audit** is underway to gather baseline information on the landbank of available mineral resources across Highland. This is aimed at improving the monitoring process for active and dormant mineral assets across the area.

We will continue to publish monthly updates of social and economic changes published in **Ward Profiles. Monitoring Statements** give a snapshot of the social and economic changes in a Local Development Plan area, and this year the Main Issues Report for the West Highland and Islands will be supported by a Monitoring Statement. The Scottish Government expects to publish an update to the **Scottish Index of Multiple Deprivation** in May and we will publish an analysis of the results for Highland.
