NOTICE IN RESPECT OF ALDI STORES LIMITED

- 1. In October 2014, a company, Wilkinsons Maintenance, carried out works at one of Aldi's depots in Darlington.
- 2. As part of the works, a smoking shelter was relocated for a short period.
- 3. Strong winds led to this smoking shelter being lifted from the ground and striking an Aldi employee.
- 4. The employee suffered soft tissue damage and was off work for three months. The employee, after a phased return is now performing the same duties as before.
- 5. Both Aldi and Wilkinsons Maintenance were prosecuted by Darlington Burgh Council under Section 2 and 3 of the Health and Safety at Work etc Act 1974. Whilst Wilkinsons Maintenance had generated a full risk assessment and method statement and the works had been checked by Aldi, the Council felt that a separate risk assessment should have been carried out for the temporary relocation of the smoking shelter. It was under that area that charges were brought.
- Both Aldi and Wilkinsons Maintenance pled guilty to one charge each, Aldi under Section 2 of the 1974 Act and Wilkinsons Maintenance under Section 3 of the 1974 Act by putting employees at risk.
- 7. Aldi were fined £100,000 in respect of this conviction. It should be noted that while the fine is large, it is based upon the turnover of their company in question. By way of example, Wilkinsons Maintenance were fined £20,000 as a result of the same incident.
- 8. It should be noted that this conviction relates to a matter outwith the Board's area and is not linked to the sale of alcohol.
- 9. Police Scotland have not taken the opportunity to make any recommendation re further action.
- 10. Aldi Stores in the Board's area do not have smoking shelters.
- 11. This is the first time that Aldi has had to report a relevant offence.
