Application for the grant of a licence for a house in multiple occupation – 23a High Street, Inverness (Ward 15 – Inverness Central)

Report by the Principal Solicitor

Summary

This Report relates to an application for a licence for a house in multiple occupation.

This application is subject to a formal hearing procedure.

1.0 Background

- **1.1** The licensing of houses in multiple occupation is an activity covered under Part 5 of the Housing (Scotland) Act 2006. The licensing of this activity became mandatory on 1 October 2000 and from this date all houses in multiple occupation which had six or more persons residing at the premises required to be licensed. This limit or threshold has been reduced and now applies to properties with three or more unrelated persons.
- **1.2** An HMO is defined as living accommodation in which 3 or more unrelated adults live and share one or more of the basic amenities which are a toilet, personal washing facilities and facilities for the preparation or provision of cooked food. It must be their only or main residence.

2.0 Application

- 2.1 On 24 May 2016 an application for the grant of a licence in respect of a house in multiple occupation was received from Mr Ali Mohamed. The application must be determined by 23 May 2017, failing which the Council will be treated as having decided to grant the HMO licence unconditionally.
- 2.2 The property to which the application relates is 23a High Street, Inverness. The maximum number of persons applied for to reside at the property was 31. On 15 June 2016 a letter was received from the applicant advising that they wished to reduce this maximum number to 20.
- **2.3** A location plan is appended for Members information (Appendix 1).

3.0 Process

- **3.1** Following receipt of this application a copy of the same was circulated to the following agencies/services for consultation:
 - Police Scotland
 - Scottish Fire and Rescue Service
 - Highland Council Environmental Health Service
 - Highland Council Building Standards Service
 - Highland Council Planning Service
 - Highland Council Housing Service
- **3.2** At the time of writing confirmation has been received from Police Scotland, the Fire Service and the Council's Environmental Health, Planning Service and Housing Service they have no objections to the application.
- **3.3** The Building Standards Service have advised that the access to the attic rooms require be adequately blocked up and they would not consent to the granting of the HMO licence until this has been undertaken.
- **3.4** Up to date copies of the electrical and portable appliance test certification have been received and are satisfactory. Copies of the current gas and public liability insurance certificates still require to be submitted by the applicant.

4.0 Objection

- **4.1** A letter of objection has been received in relation to the application from MacLeod & MacCallum Solicitors on behalf of Inverness BID Ltd. A copy of the letter is contained in Appendix 2.
- **4.2** This letter of objection refers to a planning appeal decision (PPA-270-2148) issued on 23 May 2016 by a Reporter appointed by the Scottish Ministers. This decision granted planning permission for a change of use at this premises to a house in multiple occupation with ancillary use as a hostel. This decision notice is attached in Appendix 3.
- **4.3** The decision notice contains up-to-date information on the internal alterations and improvements to the premises currently being undertaken and the new facilities (including a new bin store) to be provided. As this up-to-date information is relevant also to the question of suitability of the accommodation for occupation as an HMO from a licensing perspective, the Committee is advised to take it into account in considering the grounds of objection raised on behalf of BID Ltd. Members should also note the six conditions to which the planning permission is subject, most of which are designed to regulate waste management at the HMO, a matter raised in the BID objection.

5.0 Hearing

5.1 In accordance with the Act both the applicant and persons submitting the objections have been invited to attend the meeting and will be provided with an opportunity to address the Committee through the hearing procedure.

6.0 Determining issues

- **6.1** Section 130 of Part 5 of Housing (Scotland) Act 2006 states that a Licensing Authority may refuse to grant a licence where the applicant or anyone else detailed on the application is not a fit and proper person to be authorised to permit persons to occupy any living accommodation as an HMO.
- **6.2** Section 131 of the same Act also states that a Licensing Authority may grant a licence only if it considers that the living accommodation concerned:
 - (a) is suitable for occupation as an HMO, or
 - (b) can be made so suitable by including conditions in the HMO licence,

and in determining whether any living accommodation is, or can be made to be, suitable for occupation as an HMO the local authority must consider—

- (a) its location,
- (b) its condition,
- (c) any amenities it contains,
- (d) the type and number of persons likely to occupy it,
- (da) whether any rooms within it have been subdivided,

(db) whether any rooms within it have been adapted and that has resulted in an alteration to the situation of the water and drainage pipes within it,

- (e) the safety and security of persons likely to occupy it, and
- (f) the possibility of undue public nuisance.
- **6.3** If required the Principal Solicitor will offer particular advice on the criteria relating to this particular application.

7.0 Policies

7.1 The following policies are relevant to this application:

or a hard copy can be supplied where requested.

8.0 Other requirements

8.1 If members are minded to grant the application delegated powers should be given to the Principal Solicitor to issue the licence once any requirements required by the services details in Paragraph 3.1 of the report have been completed and any relevant documents and certification submitted.

9.0 Recommendation

Members are invited to determine the above application.

If Members are minded to grant the licence, agreement should be given that the licence be issued by the Principal Solicitor using delegated powers once any required documents and certification, and confirmation of satisfactory completion of required works, have been received. Agreement should also be given that, in the event that these are not received by 23 May 2017, the application be refused under delegated powers.

Whether Members are minded to grant the licence or to refuse the application on one of the grounds detailed in paragraphs 6.1 and 6.2 of the report, reasons for their decision must be given.

Objection to HMO Licence application Ho Ho Hostel/Highlander Hostel, 23A High Street, Inverness

We are instructed by Inverness BID Limited, who are a statutory body representing over 850 businesses in Inverness city Centre. They wish to raise an objection in connection with the HMO application submitted in respect of the premises known as Ho Ho Hostel, 23A High Street, Inverness which were referred to in a recent planning application as Highlander Hostel, 23 High Street, Inverness. Our client is treating these addresses as interchangeable and referring to the same property, namely the premises from which the Highlander Hostel was previously operated by the Applicant.

Our client's objections in respect of the proposed HMO application are as follows:

1. Suitability of Applicant

In terms of Section 130 of the Housing (Scotland) Act 2006 (hereinafter referred to as "the Act"), our client does not believe that the Applicant can be considered a suitable or fit and proper person to be authorised to permit persons to occupy any living accommodation as an HMO.

Our client has provided us with evidence confirming that the premises were not maintained to standards expected of an HMO property. To support our client's assertion, we enclose evidence of TripAdvisor reviews dating back a number of years to confirm the poor condition of the property over a sustained period of time and the poor attitude of staff in the premises. All of which went unchecked by Mr Mohammed.

There were also previous issues in connection with the operation of the premises. There were issues in connection with noise and disturbance, including inadequate refuse storage, that were not adequately addressed by the Applicant in the past. There are therefore concerns that, given that standards are already poor at the premises, as identified below, if concerns are raised, the Applicant is not of a suitable standing to address or rectify difficulties.

Whilst our client appreciates that Mr Mohammed was ill for a short period of time, the TripAdvisor reviews clearly show that the standards at the property have not been maintained for a number of Furthermore, the TripAdvisor reviews cover a period prior to Mr Mohammed's illness. years. Therefore there were long and continued periods whereby the standards at the property were not maintained prior to any illness. Therefore our client would stipulate that Mr Mohammed is not a fit and proper person to be authorised to have HMO accommodation.

Furthermore, our client has provided evidence that the person who operated as Manager, Sinclair Ross, who appeared to be the primary point of contact for hostel residents, has been convicted of carrying out a string of assaults on various girlfriends between 1999 and 2013. Some of these assaults took place whilst Mr Ross and his girlfriend were living at the hostel at the end of 2013. This highlights that Mr Mohammed was not monitoring staff performance to ensure that HMO occupiers are kept safe.

2. Suitability of living accommodation

Under Section 131 of the Act, we would propose that the premises are not suitable for occupation as an HMO on the following grounds:

- (a) From review of the TripAdvisor reviews, it is apparent that there are issues in respect of safe access, both to the premises and also to the individual rooms within the premises.
- (b) Condition of the accommodation Again from the TripAdvisor reviews, it is clear that there are issues with damp, lack of heating, condition of the kitchen, mould in the bathrooms, windows not closing to name a few.
- (c) Amenities the accommodation contains There are inadequate cooking and sanitary facilities available for the potential occupation of the premises. The TripAdvisor reviews clearly point to an unhygienic kitchen which people feel they cannot use (thus resulting in a shortage of cooking facilities) and a shortage of sanitary facilities.
- (d) The type and number of persons likely to occupy the premises Recent press reports by Mr Mohammed have indicated that Mr Mohammed is looking to have some occupiers on a longterm basis. Our client does not believe that the accommodation is therefore appropriate to meet the proposed occupiers' needs. See our comments above with regard to kitchen and sanitary facilities.
- (e) Security is also an issue in terms of anyone being able to gain access to the premises. Furthermore, there are concerns that people with specific mental health requirements would potentially be in occupation of the premises without any specific support.
- (f) Inadequate refuse storage and noise disturbance There were issues previously in connection with noise and disturbance at the premises and inadequate refuse storage. Whilst the Scottish Government Reporter, in granting planning permission in respect of the premises has indicated that these matters will be under the control of fewer residents in the new layout, the application submitted in respect of the proposed HMO licence is actually for one additional bed than previously held. Therefore, there are concerns that the standards of hygiene, including refuse storage, and issues in respect of noise disturbance are likely to be exacerbated rather than controlled or dealt with.

In the circumstances, our client considers that the Council is entitled to, and should, refuse the proposed HMO application.

"GIRLS, DO NOT GO HERE!!"

Reviewed 4 weeks ago

After reading the reviews on this place, my best friend and I were a bit skeptical to stay here (only read reviews on cleanliness and poor hygiene). Upon check in we were surprised at how clean this place was compared to what we had read. Firstly, we were put in a tiny room of 6 beds, and being the only two females in the room we asked if we could move to a private room as we didn't feel comfortable. That was all fine until one of us went to reception to use the wifi (we couldn't connect in our room), and the man at reception 'Vigil' striked up a conversation with a very inappropriate topic (sexual). We won't go into detail, but this set off pretty big alarm bells to us. Whilst in the common room we over heard a man ask why he was paying a different rate to another person in his room for the same

amount of nights, to which vigil got VERY defensive and wouldn't give any answers, always saying 'I don't know' until the man gave up and walked away. We also noticed that the folder just sitting on the reception desk had all of the codes to every room for everyone out to see. After building a barricade with our beds against the door (I know it sounds over the top, but this is how uncomfortable we felt) we tried to get some rest so we could wake up early and find somewhere else to move. When we went to reception to see avout a refund, no one was there - so we just left after seeing a sign saying 'strictly no refunds!' After moving to a different hotel, vigil saw us on the street, approached us and asked where our suitcases were because he had gone into our room to "fix it up". Since when do hostels do daily cleans???? WE WOULD NOT RECCOMEND ANYONE TO STAY HERE - DON'T BE FOOLED BY THE BUDGET PRICE!

"Booked for two nights, checked out after 7 hours!"

Reviewed 1 September 2015

Dirty facilities-showers, rooms and showers. Rude and unhelpful staff who had no idea about my booking. Some very dodgy looking blokes-vagrants? Very unfriendly and just a complete shocker. I was very lucky with my room mates-nice guys. Could not wait until the morning. I have been around the world and stayed in some poor quality accommodation in my time and this place must be in the top 5 hostels to be avoided. The kitchen alone deserves a visit from the local authority EHO-I know as I have managed restaurants and hotels for 35 years. AVOID! **Room Tip:** Want a good room? Go to another hostel.

"Outrageous"

Reviewed 26 August 2015

This was the worst hostel experience I've ever had. I have serious doubts about whether their rooms would pass a test for minimum safety and cleanliness standards. The room we were booked into was unsafe, dirty and way overpriced. The bathroom and kitchen were filthy. Plus the staff person who greet us was really rude in more ways that one . When we asked for a refund on seeing the room, they refused. I wouldn't recommend this place to anyone. I'd rather sleep in a park.

"Cheap - but do you get what you pay for?"

Reviewed 19 August 2015

I used this hostel in 1999 (called Ho Ho Hostel back then). It was cheap, crowdy but ok. That was then. It was probably more crowdy this time with people sleeping in the common room. The beds don't seem to have changed but the mattresses are covered in plastic! The bathrooms would be ok if they were clean. But they are not. The kitchen is a disaster. Greasy, dirty and old food in the pots and pans. The fridges are complete chaos. I only dared leaving a beer in there - and it got stolen! Security is a joke. No lockers or anything and anyone with the code for the front door - which means anyone having been at the hostel at some time - can enter.

"Better to sleep on the streets, I did!"

I have backpacked around the middle east and been in some pretty dire places. but nothing like this! I was a late arrival at 23:30 so I phoned ahead at about 21:00 and made arrangements. I was given the door code by text and told my room number, every thing can get sorted in the morning. On arrival the code On arrival the code did not work and I was locked out. some passing police officers tried to help me out and eventually a guest came and opened the door. He seemed as bewildered by the door as me, so the gust showed me to where room 2 was (my room). On the way there the only staff member i met appeared, an elderly man who had obviously gotten out of bed. I said "Hello!" in a friendly manner and he stared shouting at me for waking him up and breaking the door. After he stormed off, I found my own way to room 2 having had no success at getting useful information from the unpleasant old man. The room was what I would call a "Boxroom" big enough for 1 bed comfortably, this was not however what was in the room. The room had 2 bunk beds jammed in to it, to the point of being difficult to climb one with out banging against the other. This was the least of the issues though. The rooms floor was one inch to three inches deep in filth, food packaging, tissues and bear bottles as well as the standard non-scripted dirt one would expect in a crack den, and that is exactly what this seemed to be. There was three bodies in the room already, by the look and smell of them they had not washed (Ever) and been drinking a lot of alcohol. Non or the beds had linen or sheets.

I closed the door and left never to return. NEVER EVER STAY HERE! **Room Tip:** Look out for the needles.

"Consider sleeping in the streets instead of here"

Reviewed 19 August 2015

I think the only other hostel that comes close to this experience was a windowless, box-like backpackers hostel in Kuala Lumpur. Highlander Hostel has the guts to charge about ten times that amount, offers terrible and rude service, and provides absolutely nothing of value. To be a bit more specific, here are some more graphic details :))))))

Everything is worn down and dirt. The overall easthetic impression is that the

building could have been something like a squatters apartment, drug den, brothel, or simply a combination of all.

Me and my boyfriend were placed in a 8 bed dorm, despite having booked a 4 bed room.

Rooms and toilets were not clean, with used band aids in the hand wash, dust and hair everywhere, no garbage bin, and plastic-wrapped mattresses. (These are to battle bed bugs)

Wifi worked for brief moments, about 5 minutes at a time.

Cash was the only option for paying. The man working in the "reception" was incredibly rude, complaining, using curse words, mocking my name (???!?!!?), and told that we had to make the beds ourselves. We suspected that he was a former prison guard of some sort.

Beds were squeaky and unstable, there was pigeon droppings in the window sill, and we did not even bother to use the kitchen. Instead we went up at 6 am, packed our stuff and left to never again return.

Room Tip: Leave while you still can

"Terrible, disgusting and worst service ever"

Reviewed 18 August 2015

We were shocked when we entered this hostel. It's dirty, it's run down, the staff is helpful nor friendly. Our group came to stay one night. After we arrived we tried our best to find another hostel or hotel in town, we were even prepared to accept the loss of the money we had already paid for this place (there no refund for obvious reasons). As everything else was fully booked we had no choice but to stay. The next morning we left at 6.30am as soon as we could. Unfortunately, we were in such a haste to leave that one of us forgot his camera under the bed. We discovered this while we were boarding our flight back home. He called the hostel about 10 times to ask whether it had been found and to arrange for someone to pick it up. They did NOT answer his questions and did not offer any help, told him to call back several times without result and thus proved what we already knew from the first moment: this is the most disgusting, terrible hostel and worst service you can imagine.

"Disgusting!! Stay away!!"

I wish there was a way to give this place no stars. 1 star is giving them too much credit. The place is filthy, the beds are squeaky and broken. Don't visit the showers, you'll probably catch leprosy. I don't know how or why I stayed 2 nights. STAY AWAY!! The place is dodgy.

"This is the worst European hostel I have ever stayed in!"

The hostel was disgusting! Smelled of smoke every where, which is an achievement considering smoking is illegal within all public buildings in the UK. Everything is dirty. Staff unhelpful and disinterested, with the added bonus of knowing nothing-couldn't even give me a taxi number to get me to the airport!

"Terrible hostel ever"

This hostel is a worn out hostel! It's dirty and greasy. The beds are terrible - noisy and the mattresses is covered with plastic and you feel every single spring in it. We decided not to use the kitchen for foodmaking since it was unbeliveable messy and greasy. We would not even dare to put food in the fridge! The.doors are making a lot of noise making it hard to sleep. One of the showers was okay the other wasen't. The common room is not at all cosy and nice. The television is central placed and very loud and when it's closed the employes plays very loud music while they're playing billiard. It seems like they are trying to start up a party. I was shocked when we saw this hostel and when I told the reception boy that this is a very worn out hostel he replied that they had never had complains. I doubt...

"It was immoral how gross this place was"

Stay far away from here, the one 'good' thing might be the location but considering the size of Inverness everything is really close to the city centre/train station anyways. Plus being located on high street made for a really noisy room especially since the windows don't close and there's clubs metres away from this place. The beds were these cheap.plastic sacks and you have to put on your own bedsheets. The whole place reeked and everything was covered in grime, the bathrooms were to gross to use. The staff made me feel very uncomfortable and keep starring. Wifi wasn't sufficient to load emails. It was just a terrible place, I read the reviews and I knew it would be bad but I had no choice because there was no where else that had vacancies left. Having no option but to pay 20 pounds for a bed to sleep on was the worst rip off of my entire trip to Europe..

"Enough mould to grow cheese. More derelict than a warzone."

Reviewed 20 July 2015

I am very surprised to find reviews giving this place more than three stars. I would not be surprised if that were the management creating accounts to try and get better ratings. After a full 7 days of camping around the Isle of Skye, my friend and I were really looking forward to spending a night between four walls and a ceiling before taking an early plane back home.

But to our surprise, we did not get into a hostel. Our first thought was that we arrived on a construction site. Things are messy, there were ladders and buckets around, dust as well. Maybe we got the wrong address? Turns out we did get to the proper location. It was just a mess.

We talked to the receptionist who was definitely not unfriendly. But I would definitely not call him professional. Especially as he found my name a bit difficult to pronounce (despite me telling him it was as easy as "Teebo"), he decided he'd call me by half of my last name instead, even when I said I'd rather not be called that. Great.

I try to put this past me as we head to our room, but it is quite difficult to forget the first sight of the room. It felt like we were in a very poor country in a war zone. The bunk bed frames, of cheap manufacture to begin with, were definitely second if not third hand, given the amount of disrepair they were in. I can understand a bit of wobbliness, but when two out of 4 screws are missing on a ladder, and that ladder is thus unstable and swinging around as you try to climb it, it is pretty unsafe, and proves a great lack of care for the main thing a hostel provides: beds.

Again, I try to put this past me, but then I see the window. It has a curtain rack, and approximately 10-15 gliders. However, only 2 slats of the blinds were left (instead of 10-15), which makes calling this whole thing "curtains" a joke. Again, showing a great lack of care.

What I found was enough mould to make your own cheese overnight. So many black and blue spots growing all around... Disgusting.

Also, I cannot be sure for certain, but given the smell of the walls of the bedroom itself, I'm pretty sure they are mouldy as well.

Anyway. We try to spend the night in this "hostel", which proved to be difficult given the poor quality of the old, plastic-feeling, spring mattresses they use (on top of noisy roommates, but that's not something that can be controlled by the hostel), and the noise throughout the hostel which you can easily hear thanks to paper-thing walls!

After managing 3-4 hours of rest (it's fairer to call it rest instead of sleep), we decide to leave early for we need to get to the airport early anyway. I get my luggage out of under the beds (where I had put them), and notice what a big mistake that had been: the amount of dust that was on them easily put to shame the past week I had. I had managed to keep my rucksack somewhat cleanish during a rainy, muddy, swampy week on Skye, but it all got ruined by putting it under those beds.

I am not difficult. I've stayed in very cheap places with cheap everything. But I cannot comprehend how in such a country, any decent and honest human being can own this hostel and think "Yes, the state of this hostel is great. There's absolutely no need to give attention to anything specific, and I am happy to charge people for providing a great service".

This derelict, dirty, mouldy, uncomfortable, noisy, broken and neglected hostel is NOT the place where you want to spend even £15 for a night, even after a full night of camping. Actually, camping is probably a far better option than spending the night in such a place.

Oh and, would you expect them to accept debit or credit cards? Of course they don't.

Whatever excuse they have for this, I am not inclined to believe a word of it.

All in all, I would be very happy to call this place a scam.

"Glad i use trip advisor."

"Unless desperate, just don't"

You get roll to take to your room so you can put on your own sheets and put a pillow case on a pint sized of cotton fluff they call a pillow here, the blanket case for a make shift blanket. This all screams that they don't seem to like to clean their rooms much or have a lazy way about it. None the less I didn't care too much about this.

Next up while you attempt to sleep you will be serenaded till 2 or 3 am by the karaoke at the bar down the road as you will hear them as plain as day as well and whomever may be walking down the the street at that time. Stayed here as it was located centrally and we were attending a concert nearby. First impressions were fine, though after finding our way to our room (which due to the size of our group was a private room) we discovered that our beds still had previous residents linen on them and the room was covered in take away containers and general rubbish. The final straw for me was when she took me to my room and showed me the lock on the inside of the door and said 'When (not if, WHEN!!!) there are fights in the corridor you can just lock the door, but then again that means your locked in with the druggies in your room'. She left me too it and I left rather hastily.

I walked to the next hostel, Bazpackers. Where the staff were friendly and I shared a room with a nice guy who wasn't going to stab me. It was then that i noticed I had had my camera stolen during my 5 minutes at Highlanders. The only time I left my pack alone was in my 30 second walk to see the laundry when my pack was left in the reception.

We found a hostel 5 minutes up the road for less than the Highlander and much cleaner. From what we saw of the kitchen and reception area it was filthy, in need of a good clean. The floor looked like it hadn't been washed for years. Luckily we had only paid a £12 deposit and not the full amount before arrival.

"Disgustful!"

We stayed here in october after we had finished the Great Glen Way. It's the worst hostel I have ever been to! Rooms and showers were dirty (not to speak of the kitchen!), toilet seats broken, the locks on the bedroom doors didn't catch, light

bulps didn't work, the towels we hired @2GBP had large holes in them.. I guess when an accommodation has mattresses which are wipeable it says it all!

"Beyond a joke"

Reviewed 8 September 2013

The reception staff are abrupt and rude. Though I was told my card had been declined actually the card machine didn't work. The lock on the door to the bedroom didn't catch. The room was rammed with cheap bunk beds and an extra mattress on the floor for good measure. The duvet and pillows stank. Loud music and voices hammered through a thin wall. I was charged £2 for towel hire, and £2,50 for laundry and then told to do it myself but that I couldn't use it till after 9pm. When I did finally get to use it, the machine broke leaving my things floating about in filthy water. When I told the receptionist he looked at me as if I was stupid and said, "Just ring it out, it's washed isn't it?" (It should be noted he was in charge of doing the hostels washing). All the computers were broken. There was no hot water for a shower in the morning. The large, filth common room was completely miserable.

Arguably this place is in the so bad it's good category of thing. If you're like the masochist Bill Murray plays in Little Shop of Horrors, and deliberately want to stay in the worst Hostel ever then this place is quite entertaining.

"Awful"

Reviewed 24 August 2013

Arriving in Inverness, I found all B&Bs seemed to be fully booked, so I went to this hostel. There were beds available, so I booked 2 nights @ £20 per night. I was handed a bundle of linen to make my bed and told which room I was in and the combination of the lock on the door (I didn't need it, as the door opened if you just pushed it). The room contained 5 or 6 bunk beds with rather worn mattresses and duvets.

Of the 3 washrooms on the floor, the taps produced only cold water, only one had a sink plug, in another the shower fitting was broken and in the third the toilet had its seat and lid broken off. Worst of all, there was no toilet paper! (There was in one on the second evening, but it was soon used up. Fortunately I had my own, being prepared for camping.) I had to pay an extra £2 for hire of a towel and £2 for breakfast. I had to move rooms for the second night. Both rooms were of mixed sexes.

The large common room was fairly conducive to social activity, with 2 pool tables and a selection of board games and books. There were kitchen facilities to store and prepare your own food. The staff were adequately helpful.

I suppose the hostel's best feature is its centrality, being close to the bus and rail stations, tourist information centre, shops, etc. Try to avoid this place if possible, but if you must go there, be sure to take your own loo roll!

"Very poor"

Reviewed 17 August 2013

I was taking a group of foreign tourists around Scotland, and wanted cheap accommodation whilst they stayed in a local B'n'B (very good). This place was rubbish. Really. I booked a place in a 3-person dorm via hostelbookers about five days before I turned up. When I got there:

- we have no notice of your stay.

- 'Can you show a print off?' I said I didn't have one. So they said go online and show the booking (fair enough). After 5 minutes of trying to get online while they dealt with another person I said I couldn't get online. They then gave me another internet connection and told the next guest their internet was off.

- I showed them the booking. They said they had no space there. Not even that they had given it away by mistake; they had no space and i could take a place left in the 8-bed dorm. I saved 2 pounds. Wooh.

I went up and there was no pillow. i came back down and told them. After a sarcastic joke that they didn't have pillows they sighed and went to get one.
It is right above a karaoke bar. Great.

I had no problem with the guests, but The Highlander Hostel is a perfect example of how the word 'backpacker' is used by hostels that don't care. As a Scottish person I felt it was a miserable example of accommodation in my own country.

"Horrible"

Decision

I allow the appeal and grant planning permission for a change of use to a House in Multiple Occupation with ancillary use as a Hostel, subject to the 6 conditions listed at the end of the decision notice. Attention is drawn to the 3 advisory notes at the end of the notice.

Reasoning

1. I am required to determine this appeal in accordance with the development plan, unless material considerations indicate otherwise. Having regard to the provisions of the development plan the main issue in this appeal is the effect of the proposed change of use on residential and business amenity in the High Street by reason of noise and disturbance.

2. I have a duty under section 14(2) of the Planning (Listed Buildings and Conservation Areas)(Scotland) Act 1997 to have special regard to the desirability of preserving the listed building or its setting or any features of special architectural and historic interest which it possesses.

3. Adopted Policy HMO2 - HMO provision within Inverness City Centre - in the council's Houses in Multiple Occupation Supplementary Guidance (which includes policy 33 of the Highland-wide Local Development Plan) requires planning applications to be assessed against policy HMO3. To ensure that HMO provision does not have an adverse effect on the character and amenity of the city centre, the policy also requires the guideline to be reviewed if the concentration of HMO properties reaches 10% of all residential units in the city centre. Policy HMO3 - Assessing HMO Proposals - is the most relevant policy in this case, and sets out a range of criteria with which such proposals have to comply.



4. The appellant's property is a Category B listed, 4 storey former town house with shops on the ground floor that lies on the north side of High Street in Inverness City Centre. Access to the accommodation on the upper floors is through an archway that leads to pedestrianized Lombard Street to the rear where commercial uses on the west side face flats above shops opposite. Some of these flats gain access via a staircase (Stair 2) which also provides a fire escape for others, as well as a right of fire escape from the 1st Floor of the appellant's property.

5. The main entrance is on the west side of the archway where a hallway opens onto a grand staircase (Stair 1) that rises to the 2^{nd} floor with a more basic stair up to the 3^{rd} Floor. A new bin store for wheelie bins and recycling materials is to be formed at Ground Floor level in a fire-proofed cupboard under the main stair. The 1^{st} Floor would have a reception area, a common room, kitchen, laundry, a 4 person room with separate shower-room and a small office, with access through to the Stair 2 fire escape from above and to below. The 2^{nd} floor would have 2 x 4 person rooms (one with ensuite shower room), 2 x 3 persons rooms (one with ensuite shower room) at 1 x 2 person room, together with 3 x shower/WCs and a separate shower, plus access through to the Stair 2 fire escape. The 3^{rd} floor would have 2 x 3 person room and 3 x 1 person rooms with 3 showers and 2 WCs and access to the Stair 2 fire escape. The application plan shows that these rooms would provide accommodation for up to 31 persons.

6. During my site inspection, which I carried out with the council's representative and appellant, it was apparent that he was in the process of carrying out extensive improvements to the rooms and facilities. The original layout of the building has been largely retained with few alterations, except where necessary to provide WCs and showers. Where rooms had previously been used as hostel bedrooms using bunk beds, they are now being prepared for fewer occupants as defined in paragraph 5 above. The new kitchen and laundry facilities on the 1st Floor should be more than adequate to serve the residents, while the common room would provide a useful communal amenity space for them to enjoy.

7. As far as I was able to ascertain, as a result of this work, the interior of the listed building would be restored but largely unchanged, while the lack of any external alterations would ensure that the building, its setting or any features of special architectural or historic interest which it possesses would be preserved.

Main issue

8. As a building providing a primary home for 6 or more unrelated people, the appellant's property would meet the definition of a HMO in the supplementary guidance. In the report of handling, the council accept that the concentration of HMOs in this Census Output Area, including the appeal premises, would amount to 6.9% of all the residential units in the city centre, which falls well within the recommended 10% threshold set out in policy HMO2. Although this suggests that there remains some capacity for this type of use, each application has still to be assessed on its own merits under policy HMO3. Paragraph 2.16 of the supplementary guidance states that there are also 3 Specialist HMOs for the homeless in the city centre contracted to the council and 1 used when required, but the appeal premises do not fall into that category.



9. The bunk beds I saw suggest that, when it was used as a hostel, many more people were in occupation in a more transient and difficult to control manner. Policy HMO3 will only support applications where it would avoid negative impact to traffic or pedestrian safety; it is close to public transport, social and community facilities; it will avoid negative impact on residential or business amenity, particularly with regard to noise and disturbance, and must provide refuse storage, garden ground and car or cycle parking and it will avoid materially altering the character of the area.

10. Although the property has previously been licensed as a HMO, which the council does not dispute, it has now to meet the policy criteria. Of these, the building lies on the principal pedestrianized shopping street in the City Centre where there is unlikely to be any conflict with traffic or pedestrian safety, while the report of handling accepts that in such a location parking provision would not be required. It lies in close proximity to public transport connections by bus and train, and social and community facilities are close by. Although there has been trouble in the past with noise and disturbance and inadequate refuse storage, the appellant would appear to have that under control with fewer residents in the new layout. There is no communal outdoor amenity space for the occupants to enjoy, but all the city's facilities and riverside are readily available. While there is no car or cycle parking available for residents and visitors, city centre car parks are nearby.

11. The principal objection revolves around the behaviour of the residents both in terms of business and residential amenity, particularly for those who live in the adjoining flats. In the past, hostel tenants appeared to have had a very casual attitude towards their neighbours and complaints about unsocial behaviour were common. In addition, hostel refuse was being stored under Stair 2, which does not belong to the appellant, where it regularly caused a nuisance through lack of proper storage which led to unpleasant odours and rubbish being spread out onto Lombard Street.

12. With this history, it is hardly surprising that the neighbours, both in business and residential accommodation, have serious reservations over the proposed use as a HMO. They are concerned about their amenity, safety and the public image of Inverness that relies on tourism as a major source of revenue.

13. To answer these concerns, the appellant is carrying out extensive works restoring the premises to attract a better class of tenant, and the quality of accommodation is being raised to a standard that most occupiers would find both attractive and convenient. Even though HMO accommodation is likely to be medium term while the residents seek more permanent places to live, each room would be their primary home, so the tenancies are likely to be longer than would be expected in a hostel that attracts more transient visitors.

14. I therefore take the view that, with number of persons limited to the 31 applied for, living in newly decorated rooms with updated kitchen, laundry and communal facilities, shower rooms and WCs, future tenants are more likely to form a greater attachment to their rooms and treat them with greater respect, particularly as the appellant intends to have a member of staff in residence. This should result in far fewer instances of noise and disturbance within the premises while proper control of the storage and collection of refuse should also remove the previous nuisance from scattered rubbish and odour.



15. Notwithstanding their previous use as a HMO, the application seeks a change of use presumably to place the premises on a sound planning footing. However, bearing in mind the concerns of local residents and businesses over the previous hostel use, and the number of bunk beds I saw in the rooms during my inspection, I share their concern that this ancillary use might revert to a full time hostel with a larger number of temporary residents and a return to the previous problems. For that reason, because the application is for a maximum of 31 persons in 12 rooms, I find it both necessary and reasonable to impose a condition that this number shall not be exceeded.

16. I therefore conclude that, subject to the conditions to be imposed, the proposed change of use would result in a considerable improvement in residential and business amenity in the High Street by reason of noise, disturbance and refuse storage.

Material considerations

17. Most of the points raised in submissions have been covered in this decision, so the previous problems experienced by the neighbours should now be addressed. I accept the Crown and City Centre Community Council's point that a single HMO can provide accommodation for many bed spaces, so the threshold percentage does not give a clear indication of the number of residential units involved. However, the council points out that the current policy counts the number of HMO households which is the standard used to measure the total number of HMOs with each census output area of the city, and that the application meets the policy criteria.

18. There has clearly been a problem with anti-social behaviour in and around this building in the past but, while I am satisfied that the appellant's current improvements should lead to an improvement in this regard, anti-social behaviour is not a planning matter and is the subject of other legislation. Similarly, the issue of a HMO Licence is separate from the grant of planning permission, although both are likely to be required for a development of this size.

Conditions

19. The council have suggested 4 conditions, should this appeal be allowed, to which the appellant has raised no objection, and I accept subject to minor amendments. These conditions will ensure that management and maintenance procedures and a Waste Management Plan are in place prior to occupation of the HMO, that adequate off-street storage for refuse is provided within premises, and not within adjoining Stair 2 which can only be used as a fire escape, and that refuse shall be placed outside only on the day of collection. In addition to these, I shall impose the condition, referred to in paragraph 15 above, to ensure that the approved number of 31 persons shall not be exceeded.

20. The council also requested that consideration be given to imposing a condition that limits the use of the HMO to avoid its simultaneous use as a hostel but, in the absence of any specific definition as to when such a use would prevail, such a condition would be insufficiently precise and enforceable to accord with the tests in Circular 4/1998. In any event, with proper supervision by staff and the limit on the number of persons residing on the premises, whether they are longer term HMO or short term Hostel tenants should not be relevant.



Conclusion

21. My overall conclusion is that, in the light of the history of use of the property as a HMO, the alterations being carried out to the premises and the reduction in the number of residents would result in a major improvement in nearby residential and business amenity and, thereby, to the image of Inverness City as a whole.

22. I therefore conclude, for the reasons set out above, that the proposed development accords overall with the relevant provisions of the development plan and that there are no material considerations which would still justify refusing to grant planning permission. I have considered all the other matters raised, but there are none which would lead me to alter my conclusions.

Conditions

 The maximum number of persons residing in the House in Multiple Occupation (HMO), hereby permitted, shall not exceed 31 persons in the 12 rooms shown on application Drg No: 2015/GSA2/01.B.

Reason: To control the number of residents occupying the premises at any time.

2. There shall be no occupation of the HMO until the management and maintenance procedures that are agreed with the Licensing Authority for this HMO have been submitted to and approved by the Planning Authority. Thereafter all management and maintenance procedures agreed to in this document shall be adhered to at all times.

Reason: In the interests of protecting the amenity of neighbouring properties.

3. There shall be no occupation of the HMO until a copy of the contract of the services referred to in the Waste Management Plan, submitted to the Council on 26 November 2015, has been submitted to and approved by the Planning Authority. The approved Waste Management Plan shall thereafter be adhered to at all times.

Reason: To ensure that waste is properly managed in the interests of residential amenity.

4. Before the HMO, hereby permitted, is brought into use, a scheme providing for adequate off-street storage and management of refuse shall be submitted to and



approved by the Local Planning Authority. Thereafter, all refuse and recyclable materials associated with the development, hereby permitted, shall be stored within the approved bin store located on the ground floor under Stair 1 as identified on the Ground Floor Plan on application Drg No: 2015/GSA2/01.B

Reason: In the interests of residential amenity.

5. No refuse or recycling material shall be stored or placed for collection on the public highway or pavement, except on the day of collection.

Reason: In the interests of residential amenity.

6. For the avoidance of doubt, Stair 2 shall be used only as an emergency fire escape from the HMO, hereby permitted, and for no other purpose. No waste or refuse containers associated with the development shall be stored around or within the bin store located under Stair 2.

Reason: To protect the amenity of adjoining premises and residents.

Advisory notes

1. **The length of the permission:** This planning permission will lapse on the expiration of a period of three years from the date of this decision notice, unless the development has been started within that period (See section 58(1) of the Town and Country Planning (Scotland) Act 1997 (as amended)).

2. **Notice of the start of development:** The person carrying out the development must give advance notice in writing to the planning authority of the date when it is intended to start. Failure to do so is a breach of planning control. It could result in the planning authority taking enforcement action (See sections 27A and 123(1) of the Town and Country Planning (Scotland) Act 1997 (as amended)).

3. **Notice of the completion of the development:** As soon as possible after it is finished, the person who completed the development must write to the planning authority to confirm the position.
