Thank you for your letter of 11th July responding to my submissions on behalf of . I note all that you say.

We would like to submit some further responses in light of the Final Report on the closure of Dalwhinnie Primary School.

At **1.5** it is stated that "In the coming session, it is anticipated that all the children from the Dalwhinnie catchment will attend Newtonmore School". In fact, the Dalwhinnie child who might have been moving from Gergask to Newtonmore has instead opted to remain at Gergask. I am not suggesting that the statement in the report was inaccurate at the time of writing, I am simply stating it as fact today. This of course also casts a different light on **5.16**, **Response 30** that moving the catchment to Newtonmore "seems to be the firm preference of parents in Dalwhinnie", as well as the assertion in **10.2** that "Newtonmore Primary seems to be the preferred option for parents from the Dalwhinnie catchment'. I trust the report will be updated to reflect reality.

- At **5.15**, **Response 29**, we would absolutely dispute the view "that the larger pupil numbers at Newtonmore Primary offer more opportunities for pupils to be part of age appropriate peer groups." It cannot be disputed that the way in which Gergask pupils do activities together as a whole school has enormous benefits for the social development of all of the children. It is also true that when they get to high school, pupils who went to Gergask are extremely well represented in prize giving and achievements.
- At **5.17**, **Response 32** it is not at all clear what view the Highland Council is agreeing with. Nowhere has it been suggested that if the catchment is moved to either school pupils will "[have] to move" anywhere. Presumably, parents will still have the right to choose which school to send their children to.

On behalf of the and of the wider community I write to stress our continued support for our communities opposition to the perceived suggestion that the catchment area for Dalwhinnie Primary School should be changed to Newtonmore, rather than to the catchment area of Gergask Primary School

The reasons are unchanged and as fervently believed as in

letter of 7th March.

- 1) Dalwhinnie is closer to Laggan than Newtonmore, less travel time is less cost to Highland Council for school transport. Over the next 10 years of disruption with the dualling of the A9, it will be less disruptive and safer for the school transport to travel to Gergask rather than Newtonmore.
- 2) Gergask Primary is already clustered with Kingussie Primary giving many opportunities for peer group interaction and extra curricular activities. Gergask Primary pupils also join with Newtonmore regularly for events such as shinty practice.
- 3) Your report totally ignores the benefits for children attending a small rural school.
