# 2. PROGRAMME MANAGER UPDATE – PROGRESS REPORT

ES quarterly update report was distributed to everyone in advance of the meeting, and some verbal updates were discussed.

### Key Points:

- Offshore wind SSE progress with Beatrice Offshore Windfarm planning application submitted for O&M base at Wick harbour. First O&M jobs advertised by SSE. CNSRP Delivery Group priority is to work with SSE/ BOWL to understand recruitment timescales and to ensure jobs can be filled/ based in Wick. Also need to understand supply chain requirements. SSE staff were due to attend the meeting, but will return later in November for discussions.
- Meygen project progress good to see Scrabster harbour's role in the project, along with JGC Engineering. Again, key priority will be to understand the O&M plans of Atlantis Resources.
- NDA Archive D Flear confirmed keys for the facility had been handed over today (09/11/16) to the commercial operator, and that the facility remained on track to open in January 2017. Staff recruitment has also been completed. Work has also now commenced on the carparking space that will be shared between the NDA Archive and Wick John O'Groats airport.

#### Scrabster Harbour Trust

Cllr Farlow highlighted ongoing issues relating to the forestry industry around Strathhalladale, and the impact on roads infrastructure.

#### Highlands and Islands Enterprise

RK reported continuing growth from local companies account-managed by HIE. He also highlighted the Enterprise & Skills review being undertaken by Scottish Government. Outcomes are expected in the Autumn.

#### Scottish Natural Heritage

John Henderson has stepped down as Chair of the Peatlands Partnership, with Stuart Gibb taking on the role.

#### Skills Development Scotland

RB highlighted the Oil & Gas related Transition Training Fund as an opportunity to support personnel moving out of oil & gas into other sectors.
