Recommendation

1. BACKGROUND

- 1.1 To inform the Planning Applications Committee of the submission of the attached Proposal of Application Notice (PAN).
- 1.2 The submission of the PAN accords with the provisions of the Planning etc. (Scotland) Act 2006 and was lodged on 11 May 2017. Members are asked to note this may form the basis of a subsequent planning application.
- 1.3 The applicant had been advised to submit this proposal of application notice as the applicant has materially changed their proposal from the previously submitted Proposal of Application Notice which was reported to South Planning Applications Committee on 17 January 2017. At that time members highlighted the following material planning considerations to be brought to the applicant's attention:

clarification on how much of the site was still available for mixed use given that this development was proposing to comprise solely residential units, together with the other material considerations identified in the report.

2. DESCRIPTION OF PROPOSED DEVELOPMENT

2.1 Based upon the information provided, the development is likely to comprise of residential development, affordable housing, community and commercial uses with associated landscaping, parking and infrastructure.

3. SITE DESCRIPTION

- 3.1 The site lies approximately 3.3km to the south of Inverness City Centre. The site extends to approximately 2.2 hectares. The proposed development would be located to the rear of ASDA between the Southern Distributor Road and the B861. The Slackbuie District Centre is located to the north of the site.
- 3.2 It is anticipated that there will be opportunity for access to the site from the B861. Pedestrian access to the site will be via the same routes and the core path which runs through the site.
- 3.3 There are a number of sites designated for natural heritage interests in the wider area but unlikely to be directly affected by the development.
- 3.4 There are no scheduled monuments within the site. There are a number of listed buildings and archaeological records, identified within the Highland Historic

Environment Record, which exist in proximity to the site.

- 3.5 The site is not within the indicative 1 in 200 year flood risk mapping produced by Scottish Environment Protection Agency.
- 3.6 The site is not located within any international or regional landscape designations.
