Report title: Review of Polling Districts and Polling Places 2018

Report by: The Chief Executive

Purpose/Executive Summary

The Electoral Administration Act 2006 introduced a duty on all local authorities to review their UK Parliamentary Polling Districts and Polling Places at least once every four years. The last compulsory review took place in 2013-14. The Electoral Registration and Administration Act 2013 introduced a new provision altering the timing of compulsory reviews. In terms of the 2013 Act the compulsory review periods are the period of 16 months beginning with 1 October 2013 and the period of 16 months beginning with 1 October of every fifth year after that. The next compulsory review is therefore scheduled for October 2018. This report outlines the proposed timetable to undertake a preliminary review ahead of the statutory review. The purpose of the preliminary review is to ascertain stakeholders' views and opinions and, in particular, undertake comparison between the original polling scheme used last in 2015-16 with the revised Highland Council Scheme which was employed in both the Council and UK Parliamentary elections held this year.

Recommendation

Members are asked to:

- Agree the timetable for the review of polling districts and polling places.
- Provide any comments or feedback to inform future stages of the review.

1. Preliminary Review

1.1 In accordance with good practice and guidance provided by the Electoral Commission it is proposed to initiate a preliminary review ahead of next year's compulsory statutory review. This will have the benefit of having a longer period of consultation and will seek to identify and allow resolution of any potential issues ahead of the compulsory review. It is anticipated that such action will minimise objections and challenges to the subsequent review proposals.. The proposed timetable for this stage is outlined in 1.2.

1.3 Meetings with members have commenced to review the current scheme in each Ward. The outcome of the preliminary review will form the basis of the compulsory review outlined in 2.

2. Compulsory Review

2.1 The compulsory review period commences on 1 October 2018 and must be completed within a 16 month period. There is no minimum time frame for this review but it must follow certain stages. It is anticipated that the preliminary review will have dealt with many of the issues in advance of this stage.

2.3 On completion of stage 8 and following a final report to Highland Council the new scheme will be in place for all elections after that date.

3. Implications

3.1 At this stage there are no identified implications which require to be highlighted. The preliminary review process will highlight any access or financial implications and these will be reported to Committee early in 2018.
