2 Previous Minute and Matters Arising

The previous minute was agreed as a true and accurate record.

Funding in the 3rd sector – Elaine asked for feedback from the 3rd sector with regards to funding issues. Moira asked for it to be noted that we should be aware that this is not just about funding cuts but also about the overall availability of funding for the Violence Against Women agenda. Elaine asked members if they have any funding concerns for going forward this year. Women's Aid informed that this would be reported later in the meeting, as part of the update from the Safety Group, as this issue had been discussed earlier. Elaine asked for all to be cautious and make sure we are evidencing that we are getting the most out of the resources that we have and to ensure we are being cost effective. To be added to future agendas as a substantive item.

3 Prevention of Sexual Violence

Moira updated the group with regards to RASASH and the delivery of The Rape Crisis Scotland Prevention pack. RASASH has worked with over 2000 school children over the last year in delivering the pack. There has been a suggestion that other people deliver this training. Rape Crisis Scotland, who own the pack, have discussed this and would be content to use this model if there was a quality control process put in place about recruitment and how we ensure people are delivering a consistent message across the pack. There were two

options to do this; Option, seek to recruit trainers from across partner agencies, train them and ensure CPD in place to ensure the quality issue was addressed. For this to be done there would be a call on Melody's (who co-ordinates the training in schools) investment of time to make this work. All partners were contacted and asked for trainer nominees previously, however there was not a single nominee put forward for this. Option 2, was additional funding for Melody's post, if there was additional money, her post could be put back to a full time post and then be able to deliver more training to schools. Moira stated that 'The Gordon Cook foundation' had approached Ailsa recently to say that there was potentially money on the table for school prevention initiatives and organizations were invited to put in outlined proposals which RASASH have done and waiting to hear nearer the summer time what the outcome of this is.

Moira confirmed that Melody is still doing 3 days and if able to do 5 days this would scale up the numbers of the pack being delivered. Debbie asked if there was any potential for linking up with the Drugs and Alcohol Partnership to deliver both issues i.e. sexual prevention and drugs and alcohol awareness. This was discussed by the group and how we can deliver as a Highland Partnership 'Public Protection' banner. Discussion had taken place earlier that day at the Safer Highland meeting as the issue of the various agencies/organizations seeking an input within schools had been raised. Linda suggested that we could put a paper to Safer Highland to outline a proposal for a shared resource that would meet the needs of everyone and provide a sustainable option.

Gillian informed that she is aware of Ailsa Villegas is supporting the development of a health and wellbeing tool kit for schools with Christine Gordon who is a Quality Improvement Officer for education, so maybe we could look at what they are doing with that and try and build this in with what we need. Elaine asked the group how they felt about Linda's proposal to put a paper to 'Safer Highland', all agreed. Jacqueline agreed to speak to Bill Alexander who initiated the discussions at Safer Highland and Christine and feedback to the group on whether there is benefit in writing a formal paper to 'Safer Highland'.

Gillian continued discussion with regards to other work under prevention and noted that it was hoped that the issue with RASASH and capacity could be better addressed through this forum. A meeting was recently held on how to approach prevention more widely and in a more strategic way. Gillian suggested that we establish a short term Prevention Sub Group that could look at how we have a better approach to prevention with regards to the partnership, all in agreement to this.

5 2013-16 Highland VAWP Action Plan Achievements	Action

6 2017-20 VAWP Action Plan	Action
Gillian had prepared some suggested activities for the VAW Action Plan for 2017-20 and had aligned these with our suggested priorities. Previous papers in relation to staff views, training and sexual violence had been sent to the group for views. These papers, along with issues in relation to improving safety and prevention had been developed to highlight 5 areas for us to work on over 2017-20. The meeting broke into smaller groups to discuss the suggested activities to see if we agreed that this was the sorts of things we need to progress over the next three years. Some amendments were suggested and written feedback was given to Gillian to include in the draft plan. The group was asked to agree the framework of the plan. Debbie told the group about the framework the Alcohol & Drugs Partnership were using and it was suggested that a similar model be used for VAW. It was noted that in particular Partnership working was not a key area for improvement, but rather it was integral to our success and required to be a thread running through the entire plan. No conclusion was made in relation to the framework and it was agreed that Gillian would work with Kate and Moira to develop this and circulate to the group.	GGu/ KB/MP All
