## **BUSINESS**

# 1. Apologies

In accordance with the Appeals Procedure, Mr D Goldie, Head of Housing and Building Maintenance, presented the Management Side case and during questioning, at the agreement by all parties, the hearing was adjourned at 11.25 am and resumed at 11.25 am to allow additional evidence to be presented.

On resuming the meeting (at 11.25 am), there was a further adjournment at 11.30 am to allow the additional evidence tabled to be considered. The hearing was then resumed at 11.45 am and during the continuation of the presentation of the Management Case two witnesses were called and heard. Thereafter, Mr P MacPherson presented the Appellant's Side case to the Committee during which one witness was called.

Following questioning and after the Management Side and the Appellant's Side had summed up their respective cases, both parties withdrew to allow the Committee to deliberate in private.

The meeting was adjourned at 12.50 pm and resumed at 1.30 pm.

Having given careful consideration to the various issues raised, the Committee **AGREED** that the grounds of the appeal had not been substantiated and the appeal be not upheld.
