## 3. Confirmation of minutes Dearbhadh a' Gheàrr-chunntais

There had been submitted for confirmation as a correct record the minute of meeting of the Committee held on 5 December 2017 which was **APPROVED**.

# 4. Licences granted under delegated powers Ceadachdan a bhuilicheadh fo ùghdarras air a thiomnadh

There had been circulated Report No HLC/001/18 by the Principal Solicitor which detailed all Licences which had been granted under delegated powers under the Civic Government (Scotland) Act 1982 in the period from 23 November 2017 to 12 December 2017.

(b) a future meeting of the Committee when the applications will be determined in terms of the Hearings Procedure.

## 6. Response to Scottish Government consultation on guidance on licensing of sexual entertainment venues and changes to licensing of theatres Freagairt do cho-chomhairle Riaghaltas na h-Alba mu stiùireadh air ceadachd airson aitreabhan cur-seachad cleamhnasach agus atharrachaidhean do cheadachd thaighean-cluiche

There had been circulated Report No HLC/003/18 by the Principal Solicitor inviting the Committee to consider the draft guidance produced by Scottish Government on the licensing of sexual entertainment venues and changes to licensing of theatres, to approve the attached draft consultation response, and to reconsider arrangements for the licensing of premises used for the performance of plays.

In response to a question, the Principal Solicitor advised that if the Committee ultimately resolved to licence sexual entertainment then a premises that sold alcohol and offered sexual entertainment on 4 or more separate occasions within any 12 month period would require both a liquor licence and a sexual entertainment licence under the separate licensing regimes.

Thereafter, the Committee **APPROVED**:- (1) the draft consultation response at Appendix 2 of the Report and (2) the arrangements for the licensing of premises used for the performance of plays.
