Report title:	Application for the grant of a taxi driver's licence – Anwar Chowdhury (Ward 14 – Inverness Central)

- 1. Purpose/Executive Summary
- **1.1** This report relates to an application for the grant of a taxi driver's licence.

This item is subject to a formal hearing procedure

2. Recommendation

2.1 Members are asked to determine the application in accordance with the hearings procedure.

3. Background

3.1 The Highland Council has resolved that in terms of the Act a licence will be required for the driving of a taxi. A licence for the same is issued by the Highland Council and is valid for the whole Council area.

4. Application

- 4.1 Mr Anwar Chowdhury applied for the grant of a taxi driver's licence on 12 May 2017.
- **4.2** The application was circulated to both Police Scotland and the Council's Trading Standards Service.
- **4.3** There have been no objections received in relation to the application.
- **4.4** In terms of the abovementioned Act the Licensing Authority have nine months from receipt of the application to determine the same, therefore this application must be determined by 11 February 2018. Failure to determine the application by this time would result in the application being subject of a `deemed grant' which means that a licence would require to be issued to Mr Chowdhury for a period of 1 year. The application is before this Committee as this is the last meeting before the determination date expires.

5. Taxi driver's knowledge test

- **5.1** The Council's policy in respect of taxi driver's knowledge test states that an applicant is permitted a maximum of three attempts. Should they fail all three attempts the application requires to be referred to the Highland Licensing Committee for consideration. The pass mark for each of the two sections is 85%.
- 5.2 Mr Chowdhury has sat the test twice, the results of which are detailed below:
 - 1st Attempt Highland Area Pass 87% Local Area – Fail 60%
 - 2nd Attempt Local Area Fail 65%

6. Determining issues

- 6.1 Paragraph 5(3) of Schedule 1 of the Civic Government (Scotland) Act 1982 states that a licensing authority may refuse an application to grant or renew a licence where:
 - (a) the applicant or anyone else detailed on the application is not a fit and proper person;
 - (b) the activity would be carried out by a person other than the applicant who, if he had made the application himself, would have been refused;
 - (c) where the licence applied for relates to an activity consisting of or including the use of premises or a vehicle or vessel, those premises are not or, as the case may be, that vehicle or vessel is not suitable or convenient for the conduct of the activity having regard to
 - (i) the location, character or condition of premises or the character or condition

of the vehicle or vessel,

- (ii) the nature and extent of the proposed activity,
- (iii) the kind of persons likely to be in the premises, vehicle or vessel,
- (iv) the possibility of undue public nuisance, or
- (v) public order or public safety; or
- (d) there is other good reason for refusing the application.

If required the Principal Solicitor – Regulatory Services will offer particular advice on the criteria relating to this particular application.

6.2 In addition, section 13(5) of the Act provides that a licensing authority may require an applicant for a taxi driver's licence to take a test of his knowledge of the area to which the licence is to relate, of the layout of roads in that area and such other matters relating to the operation of a taxi as the authority consider desirable, and the authority may refuse to grant a licence to a person who does not satisfy them that he has adequate knowledge of any of these matters.
