**Description:** Extension to wind farm - erection of nine 3mw tubines (installed

capacity of 27mw) and associated infrastructure works

**Ward:** 5 – Wester Ross, Strathpeffer and Lochalsh

#### 1.0 BACKGROUND

- 1.1 To inform the Planning Applications Committee of the submission of the attached Proposal of Application Notice (PAN).
- 1.2 The submission of the PAN accords with the provisions of the Planning etc. (Scotland) Act 2006 and was lodged on 13.02.2018. Members are asked to note this may form the basis of a subsequent planning application.
- 1.3 The submitted information attached includes:
  - Proposal of Application Notice
  - Site and Location Plan

#### 2.0 DESCRIPTION OF PROPOSED DEVELOPMENT

The proposal is for a 9 wind turbine wind farm that will effectively be an extension to the existing Lochluichart Wind Farm.

#### 3.0 SITE DESCRIPTION

- 3.1 The site is situated between Loch Glascarnoch and Loch Luichart, approximately 18km north-west of Dingwall. The site is grazing land for sheep and deer and comprises primarily wet modified bog and wet dwarf shrub heath. It is located on a landscape character type described as 'rounded hills' in the Ross and Cromarty Landscape Character Assessment (SNH, 1999) and immediately adjacent to the 'rugged mountain massif' landscape character type. The former is a landscape character that could be described as being open and exposed.
- 3.2 There are no statutory natural heritage designations on the site. However, the site is likely to support European Protected Species (EPS) namely otter, and possibly wildcat.
- There are three Special Protection Areas (SPA's) designated under the EC 'Wild Birds' Directive within the vicinity of the site. These are at Achanalt to the south-west, Beinn Dearg to the north-west and at Ben Wyvis to the east. The qualifying interest of the Achanalt Marshes SPA is its population of wood sandpiper, totalling some 3 breeding pairs or 50% of the British breeding population. The qualifying interest of the Beinn Dearg SPA and Ben Wyvis SPA is dotterel. Together these SPA's are home to around 5% of the British breeding population. In addition to the qualifying interests, the Beinn Dearg SPA and Ben Wyvis SPA support a number of other Annex 1 species, including one pair of golden eagles and golden plover respectively.
- There are a number of Areas of Great Landscape Value (AGLV) focussing on the nearby mountain ranges within the vicinity of the site, particularly the Beinn Dearg Fannich range directly to the west and Ben Wyvis to the east. The site is also close to two search areas for wild land (as identified in SNH's policy statement Wildness in Scotland's Countryside) and important

tourist routes to Wester Ross and Skye. The Wester Ross National Scenic Area lies 20km to the west. The site lies within the Ministry of Defence Tactical Training Area 14T.

3.5 The nearest settlement is the village of Lochluichart, approximately 2km to the south, and nearest residential properties to the proposed turbines is at Aultdearg, approximately 2km to the west, and Forest Hill, approximately 1.5km to the south-east.
