Application for the provisional grant of a premises licence under the Licensing (Scotland) Act 2005

## An Talla – Grab and Go Shop, Dochgarroch Locks, Dochgarroch, IV3 8DG

## Report by the Clerk to the Licensing Board

#### Summary

This report relates to an application for the provisional grant of a premises licence in respect of An Talla – Grab and Go Shop, Dochgarroch Locks, Dochgarroch, IV3 8DG.

## **1.0** Description of premises

1.1 The An Talla – Grab and Go Shop is situated at Dochgarroch Locks and consists of a cruise ticket office and gift shop.

## 2.0 Operating hours

2.1 The applicant seeks the following **off-sale** hours:

## Off sales:

Monday to Sunday: 1000 hours to 2200 hours

#### 3.0 Background

3.1 On 1 February 2019 the Licensing Board received an application for the provisional grant of a premises licence from Jacobite Cruises Ltd.

The application was accompanied by the necessary section 50 certification in terms of Planning, together with a Disabled Access Statement.

- 3.2 The application was publicised during the period 18 February until 11 March 2019 and confirmation that the site notice was displayed has been received.
- 3.3 In accordance with standard procedure, Police Scotland, the Scottish Fire and Rescue Service and the Council's Community Services (Environmental Health) and Planning and Building Standards were consulted on the application.
- 3.4 Notification of the application was also sent to NHS Highland and the local Community Council.

- 3.5 Further to this publication and consultation process, no timeous objections or representations have been received.
- 3.6 The applicant must nevertheless be given the opportunity to be heard before the Board determines the application and has accordingly been invited to the meeting. The applicant has been advised of the hearings procedure which may also be viewed via the following link:

## 4.0 Legislation

4.1 The Licensing Board must, in considering and determining the application, consider whether any grounds of refusal apply and, if none of them applies, the Board must grant the application.

Relevant grounds of refusal are: -

- 1. that the premises are excluded premises;
- 2. that the Board considers, having regard to the licensing objectives, that the applicant is not a fit and proper person to be the holder of a premises licence;
- 3. that the grant of the application would be inconsistent with one or more of the licensing objectives;
- 4. that having regard to;
  - (i) the nature of the activities proposed to be carried on in the subject premises,
  - (ii) the location character and condition of the premises, and
  - (iii) the persons likely to frequent the premises,

the Board considers the premises are unsuitable for use for the sale of alcohol, or

- 5. that the Board considers that, if the application were to be granted, there would, as a result, be overprovision of licensed premises, or licensed premises of the same or similar description as the subject premises, in the locality.
- 4.2 For the purposes of the Act, the licensing objectives are-
  - (a) preventing crime and disorder,
  - (b) securing public safety,
  - (c) preventing public nuisance,
  - (d) protecting and improving public health, and
  - (e) protecting children and young persons from harm.

4.3 If the Board would refuse the application as made, but a modification is proposed by them and accepted by the applicant, the application can be granted as so modified.

## 5.0 Licensing Standards Officer

5.1 The LSO has provided the following comments:-

(i) The applicants have commenced building works for a Visitor Centre at Dochgarroch, Inverness. The building which will occupy a substantial site comprises of a "Grab and Go shop" which will provide a grocery facility for persons primarily enjoying boating holidays on the Caledonian Canal and the Lochs of the Great Glen.

(ii) As part of the grocery provision a range of alcohol will be offered for sale by way of "off sales" only. The display area of the alcohol will comprise some 2.3 square metres, which is well under the current threshold within the Board's Policy for considering over provision.

(iii) The necessary section 50 certificate concerning planning has been submitted with the application, as have layout plans of acceptable quality.

(iv) The premises from the plans provided seem suitable for the sale of alcohol as indicated within the operating plan.

(v) The site notice has been displayed for the required 21 days. From the public consultation phase of the application no objections or representations have been received.

(vi) It is the opinion of the LSO that the proposed operating plan is entirely in keeping with the 5 licensing objectives.

## 7.0 Conditions

## 7.1 Mandatory conditions

If the application is approved the mandatory conditions set out in Schedule 3 of the Act will apply.

No local conditions are considered necessary.

# 7.3 Special conditions

No special conditions are considered necessary.

## Recommendation

The Board is invited to determine the above application.

If the Board is minded to refuse the application, the Board must specify the ground for refusal and, if the ground for refusal is in relation to a licensing objective, the Board must specify the objective in question.
