- 1. Purpose/Executive Summary
- 1.1 This report provides an update on the work undertaken on the Area Capital Roads Programme for 2018/19 financial year.

3. Area Capital Programme

3.1 Finance

The capital programme for 2018/19 was approved at the Ross and Cromarty Committee on 31 October 2017. The programme was based on the previous year's budget of £1,533,695.

The 2018/19 capital budget was set at \pounds 1,522,900 which was a reduction of \pounds 10,795 on the previous year.

Care and Learning had a surplus of funds following the issue of Chromebooks to all Highland pupils. The surplus was allocated to roads capital budget with £326,685 assigned to Ross and Cromarty.

The total capital budget for Ross and Cromarty for 2018/19 is therefore £1,849,585.

At the end of December 2018 \pm 1,464,313, or 79%, of the budget has been spent. The remaining \pm 385,272 has been allocated to Capital Patching to maintain the road network over the rest of the winter months.

3.2 Surface Dressing Schemes

Pre-surface dressing patching started in April 2018 and continued through to July. The patching was more extensive than previously envisaged due to the severe 2017/18 winter.

Surface dressing started in May and continued to July when the plant was transferred to Skye.

Twenty-four roads were surface dressed giving a total of 179,180 sq m covering 31 km. This represents 1.27% of the road network in Ross and Cromarty.

Surface dressing at 18 roads was cancelled due to either the road being in too poor a condition to surface dress or time constraints.

Completed surface dressing sites are detailed in **Appendix A**.

3.3 Inlay Schemes

Only Parkland Place in Balintore was inlaid from a total of five sites on the programme.

Financial pressures due to the excessive patching required for the surface dressing operation resulted in the sites being deferred.

3.4 **Overlay Schemes**

Three overlay schemes were completed giving a total of 8,165 sq m covering 1.32 km. This represents 0.053% of the road network in Ross and Cromarty. Four schemes were cancelled due to time constraints and financial pressures. Deferred schemes will be considered for next year's capital programme.

In addition, Glenelg Village Road has been strip widened to form a footway and has been overlaid although bollards and lining remain outstanding.

On the A832 at The Fain the original length of the overlay was extended from 500 m to 725 m as the road had deteriorated over last winter. The additional length reflects the deterioration caused by the prolonged and severe winter and could not be surface dressed due to its poor condition.

These sites are detailed in **Appendix A**.

3.5 Machine Patching Schemes

Four roads were machine patched with three schemes being deferred due to time constraints and financial pressures.

The extent of the machine patching on Craig Road was significantly extended and the sunken gullies rebuilt on reinforced concrete foundations.

The A890 at Achnashellach was originally programmed for 500 sq m of machine patching. With the additional capital monies this scheme was extended to include strip widening over 600 m. The site will be overlaid next financial year.

These sites are detailed in **Appendix A**.

3.6 Footway Schemes

The capital programme had allocated 8,400 sq m of slurry sealing to footways across eight sites in Ross and Cromarty. Due to plant issues none of these works were completed.
