4. Quarter 1 Monitoring Statement

- 4.1 A monitoring statement showing transactions to the end of June 2019 against budget and estimated year end position is attached at **Appendix One.**
- 4.2 **Income** No income has yet been received. The income to Cromarty Good Fund is derived from Cromarty Victoria Hall and East Church Hall. These properties are leased to the Highland Council. When the income budget was set, the rents totalled £4,840. Property rents have now been reviewed and from April 2019 the total anticipated income from these properties for 2019/20 is £6,020. The budget and the estimated year end outturn has been amended to reflect this.
- 4.3 **Expenditure** to date relates to property costs of £301 for the rent reviews, the budget and the estimated year end outturn has been adjusted to reflect this.
