Report Title: Lochaber Parking Income Update

Report By: Interim Chief Officer Resources (Community Services)

## 1. Purpose/Executive Summary

1.1 To summarise in year income figures from Pay & Display Car Parks in Fort William and update members on previous committee requests on the 7 November 2018.

#### 2. Recommendations

- 2.1 Members are asked to:-
  - Note the reporting of performance; and
  - Agree the introduction of car parking charges as detailed in the report for West Bay Mallaig
- 3. Implications
- 3.1 Resource Car park income performance and enforcement activity is dependent on staff resources.
- 3.2 Legal Roads (Scotland) Act 1984, Road Traffic Regulation Act 1984, Road Traffic Act 1991
- 3.3 Community (Equality, Poverty and Rural) No implications.
- 3.4 Climate Change / Carbon Clever EV Charging is provided in An Aird 2 and West Bay Mallaig car parks and we are expecting to expand this provision in the future.
- 3.5 Risk None, however continual monitoring of incomes and management of Service budget to ensure budget targets are met to mitigate budget pressures.
- 3.6 Gaelic No implications.

#### 4. Breakdown of Car Park Income in Fort William

- 4.1 In the 2019/20 budget process the baseline income budgets for parking were reviewed and amended to reflect actual incomes in 2018/19. This resulted in setting the 2019/20 service income budget for Lochaber at £420,000 including consideration for any variation in future sales.
- 4.2 The attached tables in **Appendix 1** break down income levels for calendar year 2018 and in year for 2019 and detail three specific Car Parks for information (West End, Viewforth and Middle Street)

Please Note that the tables are set January to December to highlight the seasonality variations.

## 5. Year on Year performance

5.1 Overall year on year comparisons show an increase in both transactions and actual income with year-end income projected to exceed baseline budget targets at this time.

The rise in transaction numbers strongly indicates that occupancy is on the rise for all sites.

## April to July - Year on Year Comparisons.

- "At Machine" transactions have increased by 7%.
- Contactless Card payments have increased by 29% with 27% of all transactions at the machines now cashless.
- "Remote" transactions (Ringo) have increased by 79% this includes season ticket purchases.

It should be noted that the year on year income comparison for Viewforth Car Park have shown a reduction in 2019 so far, but this can be directly correlated to the reduction in available bays due to the ongoing construction works. The deficit is compensated by fees charged to the developer for the suspension of bays they are using.

5.2 The analysis of 2018/19 income was used to calculate the seasonality in Fort William and is provided in the table below. It shows the spread across the year with highest use in August and all other months a factor of August income.

This index has been applied to in year figures in **Appendix 1** "Totals" table to calculate the projected outrun for 2019.

#### 6. Enforcement

6.1 The attached **Appendix 2** details enforcement activity in Lochaber for the 2018 and to date in 2019. The issue of Penalty Charge Notices is currently being managed from Inverness due to vacant posts however at the time of writing two FTE posts are being advertised to be based in Lochaber.

## 7. Mallaig – West Bay Car Park

- 7.1 Work has been ongoing over the last year with the local community to explore the introduction of car parking charges at West Bay Car Park in Mallaig. There is broad support from the community for the introduction of charges at this location. Main usage of the facility is by visitors and therefore it is proposed that charging is seasonal, between March and October. Local feedback has led to the inclusion of 30 minutes free parking. A season ticket for parking at West Bay will also be available that would offer prepaid parking at £10 per month.
- 7.2 The proposed Tariffs are as follows:-

7.3 Should Members agree the introduction of charges at West Bay in Mallaig, it is proposed charging would begin immediately.

## 8. Further Developments

8.1 Discussions are continuing with Members to consider parking provision across the Lochaber area, particularly in light of the increase in visitor numbers. This includes the consideration of introducing further car parking charges and new facilities. At the Lochaber Area Committee in November 2018, Members requested that officers should explore the creation of a car park at the Glen Nevis turning area. This has not been progressed to date due to resourcing issues however this will be investigated moving forward within the wider context of car parking provision across the local area.
