Report Title:	Early Years Update

Report By: Chief Executive

1. Purpose/Executive Summary

1.1 This report provides members with an update on early years. It highlights the progress of the Early Learning and Childcare (ELC) expansion programme, the key risk areas associated with the programme, and the mitigating actions being taken.

Recommendations

- 2.1 Members are asked to:
 - i. Note the update provided in relation to Early Years and ELC expansion
 - ii. Note the status of ELC capital projects and the risk management actions being taken

3. Implications

- 3.1 Resource ELC provision is funded from a baseline Highland Council budget, pre-dating Scottish Government expansion, supplemented by SG funding to deliver expansion to 1140 hours. Resource monitoring is through the ELC Programme Board and revenue monitoring reports to Committee.
- 3.2 Legal no legal implications to highlight.
- 3.3 Community (Equality, Poverty, Rural and Island) the expansion of ELC will provide the opportunity to positively support many of these areas including supporting families into work and education.
- 3.4 Climate Change / Carbon Clever capital investment projects will consider appropriate solutions to mitigate carbon impact and energy efficiency.
- 3.5 Risk as highlighted within this report, there are a number of key risks related to a change programme of this size. A comprehensive risk management approach is in place

through programme governance, with risk also being considered through both Service Risk Registers and Corporate Risk Registers. A number of mitigating actions are in place, which are reflected within this report.

3.6 Gaelic – expansion will include provision within Gaelic settings.

4. ELC Expansion Programme Update

- 4.1 As reported in previous committee papers the ELC expansion of hours represents a significant change programme. This change has a number of key components, with particular challenges in the number of new workforce required and the physical changes and additions to buildings. This report provides an update on progress towards delivering expansion, highlights risks and implications, and the management action being taken to ensure delivery and mitigating risk.
- 4.2 As reported to previous committee on 10th October 2019 the relatively late approval of the final programme in June 2019, and the significant number of ELC capital projects to be delivered (84 settings), meant that there was a significant risk around delivery of aspects of that investment for August 2020. Previous reports have also highlighted those ELC settings and projects which were deemed higher priority. As a result mitigating actions are being taken to manage risk around late delivery of capital, including identification of contingency plans, and where necessary early decisions being made around these.
- 4.3 Recognising the scale of the ELC programme, since the last committee report in December 2019, there has been a number of key staff appointments to support delivery. These include new posts of ELC Programme Manager, ELC Programme Manager (capital) and Project Co-ordinator Workforce development. The vacant post of ELC project manager has also been filled.
- 4.4 ELC expansion has been on a phased basis, and as of January 2020, out of 245 ELC settings in Highland, over 50% are now delivering 1140 hours. The next key phase is 100% completion by August 2020, with the Council and Partner Provider planning in relation to staffing, capital and any other changes required, focused on delivery by this timescale, and any mitigating actions necessary.
- 4.5 The Highland operating models for delivery of ELC are as set out on **Appendix 1** and have been developed with input from the Improvement Service, and other partners, and engagement at a local level. These operating models have also been developed in parallel with assessment of capital investment requirements. It is however recognised that a review of models post August 2020 will be necessary.
- 4.6 The impact of choice within some of the Highland Council's contingency plans, may require parents to split their entitlement with another provision. However, it was always the case that in some ELC settings in Highland the operating models may have required parents to consider a split placement. To this end, the Highland Council need to ensure that they are making best use of partner settings to promote the provider neutral values. Communicating this to parents, schools, partners, and commissioned childminders will increase everyone's understanding of quality, flexibility and choice within the differing providers within their area.
- 4.7 Enrolment data will also provide a more accurate picture of the number of children who will be using their funded entitlement, as well as any implications on capacity and the number of full-time equivalent staff that are required for August 2020. The level of

additional staffing is significant, and represents both a major employment and career opportunity within the Highlands, as well as a major transformational challenge.

4.8 The whole recruitment drive across Scotland is about building and shaping a career in Early Years, to ensure the delivery of quality ELC. Highland Council is keen to ensure that the recruitment strategy for ELC provides us with the staff we need not only to deliver the expanded hours, but provide children with quality experiences in ELC, in settings that are reaching more than the National Standard of 'Good'. Each month we review the Care Inspectorate ratings of our settings. A clear plan to ensure immediate and long-term actions for improvement across ELC settings in Highland has been developed.

5. ELC Capital Investment Update

- 5.1 **Appendix 2** provides an updated analysis of the 84 ELC capital projects, and the risk rating applied to each. The risk ratings are based on the following methodology:
 - Blue Work completed
 - Green Work underway onsite
 - Yellow Project progressing and on schedule
 - Amber Possible risk of delay and mitigating action being taken
 - Red Probable risk of delay and mitigating action being taken
 - Purple Part of a major project August 2021 completion
- 5.2 There are 21 projects which were deemed 'higher priority' in relation to the risk around project delivery, and contingency requirements. As set out on Appendix 2, at the date of this report there are 16 projects categorised as 'Red'. A contingency planning approach has been taken in relation to managing risk around these projects, and to date there are 11 settings where an early pro-active decision has been made to implement those contingency plans. This early decision has been made in recognition of work that can then be taken forward to implement that contingency, and ensuring parents are aware of any implications at enrolment. In relation to the remaining projects, further review of contingency arrangements is underway, as well as mitigating action in relation to the capital project delivery, and any further decisions to implement the contingency will be taken at the appropriate time. The types of contingencies that are being implemented for the 11 projects noted include; temporary premises until the build is completed, management of session hours and working flexibly with primary school and/or partner providers. Contingency arrangements will ensure delivery of 1140 hours by August 2020, and briefings will be provided to members at a local level to understand progress with capital investment delivery, and contingency arrangements.
- 5.3 Some of the key developments in relation to ELC projects are as follows:

Bun-Sgoil Ghaidhlig Inbhir Nis: Opening of the annexe adjacent to the school at the start of the new term in January. The building comprises two nursery classrooms, two primary classrooms, a production kitchen, dining area, offices and other facilities. It will provide the nursery accommodation required to deliver the increased provision from August 2020 as well increasing the capacity of the primary school to address the roll pressures there. The kitchen will also supply meals to other nurseries in the Inverness area.

Ullapool Primary School: The nursery extension was handed over in November. This comprises two nursery rooms (one English and one Gaelic Medium) with ancillary accommodation linked to the main building to replace a dilapidated nursery unit.

Portree Primary School: The conversion of areas vacated following the move of Gaelic provision to the new Bun-sgoil Ghàidhlig Phort Rìgh has been completed and the nursery will be occupied in February.

Progress on site with the following projects, all of which are due to be operational before the end of the current session.

Deshar Primary School: New nursery unit. This is a successful joint initiative with a community fund-raising group that have contributed £80,000 towards the project.

Keiss Primary School: New nursery unit.

Tomnacross Primary School: Extension/refurbishment of the former school house.

Tongue Primary School: New nursery unit.

5.4 As part of ongoing communication planning, regular update reports will continue to be taken to this Committee. Local updates will also be provided to elected members at a local level through ward level briefings and Area Committee updates where required. These will be part of a broader communication plan to all key stakeholders.

6. ELC Good Practice Update

- 6.1 An ELC quality action plan has been agreed which describes a systematic model of ELC improvement, based on rigorous self-evaluation. Approach to self evaluation is formative, based on area and authority data to support overall planning and support for settings. An audit was conducted with Highland Council Head Teachers and Partner setting Managers around the National Standard, which all settings must meet from August 2020. This identified strengths and weaknesses linked to the National Standard and established next steps for improvement planning. Clear communication strategies are key to quality improvement and guidelines around targeted support will be shared with local areas.
- 6.2 A detailed CPD plan is currently being drafted with a menu of bespoke training to address needs as identified from the National Standard audit. The planned CPD will be reviewed regularly in light of the data gathered through various quality improvement activities. Several models of CPD are on offer, drawing on existing knowledge and skills within the current workforce. Various mediums are being utilised, for example; the ELC Blog, VScene, Webinars and Video Conferencing. In addition to, setting visits and workshops. These will increase accessibility to CPD opportunities for all ELC staff. Looking outwards we continue to access CPD and support from Northern Alliance and Scottish Government Advisors.

Appendix 1 - Highland Operating Model

The Highland Council offers three different operating models that include term time school hours, extended hours and whole year provision to allow demands on provision to be met. However, due to geographical challenges in the Highlands, the flexibility that can be offered depends on your area. Nonetheless in most cases a blended provision between partners, childminders or local authority nurseries will make extended (8am – 6pm) coverage possible. Ongoing work is being undertaken to ensure there is equity of what is offered across Highland and that within each ASG a mixture of models is offered wherever possible.

Option 1	In accordance with school opening times during <u>school term time</u> Settings are open for 30 hours a week over 38 weeks.	Allowing up to 30 funded hours per week in accordance with school opening times. In most cases this will be over 5 days (9am - 3pm) however some schools operate an asymmetric week with early closing on a Friday.
Option 2	Opening hours (8am - 6pm) during <u>school</u> <u>term time</u> Settings are open for 50 hours a week over 38 weeks.	Allowing up to 30 funded hours per week with the opportunity to purchase additional hours, subject to availability.
Option 3	Opening hours (8am – 6pm) <u>all year</u> Settings are open for 50 hours a week over 49 weeks.	Receiving funded hours in discussion with the setting and the opportunity to purchase additional hours, subject to availability. Where capacity allows Option 2 will also be available.
