Minutes of Meeting held 19 September 2019

#### 3. Input from SACRO:

Item 10 taken next – Kelly and Jim provided an overview of SACRO, they provide services including looking at the root causes of offending and prevention, working with those who have offended or those on the periphery in partnership easing pressure on statutory services.

In Highland – Shine, working with females who have offended both in prison and in the community. Can work with females up to a 6-month period or longer if required.

Veterans Mentoring Service – people can self-refer into this as well as through the CJ system. Referral can be made at an early stage.

Click Service which looks at the night-time economy, recently appointed staff member will be based in the Castle in Inverness. This service will have an outreach element to it for those involved in this industry.

A homeless accommodation is up and running in Moray for young people and adults.

James asked about Bail Supervision, which is not used very much in Highland and if there is anything, we can learn from SACRO in relation to this. Jim updated the meeting that there is a successful Bail Supervision Service in Kilmarnock which could be looked at to see what has worked and what hasn't. SACRO could help deliver this but the Courts and COPFS would need to be part of this.

The Intensive Support Package was also mentioned which is a high-risk public safety package. There is no footprint in Highland for this and geography is not seen as a barrier with this service.

Disability Framework which is being used in Aberdeen, there is a standard and enhanced framework which is used to measure progress in relation to outcomes.

Refresh – this is a service which is being run in Aberdeen & shire aimed at young people who have disengaged and are showing challenging behaviour. Referrals are made from schools through PEF funding. Work is being done with schools and other organisations to help increase life chances before young people start offending.

Other activities mentioned – rock balancing, bubble therapy, meditation movement and Cherokee Sundance which have had some positive results.

## 4. Minutes of Previous Meeting:

James Docherty and Kirsty Giles attended a workshop session of the Sutherland Community Partnership on Wednesday 11th September. The meeting was to explain the role of the Violence Reduction Unit and how it might support the aspirations of the Community Partnership to develop work to address adverse childhood experiences and trauma informed/trauma responsive approaches with communities. The session was well received and there is interest in developing a community focused approach based through a shared agenda.

The next steps will involve consideration of how to raise awareness and provide training to staff across all services in a series of locations across Sutherland. VRU colleagues are planning to visit for five days at a time to be determined to develop this work further.

Discussions with the Caithness Community Partnership will start in October.

Margaret mentioned information that had come in in the past couple of days from SG and CJS in relation to Coordinator Tasks (Partnership Manager). Information around this was circulated at the meeting for discussion.

It was felt that we are broadly doing the tasks set out and that there is inconsistency across the partnerships nationally. Some things were not reflected in the list including the collaboration between statutory and third sector. It may be the case that a standard job description and pay scale may be something that is being looked at nationally.
